A BILL

To require the Attorney General to promulgate regulations relating to gender-related persecution, including female genital mutilation, for use in determining an alien's eligibility for asylum or withholding of deportation.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REQUIREMENT TO PROMULGATE REGULA-**
2 **TIONS CONCERNING GENDER-RELATED PER-**
3 **SECUTION.**

4 (a) **REGULATIONS FOR USE IN EVALUATING ASYLUM**
5 **APPLICATIONS.**—The Attorney General shall promulgate
6 regulations, which shall apply to the determination of an
7 alien’s eligibility to be granted asylum under section
8 208(a) of the Immigration and Nationality Act, interpret-
9 ing, in a manner consistent with international law and
10 standards, the term “persecution”, as used in section
11 101(a)(42)(A) of such Act, to include gender-related per-
12 secution, including female genital mutilation. The regula-
13 tions under this subsection may not create burdens, or in-
14 crease requirements, for establishing persecution beyond
15 those established by international law and standards and
16 recent decisions of the Board of Immigration Appeals.

17 (b) **REGULATIONS FOR USE IN WITHHOLDING DE-**
18 **PORTATION OR RETURN.**—The Attorney General shall
19 promulgate regulations relating to gender-related persecu-
20 tion, including female genital mutilation, which shall apply
21 to the determination under section 243(h) of the Immigra-
22 tion and Nationality Act. The regulations under this sub-
23 section shall be consistent, to the extent appropriate under
24 such Act, with the regulations under subsection (a).

25 (c) **DEADLINE.**—The Attorney General shall promul-
26 gate the regulations required by this Act not later than

1 the date that is 30 days after the date of the enactment
2 of this Act.

3 (d) DEFINITION.—For purposes of this Act, the term
4 “gender-related persecution” means a harm that—

5 (1) is specific to, or disproportionately affects,
6 women on the ground of their gender; and

7 (2) otherwise would be considered persecution
8 for purposes of section 101(a)(42)(A) of the Immi-
9 gration and Nationality Act.
