A BILL

- To establish certain disclosure requirements relating to franked mail sent by Members of the House of Representatives.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. DISCLOSURE REQUIREMENTS.
 - 4 (a) Relating to Each Mailing.—Any franked
 - 5 mail sent by a Member of the House of Representatives
 - 6 shall bear on its face, or on the envelope or outside cover
 - 7 or wrapper in which the mail matter is sent, the following
 - 8 notice: "THIS MAILING WAS PREPARED, PUBLISHED,
 - 9 AND MAILED AT TAXPAYER EXPENSE.", or a notice to

- 1 the same effect in words which may be prescribed under
- 2 subsection (c).
- 3 (b) Relating to the Congressional Record.—
- 4 There shall be published in the Congressional Record, on
- 5 an annual basis, a summary tabulation setting forth, for
- 6 the office of each Member of the House of Representa-
- 7 tives, the total number of pieces of franked mail mailed
- 8 during the year involved and the total cost of those
- 9 mailings.
- 10 (c) Regulations.—The House Commission on Con-
- 11 gressional Mailing Standards shall prescribe such rules
- 12 and regulations and shall take such other action as the
- 13 Commission considers necessary and proper for Members
- 14 to conform to the provisions of this subsection and appli-
- 15 cable rules and regulations.
- 16 (d) Definitions.—For purposes of this section—
- 17 (1) the term "Member of the House of Rep-
- 18 resentatives" means a Representative in, or a Dele-
- 19 gate or Resident Commissioner to, the Congress;
- 20 and
- 21 (2) the term "franked mail" has the meaning
- given such term by section 3201(4) of title 39, Unit-
- ed States Code.

- 1 (e) Effective Date.—This section shall apply with
- 2 respect to sessions of Congress beginning after the date

3 of the enactment of this Act.
