A BILL

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Sweatshop Product
- 5 Ban Act of 1996".
- 6 SEC. 2. CONDITION ON SALE OF IMPORTED CONSUMER
- 7 ITEMS IN COMMISSARY AND EXCHANGE
- 8 STORES.
- 9 (a) Compliance With Minimum Labor Stand-
- 10 ARDS REQUIRED.—(1) Chapter 147 of title 10, United
- 11 States Code, is amended by adding at the end the follow-
- 12 ing new section:
- 13 "§ 2490b. Commissary and exchange stores: condition
- on sale of imported consumer items
- 15 "(a) Compliance With Minimum Labor Stand-
- 16 ARDS.—The Defense Commissary Agency and any non-
- 17 appropriated fund instrumentality operating a military ex-
- 18 change store may not purchase for resale in a commissary
- 19 or exchange store any consumer item imported into the
- 20 United States if the Defense Commissary Agency or non-
- 21 appropriated fund instrumentality has reason to believe

- 24 "(b) Establishment of Standards.—The Sec-

- 5 "(c) Process to Determine Compliance.—The
- 6 Secretary of Labor shall annually develop and submit to
- 7 the Secretary of Defense a list of companies and manufac-
- 8 turers that are not in compliance with the minimum labor
- 9 standards developed under subsection (b). The Secretary
- 10 of Defense shall annually certify to Congress that the De-
- 11 fense Commissary Agency and nonappropriated fund in-
- 12 strumentalities have not purchased any consumer items
- 13 from the companies and manufacturers identified by the
- 14 Secretary of Labor.
- 15 "(d) Definition.—In this section, the term 'non-
- 16 appropriated fund instrumentality' means the Army and
- 17 Air Force Exchange Service, Navy Exchange Service Com-
- 18 mand, Marine Corps exchanges, or any other instrumen-
- 19 tality of the United States under the jurisdiction of the
- 20 Armed Forces which is conducted for the comfort, pleas-
- 21 ure, contentment, or physical or mental improvement of
- 22 members of the Armed Forces.".

- 1 (b) Effective Date.—Section 2490b of title 10,
- 2 United States Code, as added by subsection (a), shall
- 3 apply with respect to contracts entered into or extended
- 4 after the date of the enactment of this Act for the pur-
- 5 chase of imported consumer items for sale in military com-
- 6 missary or exchange stores.
