A BILL

To amend title 38, United States Code, to improve health care services provided by the Department of Veterans Affairs to women veterans.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Women Veterans"
- 5 Health Act of 1996".
- 6 SEC. 2. WOMEN'S HEALTH SERVICES.
- 7 (a) Women's Health Services.—Section 1701 of
- 8 title 38, United States Code, is amended—

- 22 SEC. 4. REPORT ON WOMEN'S HEALTH CARE AND RE-
- SEARCH.
- 24 (a) IN GENERAL.—Not later than January 1, 1999,
- 25 the Secretary of Veterans Affairs shall submit to the Com-

2	Representatives a report on the provision of health care

 - (4) A description of the personnel of the Department who provided such services to women veterans, including the number of employees (including both the number of individual employees and the number of full-time employee equivalents) and the professional qualifications or specialty training of such employees and the Department facilities to which such personnel were assigned.
 - (5) A description of any actions taken by the Secretary to ensure the retention of the personnel described in paragraph (4) and any actions under-

SEC. 6. POPULATION STUDY.

- 2 (a) Study.—The Secretary of Veterans Affairs, sub-
- 3 ject to subsection (f), shall conduct a study to determine
- 4 the needs of veterans who are women for health-care serv-
- 5 ices. The study shall be carried out through the Center
- 6 for Women Veterans.
- 7 (b) Consultation.—Before carrying out the study,
- 8 the Secretary shall request the advice of the Advisory
- 9 Committee on Women Veterans on the conduct of the
- 10 study.
- 11 (c) Persons To Be Included in Sample of Vet-
- 12 ERANS STUDIED.—(1) Subject to paragraph (2), the study
- 13 shall be based on—
- 14 (A) an appropriate sample of veterans who are
- women; and
- 16 (B) an examination of the medical and demo-
- 17 graphic histories of the women comprising such sam-
- 18 ple.
- 19 (2) The sample referred to in paragraph (1) shall
- 20 constitute a representative sampling (as determined by the
- 21 Secretary) of the ages, the ethnic, social and economic
- 22 backgrounds, the enlisted and officer grades, and the
- 23 branches of service of all veterans who are women. The
- 24 Secretary shall ensure that homeless Women Veterans are
- 25 included in the sample.

- 1 (3) In carrying out the examination referred to in
- 2 paragraph (1)(B), the Secretary shall determine the num-
- 3 ber of women of the sample who have used medical facili-
- 4 ties of the Department, nursing home facilities of or under
- 5 the jurisdiction of the Department, and outpatient care

- 7 (d) Reports.—The Secretary shall submit to the
- 8 Committees on Veterans' Affairs of the Senate and House
- 9 of Representatives reports relating to the study as follows:
- 10 (1) Not later than nine months after the date
- of the enactment of this Act, an interim report de-
- scribing (A) the information and advice obtained by
- the Secretary from the Advisory Committee on
- Women Veterans, and (B) the status of the study.
- 15 (2) Not later than December 31, 1999, a final
- report describing the results of the study.
- 17 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
- 18 authorized to be appropriated to the General Operating
- 19 Expenses account of the Department of Veterans Affairs
- 20 \$2,000,000 to carry out the purposes of this section.
- 21 Amounts appropriated pursuant to this authorization of
- 22 appropriations shall be available for obligation without fis-
- 23 cal year limitation.

- 1 (f) Limitation.—No funds may be used to conduct
- 2 the study described in subsection (a) unless expressly pro-
- 3 vided for in an appropriation Act.
- 4 SEC. 7. OUTREACH SERVICES FOR HOMELESS WOMEN VET-
- 5 ERANS.
- 6 Section 7722(e) of title 38, United States Code, is
- 7 amended by adding at the end the following new sentence:
- 8 "In carrying out this subsection, the Secretary shall take
- 9 such steps as may be necessary to ensure that homeless
- 10 women veterans are included in such outreach programs
- 11 and outreach services.".
- 12 SEC. 8. SAFE AND EFFECTIVE TREATMENT FOR WOMEN
- 13 PSYCHIATRIC PATIENTS.
- 14 The Secretary of Veterans Affairs shall ensure that
- 15 women veterans who receive psychiatric treatment from
- 16 the Secretary, particularly in the case of women who are
- 17 sexually traumatized, receive such treatment (on both an
- 18 inpatient and outpatient basis) in a safe and effective
- 19 manner that recognizes the privacy needs of such women.
- 20 SEC. 9. MAMMOGRAPHY QUALITY STANDARDS.
- 21 (a) Applicability to Department of Veterans
- 22 Affairs of Mammography Quality Standards Act
- 23 OF 1992.—Subsections (a) through (k) of section 354 of
- 24 the Public Health Service Act (42 U.S.C. 263b) shall
- 25 apply with respect to facilities of the Department of Veter-

- 12 Veterans Affairs shall take appropriate steps to cooperate
- 13 with the Secretary of Health and Human Services in the
