# A BILL

To provide that individuals otherwise entitled to receive payments from the Federal Government may specify that a portion of those payments be used for deficit reduction.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 (a) Short Title.—This Act may be cited as the
- 5 "Citizen Debt Reduction Contribution Act".
- 6 (b) Table of Contents.—

#### 1 SEC. 2. SENSE OF THE CONGRESS.

- 2 It is the sense of the Congress that any budget sav-
- 3 ings resulting from this Act should be used solely to re-
- 4 duce net Government spending. Congress appreciates and
- 5 respects the contributions made by citizens participating
- 6 in the programs authorized by this Act, and shares their
- 7 concerns at excessive Government spending.

#### 8 SEC. 3. INCOME TAX REFUNDS.

- 9 (a) GENERAL RULE.—Subchapter A of chapter 61 of
- 10 the Internal Revenue Code of 1986 (relating to returns
- 11 and records) is amended by adding at the end the follow-

#### 17 "SEC. 6097. DESIGNATION OF INCOME TAX OVERPAYMENTS.

- 18 "(a) General Rule.—Every taxpayer who makes a
- 19 return of the tax imposed by chapter 1 for any taxable
- 20 year may designate that a specified portion (not less than

- 1 \$1) of any overpayment of tax for such taxable year shall
- 2 be used to reduce the public debt of the United States.
- 3 "(b) Manner and Time of Designation.—Any
- 4 designation under subsection (a) for any taxable year shall
- 5 be made—
- 6 "(1) at the time of filing the return of the tax
- 7 imposed by chapter 1 for such taxable year, and
- 8 "(2) in such manner as the Secretary may by
- 9 regulation prescribe, except that such designation
- shall be made either on the first page of the return
- or on the page bearing the taxpayer's signature.
- 12 "(c) Treatment of Amounts Designated.—For
- 13 purposes of this title, the amount designated by any tax-
- 14 payer under subsection (a)—
- 15 "(1) shall be treated as being refunded to such
- taxpayer as of the last date prescribed for filing the
- 17 return of tax imposed by chapter 1 (determined
- 18 without regard to extensions) or, if later, the date
- the return is filed, and
- 20 "(2) shall be treated as a contribution made by
- 21 such taxpayer on such date to the United States."

- 3 "(a) The Secretary concerned shall establish a pro-
- 4 gram under which a member or former member of the
- 5 armed forces under the jurisdiction of the Secretary who
- 6 is entitled to receive retired or retainer pay may elect that
- 7 all or a designated portion of such pay for any month be
- 8 transferred to the general fund of the Treasury as a gift
- 9 to reduce the public debt. Any such election may be re-
- 10 voked at any time.
- 11 "(b) For any month for which an election under sub-
- 12 section (a) is in effect, the Secretary concerned shall with-
- 13 hold from the retired or retainer pay of the person making
- 14 the election the amount designated by that person in such
- 15 election and shall transfer the amount so withheld to the
- 16 Secretary of the Treasury.
- 17 "(c) The Secretary of the Treasury is authorized to
- 18 accept any amount transferred to the Secretary under this
- 19 section as a gift under subsection (a)(1)(A) of section
- 20 3113 of title 31 (relating to accepting gifts for reducing
- 21 the public debt).
- "(d) Amounts to which an election under subsection
- 23 (a) applies shall not be includible in gross income for pur-
- 24 poses of the Internal Revenue Code of 1986. No deduction
- 25 shall be allowed under such Code with respect to any

- 9 (a) In General.—Chapter 53 of title 38, United
- 10 States Code, is amended by adding at the end the follow-
- 11 ing new section:
- 12 "§ 5320. Donations of compensation for purposes of
- 13 reducing the public debt
- 14 "(a) The Secretary shall establish a program under
- 15 which a veteran who is entitled to compensation may elect
- 16 that all or a designated portion of such compensation for
- 17 any month be transferred to the general fund of the Treas-
- 18 ury as a gift to reduce the public debt. Any such election
- 19 may be revoked at any time.
- 20 "(b) For any month for which an election under sub-
- 21 section (a) is in effect, the Secretary shall withhold from
- 22 the compensation payable to the veteran making the elec-
- 23 tion the amount designated by the veteran in such election
- 24 and shall transfer the amount so withheld to the Secretary
- 25 of the Treasury.

- 1 "(c) The Secretary of the Treasury is authorized to
- 2 accept any amount transferred to the Secretary under this
- 3 section as a gift under subsection (a)(1)(A) of section
- 4 3113 of title 31 (relating to accepting gifts for reducing
- 5 the public debt).
- 6 "(d) Amounts to which an election under subsection
- 7 (a) applies shall not be includible in gross income for pur-
- 8 poses of the Internal Revenue Code of 1986. No deduction
- 9 shall be allowed under such Code with respect to any
- 10 amount which is not includible in gross income by reason
- 11 of the preceding sentence."
- 12 (b) CLERICAL AMENDMENT.—The table of sections
- 13 at the beginning of such chapter is amended by adding
- 14 at the end the following new item:

"5320. Donations of compensation for purposes of reducing the public debt.".

#### 15 SEC. 7. BUDGETARY TREATMENT OF SAVINGS RESULTING

- 16 FROM THIS ACT.
- 17 Savings resulting from the enactment of this Act
- 18 shall not be considered for purposes of estimates made for
- 19 this Act under section 252(d) of the Balanced Budget and
- 20 Emergency Deficit Control Act of 1985.
