## <sup>104TH CONGRESS</sup> **H. R. 4259**

### A BILL

- To amend the Higher Education Act of 1965 to authorize Presidential Honors Scholarships to be awarded to all secondary school students in the top 5 percent of their graduating class, to promote and recognize high academic achievement in secondary school, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Presidential Honors5 Scholarship Act of 1996".

SEC. 2. PRESIDENTIAL HONORS SCHOLARSHIP PROGRAM.
 Part A of title IV of the Higher Education Act of
 1965 (20 U.S.C. 1001 et seq.) is amended by inserting
 after subpart 6 the following new subpart:

# 7 "SEC. 420A. PRESIDENTIAL HONORS SCHOLARSHIP PRO8 GRAM.

9 "(a) PURPOSE.—It is the purpose of this subpart to 10 establish a Presidential Honors Scholarship Program to 11 encourage high academic achievement in public and pri-12 vate secondary schools and to recognize and reward the 13 achievement of their outstanding graduates.

14 "(b) PROGRAM AUTHORITY.—The Secretary is au-15 thorized, in accordance with this subpart, to carry out a 16 program of recognizing high academic achievement in pub-17 lic and private secondary schools by awarding scholarships 18 to all students in the top 5 percent of their graduating 19 class, and thereby encouraging students to excel in their 20 secondary studies and pursue postsecondary education.

"(c) AUTHORIZATION OF APPROPRIATIONS.—There
are authorized to be appropriated \$130,000,000 for fiscal
year 1998, and such sums as may be necessary for each
of the 4 succeeding fiscal years, to carry out the purposes
of this subpart. Funds shall remain available for obligation

1	until the end of the fourth fiscal year immediately succeed-
2	ing the fiscal year for which such funds were appropriated.
3	"(d) TERMS OF SCHOLARSHIPS.—
4	"(1) Amount of scholarship.—(A) The
5	amount of a scholarship awarded under this subpart
6	shall be \$1,000.
7	"(B) Notwithstanding subparagraph (A), if
8	funds available in a fiscal year are insufficient to
9	fully fund all scholarships under this subpart, the
10	amount paid to each student shall be reduced pro-
11	portionately.
12	"(C) Notwithstanding any other provision of
13	this title, a scholarship awarded under this part—
14	"(i) shall not be counted in determining
15	the student's need for grant, loan, or work as-
16	sistance under this title; and
17	"(ii) may, alone or in combination with
18	other grant, loan, or work assistance received
19	under this title, exceed the student's cost of at-
20	tendance, as defined in section 472.
21	"(2) PERIOD OF SCHOLARSHIPS.—A student
22	who satisfies the requirements of subsection (f) may
23	receive a scholarship under this subpart for a period
24	of not more than 1 academic year of postsecondary

1	education or training on at least a half-time basis,
2	as determined by the institution.
3	"(3) Scholarship proceeds.—
4	"(A) USE AND AVAILABILITY.—Scholar-
5	ship proceeds shall be used for the scholarship
6	recipient's first year of postsecondary education
7	or training, and shall remain available for such
8	use for not more than 3 academic years follow-
9	ing his or her graduation from secondary
10	school.
11	"(B) DISBURSAL.—Scholarship proceeds
12	shall be disbursed on behalf of students who re-
13	ceive scholarships under this subpart to the in-
14	stitutions of higher education at which the stu-
15	dents are enrolled. No scholarship proceeds
16	shall be disbursed on behalf of a student until
17	the student is enrolled at an institution of high-
18	er education on at least a half-time basis, as de-
19	termined by such institution.
20	"(4) Use at any institution permitted.—
21	A scholarship awarded under this subpart may be
22	used to attend any institution of higher education,
23	as defined in section 481.
24	"(e) Selection of Scholars.—

1 "(1) IN GENERAL.—Scholarships shall be 2 awarded to all students who rank in the top 5 per-3 cent of the graduating class of each secondary school 4 that participates in the program under this subpart. 5 Ranking procedures shall be established by each 6 such school, but may not include any nonacademic 7 or extracurricular factors.

8 "(2) ANNUAL ANNOUNCEMENT OF SCHOLAR-9 SHIPS.—Each participating school shall announce 10 the availability of scholarships under this subpart, 11 and its selection procedures, to all students in the 12 school, and their parents, at the beginning of each 13 academic year.

14 "(3) RECORDS.—Each participating school
15 shall maintain records of its selection procedures,
16 the names of the students selected, and such other
17 related information as the Secretary may require.

18 "(f) STUDENT ELIGIBILITY.—In order to receive a19 scholarship under this subpart, a student must—

"(1) rank in the top 5 percent of the graduating class at the secondary school that he or she attends, as established by such school in accordance
with subsection (e); and

24 "(2) meet the requirements of section 484.
25 "(g) RECOGNITION OF SCHOLARSHIP RECEIPT.—

"(1) DESIGNATION OF SCHOLARSHIP RECIPI ENTS.—Students awarded scholarships under this
 subpart shall be known as 'Presidential Honors
 Scholars'.

"(2) CERTIFICATES; CEREMONIES.—The Sec-5 6 retary shall provide each student awarded a scholarship under this subpart a certificate from the Presi-7 8 dent that indicates that the recipient is a Presi-9 dential Honors Scholar. The certificates shall be 10 provided through the secondary schools that selected 11 such students. Such schools may present these cer-12 tificates in appropriate ceremonies.

13 "(h) EVALUATION.—The Secretary shall, from time
14 to time, conduct an evaluation of the program authorized
15 by this subpart.

16 "(i) SECRETARIAL AUTHORITY.—In order to carry
17 out the purposes of this subpart, the Secretary may, from
18 time to time, establish policies, procedures, and require19 ments, set deadlines, and require information.".
