## A BILL

To amend title XVIII of the Social Security Act to provide hospitals extend fair visitor privileges to non-family members.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Patient's Compassion
- 5 and Visitation Act of 1996".

- 2 VISITORS PRIVILEGES TO NON-FAMILY MEM-
- 3 BERS.
- 4 (a) REQUIREMENT.—Title XVIII of the Social Secu-
- 5 rity Act is amended by inserting after section 1867 the
- 6 following new section:
- 7 "VISITORS' FAIR ACCESS
- 8 "Sec. 1867A. (a) In General.—A hospital or rural
- 9 primary care hospital shall extend to a visitor of an inpa-
- 10 tient who is designated by the inpatient but who is not
- 11 a relative of the inpatient the same visiting privileges as
- 12 apply to visitors who are relatives of the inpatient.
- 13 "(b) Construction.—Nothing in this section shall
- 14 be construed as preventing a hospital from establishing
- 15 rules and procedures governing time, duration, location,
- 16 age restrictions, and other terms and conditions of inpa-
- 17 tient visitation, so long as such terms and conditions do
- 18 not treat designated visitors who are not relatives dif-
- 19 ferently from visitors who are relatives.
- 20 "(c) Enforcement.—The provisions of paragraphs
- 21 (1)(A) and (2) of subsection (d) of section 1867 (relating
- 22 to civil monetary penalties and civil enforcement) shall
- 23 apply to violations of subsection (a) in the same manner
- 24 as they apply to violations of such section.".

2	MENT.—Section 1866(a)(1) of such Act (42 U.S.C.
3	1395cc(a)(1)) is amended—
4	(1) by striking "and" at the end of subpara-
5	graph (Q),
6	(2) by striking the period at the end of sub-
7	paragraph (R) and inserting "; and", and
8	(3) by inserting after subparagraph (R) the fol-
9	lowing new subparagraph:
10	"(S) in the case of a hospital or rural primary
11	care hospital, to adopt and enforce a policy to ensure
12	compliance with the requirements of section 1867A
13	and to meet the requirements of such section."
14	(c) Effective Date.—The amendments made by
15	this section shall apply to the extension of visiting privi-
16	leges occurring on or after the first day of the first month
17	that begins more than 45 days after the date of the enact-
18	ment of this Act.
