A BILL

To improve the administration of the Women's Rights National Historical Park in the State of New York, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCLUSION OF ADDITIONAL PROPERTIES.**

4 Section 1601(c) of the Act of December 28, 1980 (16
5 U.S.C. 410 ll) is amended as follows:

6 (1) By striking "initially".

7 (2) By striking "and" at the end of paragraph

8 (8).

1 (3) By striking the period at the end of para-
2 graph (9) and inserting a semicolon.

3 (4) By adding the following at the end thereof:

4 “(10) not to exceed 1 acre, plus improvements,
5 as determined by the Secretary, in Seneca Falls for
6 development of a maintenance facility;

7 “(11) dwelling, 1 Seneca Street, Seneca Falls;

8 “(12) dwelling, 10 Seneca Street, Seneca Falls;

9 “(13) parcels adjacent to Wesleyan Chapel
10 Block, including Clinton Street, Fall Street, and
11 Mynderse Street, Seneca Falls; and

12 “(14) dwelling, 12 East Williams Street, Water-
13 loo.”.

14 **SEC. 2. MISCELLANEOUS AMENDMENTS TO 1980 ACT.**

15 Section 1601 of the Act of December 28, 1980 (16
16 U.S.C. 410 ll) is amended as follows:

17 (1) By inserting “(1)” after “(i)” in subsection
18 (i) and adding at the end of such subsection (i) the
19 following new paragraph:

20 “(2) In addition to those sums previously appro-
21 priated for land acquisition and development, there is
22 hereby authorized to be appropriated for fiscal years after
23 September 30, 1994, \$2,000,000.”.

24 (2) In subsection (h)(5) by striking “ten years”
25 and inserting “25 years”.

- 1 (3) In subsection (c), by deleting paragraph (7)
- 2 and renumbering the remaining paragraphs
- 3 accordingly.
