Mrs. WALDHOLTZ, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1617) to consolidate and reform workforce development and literacy programs, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1617) to consolidate and reform
6 workforce development and literacy programs, and for
7 other purposes. The first reading of the bill shall be dis-

1 pensed with. General debate shall be confined to the bill
2 and shall not exceed one hour equally divided and con-
3 trolled by the chairman and ranking minority member of
4 the Committee on Economic and Educational Opportuni-
5 ties. After general debate the bill shall be considered for
6 amendment under the five-minute rule. In lieu of the
7 amendment recommended by the Committee on Economic
8 and Educational Opportunities now printed in the bill, it
9 shall be in order to consider as an original bill for the
10 purpose of amendment under the five-minute rule an
11 amendment in the nature of a substitute consisting of the
12 text of H.R. 2332. That amendment in the nature of a
13 substitute shall be considered by title rather than by sec-
14 tion. The first six sections and each title shall be consid-
15 ered as read. Points of order against that amendment in
16 the nature of a substitute for failure to comply with clause
17 5(a) of rule XXI or section 302(f) or 401(b) of the Con-
18 gressional Budget Act of 1974 are waived. Before consid-
19 eration of any other amendment it shall be in order to
20 consider the amendment printed in the report of the Com-
21 mittee on Rules accompanying this resolution, if offered
22 by Representative Goodling or his designee. That amend-
23 ment shall be considered as read, may amend the portions
24 of the bill not yet read for amendment, shall be debatable
25 for ten minutes equally divided and controlled by the pro-

1 ponent and an opponent, shall not be subject to amend-
2 ment, and shall not be subject to a demand for division
3 of the question in the House or in the Committee of the
4 Whole. All points of order against that amendment are
5 waived. After disposition of that amendment, the provi-
6 sions of the bill as then perfected shall be considered as
7 original text. During further consideration of the bill for
8 amendment, the Chairman of the Committee of the Whole
9 may accord priority in recognition on the basis of whether
10 the Member offering an amendment has caused it to be
11 printed in the portion of the Congressional Record des-
12 ignated for that purpose in clause 6 of rule XXIII. Amend-
13 ments so printed shall be considered as read. At the con-
14 clusion of consideration of the bill for amendment the
15 Committee shall rise and report the bill to the House with
16 such amendments as may have been adopted. Any Member
17 may demand a separate vote in the House on any amend-
18 ment adopted in the Committee of the Whole to the bill
19 or to the amendment in the nature of a substitute made
20 in order as original text. The previous question shall be
21 considered as ordered on the bill and amendments thereto
22 to final passage without intervening motion except one
23 motion to recommit with or without instructions.
