Mr. LINDER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for the consideration of the bill (H.R. 2546) making appropriations for the government of the District of Columbia and other activities chargeable in whole or in part against the revenues of said District for the fiscal year ending September 30, 1996, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-

1 ation of the bill (H.R. 2546) making appropriations for  
2 the government of the District of Columbia and other ac-  
3 tivities chargeable in whole or in part against the revenues  
4 of said District for the fiscal year ending September 30,  
5 1996, and for other purposes. The first reading of the bill  
6 shall be dispensed with. All points of order against consid-  
7 eration of the bill are waived. General debate shall be con-  
8 fined to the bill and amendments specified in this resolu-  
9 tion and shall not exceed one hour equally divided and con-  
10 trolled by the chairman and ranking minority member of  
11 the Committee on Appropriations. After general debate  
12 the bill shall be considered for amendment under the five-  
13 minute rule. Before consideration of any other amend-  
14 ment, it shall be in order without intervention of any point  
15 of order to consider the amendment printed in the report  
16 of the Committee on Rules accompanying this resolution,  
17 if offered by a Member designated in the report. That  
18 amendment shall be considered as read, shall be debatable  
19 for ten minutes equally divided and controlled by the pro-  
20 ponent and an opponent, shall not be subject to amend-  
21 ment, and shall not be subject to a demand for division  
22 of the question in the House or in the Committee of the  
23 Whole. If that amendment is adopted, the bill, as amend-  
24 ed, shall be considered as the original bill for the purpose  
25 of further amendment. The bill, as amended, shall be con-

1 sidered as read through page 58, line 4. All points of order  
2 against provisions of the bill, as amended, for failure to  
3 comply with clause 2 or 6 of rule XXI are waived. Debate  
4 on each further amendment to the bill and any amend-  
5 ments thereto shall be limited to thirty minutes. It shall  
6 be in order without intervention of any point of order to  
7 consider each of the amendments printed in the Congres-  
8 sional Record and numbered 1, 2, or 4 pursuant to clause  
9 6 of rule XXIII, if offered by the Member who caused it  
10 to be printed or a designee. Each such amendment shall  
11 be considered as read, shall be debatable for thirty min-  
12 utes equally divided and controlled by the proponent and  
13 an opponent, shall not be subject to amendment, and shall  
14 not be subject to a demand for division of the question  
15 in the House or in the Committee of the Whole. During  
16 consideration of the bill for amendment, the Chairman of  
17 the Committee of the Whole may accord priority in rec-  
18 ognition on the basis of whether the Member offering an  
19 amendment has caused it to be printed in the portion of  
20 the Congressional Record designated for that purpose in  
21 clause 6 of rule XXIII. Amendments so printed shall be  
22 considered as read. At the conclusion of consideration of  
23 the bill for amendment the Committee shall rise and re-  
24 port the bill, as amended, to the House with such further  
25 amendments as may have been adopted. The previous

1 question shall be considered as ordered on the bill, as  
2 amended, and amendments thereto to final passage with-  
3 out intervening motion except one motion to recommit  
4 with or without instructions.
