Mr. DREIER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3019) making appropriations for fiscal year 1996 to make a further downpayment toward a balanced budget, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3019) making appropriations for
6 fiscal year 1996 to make a further downpayment toward

1 a balanced budget, and for other purposes. The first read-
2 ing of the bill shall be dispensed with. General debate shall
3 be confined to the bill and shall not exceed one hour equal-
4 ly divided and controlled by the chairman and ranking mi-
5 nority member of the Committee on Appropriations. After
6 general debate the bill shall be considered for amendment
7 under the five-minute rule. The amendment printed in sec-
8 tion 2 of this resolution shall be considered as adopted
9 in the House and in the Committee of the Whole. The
10 bill, as amended, shall be considered as the original bill
11 for the purpose of further amendment. The bill, as amend-
12 ed, shall be considered as read. No further amendment
13 shall be in order except those specified in the report of
14 the Committee on Rules accompanying this resolution.
15 Each further amendment may be considered only in the
16 order specified in the report, may be offered only by a
17 Member designated in the report, shall be considered as
18 read, shall be debatable for the time specified in the report
19 equally divided and controlled by the proponent and an
20 opponent, shall not be subject to amendment except as
21 specified in the report, and shall not be subject to a de-
22 mand for division of the question in the House or in the
23 Committee of the Whole. All points of order against the
24 amendments specified in the report are waived. At the con-
25 clusion of consideration of the bill for amendment the

1 Committee shall rise and report the bill to the House with
2 such amendments as may have been adopted. The previous
3 question shall be considered as ordered on the bill and
4 amendments thereto to final passage without intervening
5 motion except one motion to recommit. The motion to re-
6 commit may include instructions only if offered by the mi-
7 nority leader or his designee.

8 SEC. 2. The amendment considered as adopted in the
9 House and in the Committee of the Whole is as follows:

10 Page 539, line 16, strike “specifically addresses the
11 availability of” and insert in lieu thereof “expressly makes
12 available for obligation”.
