AN ACT

- To clarify the application of certain Federal criminal laws to territories, possessions, and commonwealths, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Possessions and Terri-
- 5 tories Criminal Law Clarification Act".

3 (a) Sections 241 and 242 of title 18, United States
4 Code, are each amended by striking "any State, Territory,
5 or District" and inserting "any State, Territory, Common6 wealth, Possession, or District".

7 (b) Sections 793(h)(1) and 794(d)(1) of title 18,
8 United States Code, are each amended by adding at the
9 end the following: "For the purposes of this subsection,
10 the term 'State' includes a State of the United States, the
11 District of Columbia, and any commonwealth, territory,
12 or possession of the United States.".

(c) Section 925(a)(5) of title 18, United States Code,
is amended by striking "For the purpose of paragraphs
(3) and (4)" and inserting "For the purpose of paragraph
(3)".

(d) Sections 1014 and 2113(g) of title 18, United
States Code, are each amended by adding at the end the
following: "The term 'State-chartered credit union' includes a credit union chartered under the laws of a State
of the United States, the District of Columbia, or any
commonwealth, territory, or possession of the United
States.".

(e) Section 1073 of title 18, United States Code, is
amended by adding at the end of the first paragraph the
following: "For the purposes of clause (3) of this para-

graph, the term 'State' includes a State of the United
 States, the District of Columbia, and any commonwealth,
 territory, or possession of the United States.".

4 (f) Section 1715 of title 18, United States Code, is
5 amended by striking "State, Territory, or District" each
6 place those words appear and inserting "State, Territory,
7 Commonwealth, Possession, or District".

8 (g) Section 1716 of title 18, United States Code, is
9 amended—

10 (1) in subsection (g)(2) by striking "State, Ter11 ritory, or the District of Columbia" and inserting
12 "State";

(2) in subsection (g)(3) by striking "the municipal government of the District of Columbia or of the government of any State or territory, or any county,
city, or other political subdivision of a State" and inserting "any State, or any political subdivision of a
State"; and

19 (3) by adding at the end the following:

"(j) For purposes of this section, the term 'State' includes a State of the United States, the District of Columbia, and any commonwealth, territory, or possession of the
United States.".

(h) Section 1761 of title 18, United States Code, is
 amended by adding at the end the following new sub section:

4 "(d) For the purposes of this section, the term 'State'
5 means a State of the United States and any common6 wealth, territory, or possession of the United States.".

7 (i) Section 3156(a) of title 18, United States Code,
8 is amended—

9 (1) by striking "and" at the end of paragraph
10 (3);

(2) by striking the period and inserting "; and"at the end of paragraph (4); and

(3) by adding at the end the following newparagraph:

15 "(5) the term 'State' includes a State of the
16 United States, the District of Columbia, and any
17 commonwealth, territory, or possession of the United
18 States.".

(j) Section 102 of the Controlled Substances Act (21
U.S.C. 802) is amended—

21 (1) by amending paragraph (26) to read as fol-22 lows:

23 "(26) The term 'State' means a State of the
24 United States, the District of Columbia, and any

commonwealth, territory, or possession of the United
 States."; and

3 (2) by redesignating paragraph (43), as added
4 by section 90105(d) of the Violent Crime Control
5 and Law Enforcement Act of 1994, as paragraph
6 (44).

7 (k) Section 1121 of title 18, United States Code, is8 amended by adding at the end the following new sub-9 section:

"(c) For the purposes of this section, the term 'State'
means a State of the United States, the District of Columbia, and any commonwealth, territory, or possession of the
United States.".

(1) Section 228(d)(2) of title 18, United States Code,
is amended by inserting "commonwealth," before "possession or territory of the United States".

(m) Section 1546(c) of title 18, United States Code,
is amended by adding at the end the following: "For purposes of this section, the term 'State' means a State of
the United States, the District of Columbia, and any commonwealth, territory, or possession of the United States.".

(n) Section 1541 of title 18, United States Code, isamended—

24 (1) in the first undesignated paragraph, by25 striking "or possession"; and

(2) by adding at the end the following new
 paragraph:

3 "For purposes of this section, the term 'State' means
4 a State of the United States, the District of Columbia,
5 and any commonwealth, territory, or possession of the
6 United States.".

7 (o) Section 37(c) of title 18, United States Code, is 8 amended in the final sentence by inserting before the pe-9 riod the following: ", and the term 'State' means a State 10 of the United States, the District of Columbia, and any 11 commonwealth, territory, or possession of the United 12 States".

(p) Section 2281(c) of title 18, United States Code,
is amended in the final sentence by inserting before the
period the following: ", and the term 'State' means a State
of the United States, the District of Columbia, and any
commonwealth, territory, or possession of the United
States".

(q) Section 521(a) of title 18, United States Code,
is amended by adding at the end the following: "State'
means a State of the United States, the District of Columbia, and any commonwealth, territory, or possession of the
United States.".

1 SEC. 3. EFFECTIVE DATE.

2 This Act and the amendments made by this Act shall3 apply to offenses committed on or after the date of enact-4 ment of this Act.
