5 (a) IN GENERAL.—Part C of title IV (42 U.S.C. 285

10 **“SEC. 464Z. PURPOSE OF THE INSTITUTE.**

11 “(a) IN GENERAL.—The general purpose of the Na-
12 tional Human Genome Research Institute is to character-
13 ize the structure and function of the human genome, in-
14 cluding the mapping and sequencing of individual genes.
15 Such purpose includes—

16 “(1) planning and coordinating the research
17 goal of the genome project;

18 “(2) reviewing and funding research proposals;

19 “(3) conducting and supporting research train-
20 ing;

21 “(4) coordinating international genome re-
22 search;

23 “(5) communicating advances in genome science
24 to the public;

1 “(6) reviewing and funding proposals to address
2 the ethical, legal, and social issues associated with
3 the genome project (including legal issues regarding
4 patents); and

5 “(7) planning and administering intramural,
6 collaborative, and field research to study human ge-
7 netic disease.

8 “(b) RESEARCH.—The Director of the Institute may
9 conduct and support research training—

10 “(1) for which fellowship support is not pro-
11 vided under section 487; and

12 “(2) that is not residency training of physicians
13 or other health professionals.

14 “(c) ETHICAL, LEGAL, AND SOCIAL ISSUES.—

15 “(1) IN GENERAL.—Except as provided in para-
16 graph (2), of the amounts appropriated to carry out
17 subsection (a) for a fiscal year, the Director of the
18 Institute shall make available not less than 5 per-
19 cent of amounts made available for extramural re-
20 search for carrying out paragraph (6) of such sub-
21 section.

22 “(2) NONAPPLICATION.—With respect to pro-
23 viding funds under subsection (a)(6) for proposals to
24 address the ethical issues associated with the ge-
25 nome project, paragraph (1) shall not apply for a

1 fiscal year if the Director of the Institute certifies
2 to the Committee on Commerce of the House of
3 Representatives, and to the Committee on Labor
4 and Human Resources of the Senate, that the Direc-
5 tor has determined that an insufficient number of
6 such proposals meet the applicable requirements of
7 sections 491 and 492.

8 “(d) TRANSFER.—

9 “(1) IN GENERAL.—There are transferred to
10 the National Human Genome Research Institute all
11 functions which the National Center for Human Ge-
12 nome Research exercised before the date of enact-
13 ment of this subpart, including all related functions
14 of any officer or employee of the National Center for
15 Human Genome Research. The personnel employed
16 in connection with, and the assets, liabilities, con-
17 tracts, property, records, and unexpended balances
18 of appropriations, authorizations, allocations, and
19 other funds employed, used, held, arising from,
20 available to, or to be made available in connection
21 with the functions transferred under this subsection
22 shall be transferred to the National Human Genome
23 Research Institute.

24 “(2) LEGAL DOCUMENTS.—All orders, deter-
25 minations, rules, regulations, permits, agreements,

1 grants, contracts, certificates, licenses, regulations,
2 privileges, and other administrative actions which
3 have been issued, made, granted, or allowed to be-
4 come effective in the performance of functions which
5 are transferred under this subsection shall continue
6 in effect according to their terms until modified, ter-
7 minated, superseded, set aside, or revoked in accord-
8 ance with law.

9 “(3) REFERENCES.—References in any other
10 Federal law, Executive order, rule, regulation, or
11 delegation of authority, or any document of or relat-
12 ing to the National Center for Human Genome Re-
13 search shall be deemed to refer to the National
14 Human Genome Research Institute.

15 “(e) AUTHORIZATION OF APPROPRIATIONS.—There
16 are authorized to be appropriated to carry out this section,
17 such sums as may be necessary for each of the fiscal years
18 1997 through 1999.”.

8 “(14) may appoint physicians, dentists, and
9 other health care professionals, subject to the provi-
10 sions of title 5, United States Code, relating to ap-
11 pointments and classifications in the competitive
12 service, and may compensate such professionals sub-
13 ject to the provisions of chapter 74 of title 38,
14 United States Code.”.

22 **“SEC. 404F. OFFICE FOR RARE DISEASE RESEARCH.**

23 “(a) ESTABLISHMENT.—There is established within
24 the Office of the Director of the National Institutes of
25 Health an office to be known as the Office for Rare Dis-

1 ease Research (in this section referred to as the ‘Office’).
2 The Office shall be headed by a director, who shall be ap-
3 pointed by the Director of the National Institutes of
4 Health.

5 “(b) PURPOSE.—The purpose of the Office is to pro-
6 mote and coordinate the conduct of research on rare dis-
7 eases through a strategic research plan and to establish
8 and manage a rare disease research clinical database.

9 “(c) ADVISORY COUNCIL.—The Secretary shall es-
10 tablish an advisory council for the purpose of providing
11 advice to the director of the Office concerning carrying
12 out the strategic research plan and other duties under this
13 section. Section 222 shall apply to such council to the
14 same extent and in the same manner as such section ap-
15 plies to committees or councils established under such sec-
16 tion.

17 “(d) DUTIES.—In carrying out subsection (b), the di-
18 rector of the Office shall—

19 “(1) develop a comprehensive plan for the con-
20 duct and support of research on rare diseases;

21 “(2) coordinate and disseminate information
22 among the institutes and the public on rare diseases;

23 “(3) support research training and encourage
24 the participation of a diversity of individuals in the
25 conduct of rare disease research;

1 “(4) identify projects or research on rare dis-
2 eases that should be conducted or supported by the
3 National Institutes of Health;

4 “(5) develop and maintain a central database
5 on current government sponsored clinical research
6 projects for rare diseases;

7 “(6) determine the need for registries of re-
8 search subjects and epidemiological studies of rare
9 disease populations; and

10 “(7) prepare biennial reports on the activities
11 carried out or to be carried out by the Office and
12 submit such reports to the Secretary and the Con-
13 gress.”.

14 **Subtitle C—Certain** 15 **Reauthorizations**

16 **SEC. 621. NATIONAL RESEARCH SERVICE AWARDS.**

17 Section 487(d) (42 U.S.C. 288(d)) is amended by

4 **Provisions**

5 **SEC. 631. ESTABLISHMENT OF NATIONAL FUND FOR**
6 **HEALTH RESEARCH.**

7 Part A of title IV (42 U.S.C. 281 et seq.), as amend-
8 ed by section 611, is further amended by adding at the
9 end thereof the following new section:

10 **“SEC. 404G. ESTABLISHMENT OF NATIONAL FUND FOR**
11 **HEALTH RESEARCH.**

12 “(a) ESTABLISHMENT.—There is established in the
13 Treasury of the United States a fund, to be known as the
14 ‘National Fund for Health Research’ (hereafter in this
15 section referred to as the ‘Fund’), consisting of such
16 amounts as are transferred to the Fund and any interest
17 earned on investment of amounts in the Fund.

18 “(b) OBLIGATIONS FROM FUND.—

19 “(1) IN GENERAL.—Subject to the provisions of
20 paragraph (2), with respect to the amounts made
21 available in the Fund in a fiscal year, the Secretary
22 shall distribute all of such amounts during any fiscal
23 year to research institutes and centers of the Na-
24 tional Institutes of Health in the same proportion to
25 the total amount received under this section, as the

1 amount of annual appropriations under appropria-
2 tions Acts for each member institute and centers for
3 the fiscal year bears to the total amount of appro-
4 priations under appropriations Acts for all research
5 institutes and centers of the National Institutes of
6 Health for the fiscal year.

7 “(2) TRIGGER AND RELEASE OF MONIES.—No
8 expenditure shall be made under paragraph (1) dur-
9 ing any fiscal year in which the annual amount ap-
10 propriated for the National Institutes of Health is
11 less than the amount so appropriated for the prior
12 fiscal year.”.

13 **SEC. 632. DEFINITION OF CLINICAL RESEARCH.**

14 Part A of title *IV* (42 U.S.C. 281 et seq.) as
15 amended by sections 611 and 631, is further amended by
16 adding at the end thereof the following new section:

17 **“SEC. 404H. DEFINITION OF CLINICAL RESEARCH.**

18 “As used in this title, the term ‘clinical research’
19 means patient oriented clinical research conducted with
20 human subjects, or research on the causes and con-
21 sequences of disease in human populations, or on material
22 of human origin (such as tissue specimens and cognitive
23 phenomena) for which an investigator or colleague directly
24 interacts with human subjects in an outpatient or inpa-
25 tient setting to clarify a problem in human physiology,

1 pathophysiology, or disease, epidemiologic or behavioral
2 studies, outcomes research, or health services research.”.

3 **SEC. 633. SENIOR BIOMEDICAL RESEARCH SERVICE.**

4 Section 228 (42 U.S.C. 237) is amended by adding
5 at the end thereof the following new subsection:

6 “(h) Notwithstanding any other provision of law, the
7 Secretary shall be treated as a non-profit entity for the
8 purposes of making contributions to the retirement sys-
9 tems of appointees under this section in a manner that
10 will permit such appointees to continue to be fully covered
11 under the retirement systems that such appointees were
12 members of immediately prior to their appointment under
13 this section.”.

14 **SEC. 634. ESTABLISHMENT OF A PEDIATRIC RESEARCH INI-**
15 **TIATIVE.**

16 *Part A of title IV (42 U.S.C. 281 et seq.), as amended*
17 *by sections 611, 631, and 632, is further amended by adding*

19 **“SEC. 404I. PEDIATRIC RESEARCH INITIATIVE**

20 *“(a) ESTABLISHMENT.—The Secretary shall establish*
21 *within the Office of the Director of NIH a Pediatric Re-*
22 *search Initiative (hereafter in this section referred to as the*
23 *‘Initiative’). The Initiative shall be headed by the Director*
24 *of NIH.*

1 “(b) *PURPOSE.*—*The purpose of the Initiative is to*
2 *provide funds to enable the Director of NIH to encourage—*

3 “(1) *increased support for pediatric biomedical*
4 *research within the National Institutes of Health to*
5 *ensure that the expanding opportunities for advance-*
6 *ment in scientific investigations and care for children*
7 *are realized;*

8 “(2) *enhanced collaborative efforts among the In-*
9 *stitutes to support multidisciplinary research in the*
10 *areas that the Director deems most promising;*

11 “(3) *increased support for pediatric outcomes*
12 *and medical effectiveness research to demonstrate how*
13 *to improve the quality of children’s health care while*
14 *reducing cost;*

15 “(4) *the development of adequate pediatric clini-*
16 *cal trials and pediatric use information to promote*
17 *the safer and more effective use of prescription drugs*
18 *in the pediatric population; and*

19 “(5) *recognition of the special attention pediatric*
20 *research deserves.*

21 “(c) *DUTIES.*—*In carrying out subsection (b), the Di-*
22 *rector of NIH shall—*

23 “(1) *consult with the Institutes and other advi-*
24 *sors as the Director determines appropriate when con-*

1 *sidering the role of the Institute for Child Health and*
 2 *Human Development;*

3 *“(2) have broad discretion in the allocation of*
 4 *any Initiative assistance among the Institutes, among*
 5 *types of grants, and between basic and clinical re-*
 6 *search so long as the—*

7 *“(A) assistance is directly related to the ill-*
 8 *nesses and diseases of children; and*

9 *“(B) assistance is extramural in nature;*
 10 *and*

11 *“(3) be responsible for the oversight of any newly*
 12 *appropriated Initiative funds and be accountable*
 13 *with respect to such funds to Congress and to the pub-*
 14 *lic.*

15 *“(d) AUTHORIZATION.—There is authorized to be ap-*
 16 *propriated to carry out this section, \$50,000,000 for fiscal*
 17 *years 1997 through 1999.*

18 *“(e) TRANSFER OF FUNDS.—The Director of NIH may*
 19 *transfer amounts appropriated to any of the Institutes for*
 20 *a fiscal year to the Initiative to carry out this section.”.*

21 **SEC. 635. DIABETES RESEARCH.**

22 *(a) FINDINGS.—The Congress finds as follows:*

23 *(1) Diabetes is a serious health problem in*
 24 *America.*

1 (2) *More than 16,000,000 Americans suffer from*
2 *diabetes.*

3 (3) *Diabetes is the fourth leading cause of death*
4 *in America, taking the lives of more than 169,000*
5 *people annually.*

6 (4) *Diabetes disproportionately affects minority*
7 *populations, especially African-Americans, Hispanics,*
8 *and Native Americans.*

9 (5) *Diabetes is the leading cause of new blind-*
10 *ness in adults over age 30.*

11 (6) *Diabetes is the leading cause of kidney fail-*
12 *ure requiring dialysis or transplantation, affecting*
13 *more than 56,000 Americans each year.*

14 (7) *Diabetes is the leading cause of nontraumatic*
15 *amputations, affecting 54,000 Americans each year.*

16 (8) *The cost of treating diabetes and its com-*
17 *plications are staggering for our Nation.*

18 (9) *Diabetes accounted for health expenditures of*
19 *\$105,000,000,000 in 1992.*

20 (10) *Diabetes accounts for over 14 percent of our*
21 *Nation's health care costs.*

22 (11) *Federal funds invested in diabetes research*
23 *over the last two decades has led to significant ad-*
24 *vances and, according to leading scientists and*
25 *endocrinologists, has brought the United States to the*

1 *threshold of revolutionary discoveries which hold the*
2 *potential to dramatically reduce the economic and so-*
3 *cial burden of this disease.*

4 *(12) The National Institute of Diabetes and Di-*
5 *gestive and Kidney Diseases supports, in addition to*
6 *many other areas of research, genetic research, islet*
7 *cell transplantation research, and prevention and*
8 *treatment clinical trials focusing on diabetes. Other*
9 *research institutes within the National Institutes of*
10 *Health conduct diabetes-related research focusing on*
11 *its numerous complications, such as heart disease, eye*
12 *and kidney problems, amputations, and diabetic neu-*
13 *ropathy.*

14 *(b) INCREASED FUNDING REGARDING DIABETES.—*
15 *With respect to the conduct and support of diabetes-related*
16 *research by the National Institutes of Health, there are au-*
17 *thorized to be appropriated for such purpose—*

18 *(1) for each of the fiscal years 1997 through*
19 *1999, an amount equal to the amount appropriated*
20 *for such purpose for fiscal year 1996; and*

21 *(2) for the 3-fiscal year period beginning with*
22 *fiscal year 1997, an additional amount equal to 25*
23 *percent of the amount appropriated for such purpose*
24 *for fiscal year 1996.*

1 **SEC. 636. PARKINSON'S RESEARCH.**

2 *Part B of title IV (42 U.S.C. 284 et seq.), as amended*
3 *by sections 204, 382 and 383, is further amended by adding*
4 *at the end the following section:*

5 *“PARKINSON'S DISEASE*

6 *“SEC. 409E. (a) IN GENERAL.—The Director of NIH*
7 *shall establish a program for the conduct and support of*
8 *research and training with respect to Parkinson's disease.*

9 *“(b) INTER-INSTITUTE COORDINATION.—*

10 *“(1) IN GENERAL.—The Director of NIH shall*
11 *provide for the coordination of the program estab-*
12 *lished under subsection (a) among all of the national*
13 *research institutes conducting Parkinson's research.*

14 *“(2) CONFERENCE.—Coordination under para-*
15 *graph (1) shall include the convening of a research*
16 *planning conference not less frequently than once*
17 *every 2 years. Each such conference shall prepare and*
18 *submit to the Committee on Appropriations and the*
19 *Committee on Labor and Human Resources of the*
20 *Senate and the Committee on Appropriations and the*
21 *Committee on Commerce of the House of Representa-*
22 *tives a report concerning the conference.*

23 *“(c) MORRIS K. UDALL RESEARCH CENTERS.—*

24 *“(1) IN GENERAL.—The Director of NIH shall*
25 *award Core Center Grants to encourage the develop-*
26 *ment of innovative multidisciplinary research and*

1 *provide training concerning Parkinson's. The Direc-*
2 *tor shall award not more than 10 Core Center Grants*
3 *and designate each center funded under such grants*
4 *as a Morris K. Udall Center for Research on Parkin-*
5 *son's Disease.*

6 *“(2) REQUIREMENTS.—*

7 *“(A) IN GENERAL.—With respect to Parkin-*
8 *son's, each center assisted under this subsection*
9 *shall—*

10 *“(i) use the facilities of a single insti-*
11 *tution or a consortium of cooperating insti-*
12 *tutions, and meet such qualifications as*
13 *may be prescribed by the Director of the*
14 *NIH; and*

15 *“(ii) conduct basic and clinical re-*
16 *search.*

17 *“(B) DISCRETIONARY REQUIREMENTS.—*

18 *With respect to Parkinson's, each center assisted*
19 *under this subsection may—*

20 *“(i) conduct training programs for sci-*
21 *entists and health professionals;*

22 *“(ii) conduct programs to provide in-*
23 *formation and continuing education to*
24 *health professionals;*

1 “(iii) conduct programs for the dis-
2 semination of information to the public;

3 “(iv) develop and maintain, where ap-
4 propriate, a brain bank to collect specimens
5 related to the research and treatment of
6 Parkinson’s;

7 “(v) separately or in collaboration
8 with other centers, establish a nationwide
9 data system derived from patient popu-
10 lations with Parkinson’s, and where pos-
11 sible, comparing relevant data involving
12 general populations;

13 “(vi) separately or in collaboration
14 with other centers, establish a Parkinson’s
15 Disease Information Clearinghouse to facili-
16 tate and enhance knowledge and under-
17 standing of Parkinson’s disease; and

18 “(vii) separately or in collaboration
19 with other centers, establish a national edu-
20 cation program that fosters a national focus
21 on Parkinson’s and the care of those with
22 Parkinson’s.

23 “(3) STIPENDS REGARDING TRAINING PRO-
24 GRAMS.—A center may use funds provided under
25 paragraph (1) to provide stipends for scientists and

1 *health professionals enrolled in training programs*
2 *under paragraph (2)(B).*

3 “(4) *DURATION OF SUPPORT.*—*Support of a cen-*
4 *ter under this subsection may be for a period not ex-*
5 *ceeding five years. Such period may be extended by*
6 *the Director of NIH for one or more additional peri-*
7 *ods of not more than five years if the operations of*
8 *such center have been reviewed by an appropriate*
9 *technical and scientific peer review group established*
10 *by the Director and if such group has recommended*
11 *to the Director that such period should be extended.*

12 “(d) *MORRIS K. UDALL AWARDS FOR INNOVATION IN*
13 *PARKINSON’S DISEASE RESEARCH.*—*The Director of NIH*
14 *shall establish a grant program to support innovative pro-*
15 *posals leading to significant breakthroughs in Parkinson’s*
16 *research. Grants under this subsection shall be available to*
17 *support outstanding neuroscientists and clinicians who*
18 *bring innovative ideas to bear on the understanding of the*
19 *pathogenesis, diagnosis and treatment of Parkinson’s dis-*
20 *ease.*

21 “(e) *AUTHORIZATION OF APPROPRIATIONS.*—*For the*
22 *purpose of carrying out this section, there are authorized*
23 *to be appropriated \$80,000,000 for fiscal year 1997, and*
24 *such sums as may be necessary for each of the fiscal years*
25 *1998 and 1999.”*
