# A BILL

To amend title XVIII of the Social Security Act to make certain changes to hospice care under the Medicare program.

- 4 after the date of the enactment of this Act, regardless of
- 5 whether or not an individual has made an election under
- 6 section 1812(d) of the Social Security Act before such

7 date.
