A BILL

To amend the Individuals with Disabilities Education Act to extend the Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Individuals with Dis-
5 abilities Education Act Amendments of 1995”.

6 **SEC. 2. REAUTHORIZATION OF RESERVATION FOR OUT-**
7 **REACH PLAN.**

8 Section 610(j)(2)(C)(iii) of the Individuals with Dis-
9 abilities Education Act (20 U.S.C. 1409(j)(2)(C)(iii)) is

1 amended by striking “the fiscal years 1991 through 1994”
2 and inserting “fiscal years 1991 through 1996”.

3 **SEC. 3. REAUTHORIZATION OF AUTHORITIES RELATING TO**
4 **EVALUATION AND PROGRAM INFORMATION.**

5 Section 618(h) of the Individuals with Disabilities
6 Education Act (20 U.S.C. 1418(h)) is amended by strik-
7 ing “fiscal years 1992 through 1994” and inserting “fiscal
8 years 1992 through 1996”.

9 **SEC. 4. REAUTHORIZATION OF AUTHORITIES RELATING TO**
10 **CENTERS AND SERVICES TO MEET SPECIAL**
11 **NEEDS OF INDIVIDUALS WITH DISABILITIES.**

12 (a) REGIONAL CENTERS FOR THE DEAF.—Section
13 625(a)(6) of the Individuals with Disabilities Education
14 Act (20 U.S.C. 1424a(a)(6)) is amended—

15 (1) in the second sentence, by striking “1994”
16 and inserting “1996”; and

17 (2) by striking the third sentence.

18 (b) AUTHORIZATION OF APPROPRIATIONS.—Each of
19 subsections (a) through (h) of section 628 of such Act (20
20 U.S.C. 1427) is amended by striking “fiscal year 1994”
21 and inserting “each of fiscal years 1994 through 1996”.

1 **SEC. 5. REAUTHORIZATION OF AUTHORITIES RELATING TO**
2 **TRAINING PERSONNEL FOR THE EDUCATION**
3 **OF INDIVIDUALS WITH DISABILITIES.**

4 (a) AUTHORIZATION OF APPROPRIATIONS.—Each of
5 paragraphs (1) through (4) of section 635(a) of such Act
6 (20 U.S.C. 1435(a)) is amended by striking “fiscal year
7 1994” and inserting “each of fiscal years 1994 through
8 1996”.

9 (b) CONFORMING AMENDMENTS.—Each of para-
10 graphs (1) and (3) of section 635(a) of such Act is amend-
11 ed by striking “631(d)” and inserting “631(e)”.

12 **SEC. 6. REAUTHORIZATION OF AUTHORITIES RELATING TO**
13 **RESEARCH IN THE EDUCATION OF INDIVID-**
14 **UALS WITH DISABILITIES.**

15 Section 643 of the Individuals with Disabilities Edu-
16 cation Act (20 U.S.C. 1443) is amended by striking “fiscal
17 year 1994” and inserting “each of fiscal years 1994
18 through 1996”.

19 **SEC. 7. REAUTHORIZATION OF AUTHORITIES RELATING TO**
20 **INSTRUCTIONAL MEDIA FOR INDIVIDUALS**
21 **WITH DISABILITIES.**

22 Section 653 of the Individuals with Disabilities Edu-
23 cation Act (20 U.S.C. 1454) is amended by striking “fiscal
24 year 1994” and inserting “each of fiscal years 1994
25 through 1996”.

1 **SEC. 8. REAUTHORIZATION OF AUTHORITIES RELATING TO**
2 **TECHNOLOGY, EDUCATIONAL MEDIA, AND**
3 **MATERIALS FOR INDIVIDUALS WITH DISABIL-**
4 **ITIES.**

5 Section 662 of the Individuals with Disabilities Edu-
6 cation Act (20 U.S.C. 1462) is amended by striking “fiscal
7 year 1994” and inserting “each of fiscal years 1994
8 through 1996”.

9 **SEC. 9. REAUTHORIZATION OF AUTHORITIES RELATING TO**
10 **INFANTS AND TODDLERS WITH DISABILITIES.**

11 Section 686 of the Individuals with Disabilities Edu-
12 cation Act (20 U.S.C. 1485) is amended by striking “the
13 fiscal years 1993 and 1994” and inserting “fiscal years
14 1993 through 1996”.
