A BILL

To designate the United States Courthouse for the Eastern District of Virginia in Alexandria, Virginia, as the Albert V. Bryan United States Courthouse.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION OF ALBERT V. BRYAN UNITED**

4 **STATES COURTHOUSE.**

5 (a) NEW COURTHOUSE.—

1 (1) IN GENERAL.—The Federal building located
2 at Courthouse Square South and Jamieson Avenue
3 in Alexandria, Virginia, shall be known and des-
4 ignated as the “Albert V. Bryan United States
5 Courthouse”.

6 (2) REFERENCES.—Any reference in a law,
7 map, regulation, document, paper, or other record of
8 the United States to the Federal building referred to
9 in paragraph (1) shall be deemed to be a reference
10 to the “Albert V. Bryan United States Courthouse”.

11 (b) OLD COURTHOUSE.—

12 (1) IN GENERAL.—The Federal building located
13 at 200 South Washington Street in Alexandria, Vir-
14 ginia, shall not be known and designated as the
15 “Albert V. Bryan United States Courthouse”.

16 (2) REFERENCES.—Any reference in a law,
17 map, regulation, document, paper, or other record of
18 the United States to the Federal building known and
19 designated prior to the effective date of this section
20 as the “Albert V. Bryan United States Courthouse”
21 shall be deemed to be a reference to the Federal
22 building referred to in paragraph (1).

23 (c) EFFECTIVE DATE.—This section shall become ef-
24 fective on the date of the completion of the construction
25 of the Federal building referred to in subsection (a)(1).
