 5 shall be known and designated as the “David W. Dyer
 6 Federal Courthouse”.

7 **SEC. 2. REFERENCES.**

8 Any reference in a law, map, regulation, document,
 9 paper, or other record of the United States to the Federal
 10 building referred to in section 1 shall be deemed to be
 11 a reference to the “David W. Dyer Federal Courthouse”.

12 **SECTION 1. DESIGNATION.**

13 *The Federal building and United States courthouse lo-*
 14 *cated at 300 Northeast First Avenue in Miami, Florida,*
 15 *shall be known and designated as the “David W. Dyer Fed-*
 16 *eral Building and United States Courthouse”.*

17 **SEC. 2. REFERENCES.**

18 *Any reference in a law, map, regulation, document,*
 19 *paper, or other record of the United States to the Federal*
 20 *building referred to in section 1 shall be deemed to be a*
 21 *reference to the “David W. Dyer Federal Building and*
 22 *United States Courthouse”.*

Amend the title so as to read as follows: “A bill to designate the Federal building and United States courthouse located at 300 Northeast First Avenue in Miami, Florida, as the ‘David W. Dyer Federal Building and United States Courthouse’.”.
