### **AN ACT**

To amend the Great Lakes Fish and Wildlife Restoration Act of 1990 to provide for implementation of recommendations of the United States Fish and Wildlife Service contained in the Great Lakes Fishery Resources Restoration Study. Be it enacted by the Senate and House of Representa tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Great Lakes Fish and5 Wildlife Restoration Act of 1998".

#### 6 SEC. 2. FINDINGS.

7 Congress finds that—

8 (1) the Great Lakes Fishery Resources Res-9 toration Study, for which a report was submitted to 10 Congress in 1995, was a comprehensive study of the 11 status, and the assessment, management, and res-12 toration needs, of the fishery resources of the Great 13 Lakes Basin, and was conducted through the joint 14 effort of the United States Fish and Wildlife Serv-15 ice, State fish and wildlife resource management 16 agencies, Indian tribes, and the Great Lakes Fishery 17 Commission; and

18 (2) the study—

(A) found that, although State, Provincial,
Native American Tribal, and Federal agencies
have made significant progress toward the goal
of restoring a healthy fish community to the
Great Lakes Basin, additional actions and better coordination are needed to protect and ef-

#### 7 SEC. 3. REFERENCE; REPEAL.

8 (a) REFERENCE.—Each reference in this Act (other 9 than in subsection (b)) to the Great Lakes Fish and Wild-10 life Restoration Act of 1990 is a reference to the Act enacted by title I of Public Law 101–537 (104 Stat. 2370). 11 12 (b) REPEAL OF DUPLICATIVE ENACTMENT.—The Great Lakes Fish and Wildlife Restoration Act of 1990, 13 enacted as title II of Public Law 101-646 (104 Stat. 14 15 4773), is repealed.

3 Section 1005 of the Great Lakes Fish and Wildlife
4 Restoration Act of 1990 (16 U.S.C. 941c) is amended to
5 read as follows:

## 6 "SEC. 1005. IDENTIFICATION, REVIEW, AND IMPLEMENTA7 TION OF PROPOSALS.

8 "(a) IN GENERAL.—The Director, in consultation 9 with the Committee, shall encourage the development and, 10 subject to the availability of appropriations, the implemen-11 tation of proposals based on the results of the Report.

12 "(b) Identification of Proposals.—

"(1) REQUEST BY THE DIRECTOR.—The Director shall annually request that State Directors and
Indian Tribes, in cooperation or partnership with
other interested entities and based on the results of
the Report, submit proposals for the restoration of
fish and wildlife resources.

19 "(2) Requirements for proposals.—A pro-20 posal under paragraph (1) shall be submitted in the 21 manner and form prescribed by the Director and 22 shall be consistent with the goals of the Great Lakes 23 Water Quality Agreement, as revised in 1987, the 24 1954 Great Lakes Fisheries Convention, the 1980 25 Joint Strategic Plan for the Management of Great 26 Lakes fishery resources, the Nonindigenous Aquatic •HR 1481 EH

Nuisance Prevention and Control Act of 1990 (16
 U.S.C. 4701 et seq.), and the North American Wa terfowl Management Plan and joint ventures estab lished under the plan.

5 "(3) SEA LAMPREY AUTHORITY.—The Great 6 Lakes Fishery Commission shall retain authority 7 and responsibility for formulation and implementa-8 tion of a comprehensive program for eradicating or 9 minimizing sea lamprey populations in the Great 10 Lakes Basin.

11 "(c) REVIEW OF PROPOSALS.—

"(1) ESTABLISHMENT OF COMMITTEE.—There
is established the Great Lakes Fish and Wildlife
Restoration Proposal Review Committee, which shall
operate under the guidance of the Council of Lake
Committees of the Great Lakes Fishery Commission.
"(2) MEMBERSHIP AND APPOINTMENT.—

18 "(A) IN GENERAL.—The Committee shall
19 consist of representatives of all State Directors
20 and Indian Tribes with Great Lakes fish and
21 wildlife management authority in the Great
22 Lakes Basin.

23 "(B) APPOINTMENTS.—State Directors
24 and Tribal Chairs shall appoint their represent-

| 25 | appropriations and subsection (e), fund implementation of    |

the proposals. In selecting and funding proposals, the Di rector shall take into account the effectiveness and appro priateness of the proposals in fulfilling the purposes of
 other laws applicable to restoration of the fishery re sources and habitat of the Great Lakes Basin.

6 "(e) Cost-Sharing.—

"(1) IN GENERAL.—Not less than 25 percent of
the cost of implementing a proposal selected under
subsection (d) (not including the cost of establishing
sea lamprey barriers) shall be paid in cash or inkind contributions by non-Federal sources.

"(2) EXCLUSION OF FEDERAL FUNDS FROM
NON-FEDERAL SHARE.—The Director may not consider the expenditure, directly or indirectly, of Federal funds received by a State or local government
to be a contribution by a non-Federal source for
purposes of this subsection.".

#### 18 SEC. 7. REPORTS TO CONGRESS.
