A BILL

- To provide for the continuation of the operations of the California Urban Environmental Research and Education Center.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. FINDINGS.

- 4 The Congress finds the following:
- 5 (1) California's rapid population growth and
 6 the lack of understanding about the environmental
 7 impacts of this growth have caused a number of se-

| 3 | (2) California has great environmental complex- |

| 6 | (3) Future environmental policies for California |
| 7 | must be informed by careful cost-benefit analysis |
| 8 | that considers the serious risks, and the benefits, of |
| 9 | environmental policy. |
| 10 | (4) The California Urban Environmental Re- |
| 11 | search and Education Center promotes coordination |
| 12 | of and collaboration on environmentally sound eco- |
| 13 | nomic development in California and ensures that |
| 14 | continued sustainable economic development can |
| 15 | occur. |
| 16 | (5) Due to the closing of many military facili- |
| 17 | ties and installations in California, such Center can |
| 18 | provide important assistance to the process of con- |
| 19 | verting defense resources to non-defense uses. |
| 20 | (6) The Center is in a position to develop model |
| 21 | incentives and remove market barriers so as to moti- |
| 22 | vate greater private sector involvement and invest- |
| 23 | ment in the solution of environmental problems. |

1 SEC. 2. CENTER.

2 (a) SUPPORT.—The Administrator of the Environ3 mental Protection Agency shall continue to support the
4 development and expansion of the California Urban Envi5 ronmental Research and Education Center.

6 (b) COOPERATIVE AGREEMENT.—

7 (1) AUTHORITY.—If the California State Uni-8 versity, Hayward consents and provides the match-9 ing funds required by paragraph (2), the Adminis-10 trator shall enter into a series of cooperative agree-11 ments with the California State University, Hayward 12 to provide continuing support for the Center. The 13 California State University, Hayward shall work in 14 close cooperation with the other universities of the 15 California State University system (including the 16 California State Universities at Sacramento, San 17 Jose, San Francisco, and Sonoma) in the research 18 and policy analysis performed under any such coop-19 erative agreement.

(2) MATCHING FUNDS.—In any cooperative
agreement described in paragraph (1), the California
State University, Hayward, shall guarantee matching funds or in-kind resources equal to 20 percent
of the funds received by the Center from the Administrator. The Center and the California State University, Hayward shall, to the maximum extent prac-

| 5 | (3) MEMBERSHIP.—A university in the Califor- |
| 6 | nia State University system or a university in Cali- |
| 7 | fornia which is not a university in the California |
| 8 | State University system may become a member of |
| 9 | the Center under such guidelines and conditions as |
| 10 | are reasonable and mutually agreeable to the Center |
| 11 | and the university. |
| 12 | (c) GOVERNING BOARD.— |
| 13 | (1) INITIAL APPOINTMENTS.—For the two-year |
| 14 | period beginning on the date of the establishment of |
| 15 | the Center, the Center shall have a Governing Board |
| 16 | composed of the following: |
| 17 | (A) The Executive Director of the Center. |
| 18 | (B) One member appointed by the Presi- |
| 19 | dent of the California State University, Hay- |
| 20 | ward. |
| 21 | (C) One member appointed by the Presi- |
| 22 | dent of the California State University, Sac- |
| 23 | ramento. |

| 10 | (2) Subsequent appointments.—After the |
| 11 | two-year period referred to in paragraph (1), the |

| 15 | university of the California State University system, |
| 16 | except as provided in subsection $(d)(1)$. |
| 17 | (3) CHAIR.—The Executive Director shall serve |
| 18 | as chair of the Governing Board for the first five |
| 19 | years after the establishment of the Center. Subse- |

| 18 | spect to the management of grants, as the Gov- |
| 19 | erning Board considers necessary to carry out |
| 20 | the functions of the Center under this Act. |
| 21 | (d) EXECUTIVE DIRECTOR; STAFF.— |
| 22 | (1) EXECUTIVE DIRECTOR.—The Center shall |
| 23 | have an Executive Director who shall be appointed |
| 24 | for a five-year term. The President of the California |
| 25 | State University, Hayward shall make the initial ap- |

pointment of an Executive Director for a five-year

| 7 | (2) BUDGET.—The Executive Director shall an- |
| 8 | nually submit to the Governing Board a budget |
| 9 | which includes projected staff requirements and |
| 10 | other projected expenses. The Governing Board shall |
| 11 | review and advise on the budget each year. |
| 12 | (e) Principal Office.—(1) The principal office of |
| 13 | the Center shall be located in northern California. |
| 14 | (2) Before the end of the two-year period beginning |
| 15 | on the date of the establishment of the Center, the Gov- |
| 16 | erning Board shall consider the establishment of a second |
| 17 | office and conference facility to be located in southern |
| 18 | California, convenient to member universities. |
| 19 | SEC. 3. FUNCTIONS. |
| 20 | (a) IN GENERAL.—The overall objective of the Center |
| 21 | shall be to promote and foster sustainable economic devel- |
| 22 | opment throughout the State of California, using the re- |
| 23 | sources and skills of its universities and colleges whenever |
| 24 | possible. The Center shall achieve such objective by engag- |
| 25 | ing in the following functions: |
| | |

1 (1) To develop an ongoing program of applied 2 environmental research, education, and outreach 3 that can be used by the Federal Government, State 4 and local governments, and the private sector to ensure that future government policies to encourage 5 6 economic development in California are grounded on 7 sound, sustainable environmental and economic prin-8 ciples.

9 (2) To foster public-private partnerships to find 10 solutions to the environmental problems of Califor-11 nia and ways of removing market barriers to private 12 sector development.

13 (3) To bring together researchers from the 14 member universities and colleges of the Center to 15 focus on the most important environmental problems 16 of California related to sustainable economic devel-17 opment, with the aim of analysis and synthesis of 18 policy implications and dissemination of policy ori-19 ented research findings to managers in the public 20 and private sectors.

21 (4) To support the following activities:

(A) The coordination and funding of research activities of universities for collaborative
collection and evaluation of data on California's
geology, hydrology, soils, biology, weather and

1 climate, natural hazards, demography, infra-2 structure, resource use, land-use patterns, land-3 ownership patterns, business development, envi-4 ronmental equity, and regulatory zones. 5 (B) The analysis of public policy implica-6 tions of economic development programs that 7 affect the ecology of California. 8 (C) The conduct of seminars and other 9 educational programs for policy makers in the 10 Federal Government, State and local govern-11 ments, and the private sector on the implica-12 tions of the findings and conclusions derived 13 from the Center's activities. The Center shall 14 use electronic technology, such as computer net-15 works and video conferencing, to convey the cu-16 mulative findings and conclusions derived from 17 the Center's activities and to foster an exchange 18 of ideas.

19 (D) The conduct, not more than once each
20 year, of a national conference on ecology and
21 sustainable economic development for business
22 and labor leaders to foster an exchange of ideas
23 and information.

24 (E) The provision of ready access to the25 Center's collective expertise for policy makers in

1 the Federal Government and State and local governments, and for representatives of private-2 3 and public-sector organizations, through meet-4 ings, publications, special reports, video, electronic mail, computer networks, and other 5 6 means to share up-to-date information on re-7 search findings and policy development for sus-8 tainable economic development. 9 (F) The minimization of duplication and 10 waste in applied research and demonstration 11 programs within the areas of the Center's ex-12 pertise. 13 (G) The development of educational pro-14 grams, curricula, and instructional materials for 15 colleges, universities, and other educational in-16 stitutions to impart the knowledge and skills re-17 quired to implement environmentally sustain-18 able economic development, for the purpose of 19 equipping students for jobs in the public and 20 private sectors. 21 (H) The development of bachelors and 22 masters degree programs for individuals who 23 have lost or may lose employment as a result of 24 cutbacks in defense spending to prepare such 25 individuals for employment as environmental

professionals, and the development of certification programs in environmental sciences and studies for such individuals.

4 (I) The preparation of minority students for environmental professions, including the de-5 6 velopment of an enriched curriculum in the en-7 vironmental sciences at the baccalaureate and 8 post-graduate levels for underrepresented mi-9 nority students to prepare such students for ca-10 reers in various environmental areas, such as 11 environmental health and the clean-up of mili-12 tary installations and facilities.

(J) The development and administration of
a repository of information on key environmental and related economic development issues
that can be readily accessed by private- and
public-sector entities, including imposition, if
necessary, of a fee for users of the repository to
cover the cost of its operation.

(5) To work closely with other university research centers for which funds have been provided
by the Environmental Protection Agency to help establish a National Environmental Outreach Program
to assist the Federal Government, State and local
governments, and the private sector in programs and

projects designed to promote environmentally sound
 economic development.

3 (6) To work closely with Federally-funded re4 search centers, such as the Lawrence-Livermore Na5 tional Research Laboratory, to foster the transfer
6 and application of environmental technology to the
7 private sector.

8 (7) To help incubate or expand small, environ9 mentally related businesses where market barriers
10 exist to such incubation or expansion.

(8) To assist small businesses in meeting environmental regulations by providing short courses
and conferences and to develop methods and models
by which small businesses may finance "green" investment where private-sector funds are otherwise
not generally available.

17 (9) To work closely, as requested, with public-18 sector officials, private-sector businesses, and indi-19 viduals seeking alternative uses for military installa-20 tions and facilities that have been or are about to be 21 closed to assist in planning the environmental as-22 pects of the conversion and clean-up of the installa-23 tions and facilities, and to help with the economic 24 development aspects of the closing of the installa-25 tions and facilities.

(10) During its first year, to develop a plan, in
conjunction with other universities to extend the activities of the Center throughout the State within 3
years. The plan shall pay particular attention to the
need for environmentally sound conversion and economic use of military installations and facilities
throughout the State.

(b) Scholarships, Fellowships, and Grants.— 8 9 (1) SCHOLARSHIPS.—The Center may provide 10 for the award of undergraduate scholarships for in-11 dividuals studying in environmental fields at univer-12 sities that are members of the Center. Individuals 13 who have lost or may lose employment as a result 14 of the closing of a military installation or facility in 15 the State of California shall have preference over 16 other individuals in the award of scholarships under 17 this paragraph.

(2) FELLOWSHIPS.—The Center may provide
for the award of graduate assistantships and fellowships at the Center to encourage study in fields related to sustainable economic development. Preference shall be given to those who have been or are
about to be laid off as a result of military base closings in California.

(3) RESEARCH GRANTS.—The Center may
 award research grants to faculty at universities and
 colleges, both public and private, to encourage re search critical to the achievement of the functions
 described in subsection (a).

6 SEC. 4. REPORT.

7 The Center shall annually submit to the Adminis-8 trator a report on the activities of the Center and on any 9 changing budget needs. The Center shall include in the 10 first report submitted under this subsection a statement 11 of any additional funds that may be required to extend 12 the activities of the Center throughout the State.

13 SEC. 5. GIFTS AND DONATIONS.

14 The Center may receive funds and other property do-15 nated, bequeathed, or devised to the Center with or without a condition of restriction, for the purpose of furthering 16 the activities of the Center. All funds donated, bequeathed, 17 or devised to the Center shall be retained in a separate 18 19 account. Each annual report submitted pursuant to sec-20 tion 4 shall include an accounting of the funds and prop-21 erty donated, bequeathed, or devised to the Center during 22 the year covered by the annual report.

23 SEC. 6. DEFINITIONS.

24 For purposes of this Act:

(1) The term "Administrator" means the Ad ministrator of the Environmental Protection Agency.
 (2) The term "Center" means the California
 Urban Environmental Research and Education Cen ter established pursuant to section 2.

6 SEC. 7. AUTHORIZATION OF APPROPRIATIONS.

7 (a) IN GENERAL.—There are authorized to be appro8 priated to the Administrator for provision to the Center
9 to carry out this Act \$4,500,000 for fiscal year 1998 and
10 such sums as may be necessary for each of fiscal years
11 1999 through 2002.

(b) AVAILABILITY.—Funds appropriated pursuant to
the authority of subsection (a) shall remain available until
expended.

(c) MATCHING FUNDS.—In addition to amounts provided as described in section 2(b)(2), the Center shall
make a good faith effort to match the amount of funds
appropriated pursuant to this section with funding from
State and local governments and the private sector.
