## A BILL

To establish computer learning centers in low-income areas.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This act may be cited as the “Computer Learning  
5 Center Act of 1997”.

1 **SEC. 2. ESTABLISHMENT AND OPERATION OF FUND.**

2 (a) ESTABLISHMENT.—A fund shall be established in  
3 the Department of Commerce to provide grants to quali-  
4 fied nonprofit organizations for the establishment of com-  
5 puter learning centers in low income areas.

6 (b) USE OF FUND.—The fund established under sub-  
7 section (a) shall be used to assist nonprofit organizations  
8 in renovating vacant storefronts in low income areas.

9 **SEC. 3. APPLICATION.**

10 (a) FORM AND PROCEDURES.—An application for as-  
11 sistance shall be submitted in such form and in accordance  
12 with such procedures as established by the Secretary of  
13 Commerce.

14 (b) MINIMUM REQUIREMENTS.—To receive a grant  
15 from the fund established under section 2, a nonprofit or-  
16 ganization must certify that it has a secure commitment  
17 from a private business partner to donate 50 up-to-date  
18 computers for a proposed learning center.

19 (c) GEOGRAPHIC DIVERSITY.—To the extent prac-  
20 ticable, the Secretary shall make grants to organizations  
21 in a manner which will equitably distribute such grants  
22 among the various regions of the United States.

23 **SEC. 4. COMPUTER LEARNING CENTERS.**

24 The computer learning centers shall provide assist-  
25 ance to residents of low-income areas by educating resi-

1 dents as to how to use computer equipment including word  
2 processing and information gathering programs.

3 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

4       There are authorized to be appropriated to the fund  
5 established in section 2, to remain available until ex-  
6 pended, \$20,000,000 for the fiscal years 1997 and 1998.
