## AN ACT

To authorize the President to award a gold medal on behalf of the Congress to Mother Teresa of Calcutta in recognition of her outstanding and enduring contributions through humanitarian and charitable activities, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4        The Congress finds that—

5            (1) Mother Teresa of Calcutta has greatly im-  
6            pacted the lives of people in all walks of life in every  
7            corner of the world through love and her selfless  
8            dedication to humanity and charitable works for  
9            nearly 70 years;

10           (2) Mother Teresa has expanded her personal  
11           dedication by founding the Missionaries of Charity,  
12           which include well over 3,000 members in 25 coun-  
13           tries, who devote their entire lives to serving the  
14           poor without accepting any material reward in re-  
15           turn;

16           (3) Mother Teresa has been recognized as a hu-  
17           manitarian around the world and has been recog-  
18           nized in the form of—

19                    (A) the first Pope John XXIII Peace Prize  
20                    (1971);

21                    (B) the Jawaharal Nehru Award for Inter-  
22                    national Understanding (1972);

23                    (C) the Nobel Peace Prize (1979); and

24                    (D) the Presidential Medal of Freedom  
25                    (1985);

1 (4) Mother Teresa is a tool of God;

2 (5) God’s love flowing through Mother Teresa  
3 has forever impacted the culture and history of the  
4 world; and

5 (6) Mother Teresa truly leads by example and  
6 shows the people of the world the way to live by love  
7 for mankind.

8 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

9 (a) PRESENTATION AUTHORIZED.—The President is  
10 authorized to present, on behalf of the Congress, a gold  
11 medal of appropriate design to Mother Teresa of Calcutta  
12 in recognition of her outstanding and enduring contribu-  
13 tions to humanitarian and charitable activities.

14 (b) DESIGN AND STRIKING.—For the purpose of the  
15 presentation referred to in subsection (a), the Secretary  
16 of the Treasury (hereafter in this Act referred to as the  
17 “Secretary”) shall strike a gold medal with suitable em-  
18 blems, devices, and inscriptions, to be determined by the  
19 Secretary.

20 **SEC. 3. DUPLICATE MEDALS.**

21 The Secretary may strike and sell duplicates in  
22 bronze of the gold medal struck pursuant to section 2  
23 under such regulations as the Secretary may prescribe,  
24 and at a price sufficient to cover the costs thereof, includ-

1 ing labor, materials, dies, use of machinery, overhead ex-  
2 penses, and the cost of the gold medal.

3 **SEC. 4. NATIONAL MEDALS.**

4 The medals struck pursuant to this Act are national  
5 medals for purposes of chapter 51 of title 31, United  
6 States Code.

7 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS; PROCEEDS**  
8 **OF SALE.**

9 (a) AUTHORIZATION OF APPROPRIATIONS.—There is  
10 hereby authorized to be charged against the Numismatic  
11 Public Enterprise Fund an amount not to exceed \$30,000  
12 to pay for the cost of the medal authorized by this Act.

13 (b) PROCEEDS OF SALE.—Amounts received from the  
14 sales of duplicate bronze medals under section 3 shall be  
15 deposited in the Numismatic Public Enterprise Fund.
