A BILL

To amend title 23, United States Code, relating to the bridge discretionary program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safe Bridges Recon-
5 struction and Restoration Act of 1997”.

6 **SEC. 2. BRIDGE PROGRAM.**

7 Section 144(g)(1) of title 23, United States Code, is
8 amended—

1 (1) by striking “Of the amounts authorized for
2 each of fiscal years 1992, 1993, 1994, 1995, 1996,
3 and 1997 by section 103 of the Intermodal Surface
4 Transportation Efficiency Act of 1991, all but
5 \$57,000,000 in the case of fiscal year 1992,
6 \$68,000,000 in the case of fiscal years 1993 and
7 1994, and \$69,000,000 in the case of fiscal years
8 1995, 1996, and 1997 shall be apportioned as pro-
9 vided in subsection (e) of this section. \$49,000,000
10 in the case of fiscal year 1992, \$59,500,000 in the
11 case of fiscal years 1993 and 1994, and
12 \$60,500,000 in the case of fiscal years 1995, 1996,
13 and 1997 of the amount authorized for each of such
14 fiscal years shall be available for obligation” and in-
15 sserting “Before any apportionment is made under
16 subsection (e), the Secretary shall set aside
17 \$800,000,000 per fiscal year for obligation”;

18 (2) by inserting “. Such \$800,000,000 shall be
19 available for obligation at the discretion of the Sec-
20 retary” after “each such apportionment”; and

21 (3) by striking “the obligation of \$49,900,000
22 in the case of fiscal year 1992, \$59,500,000 in the
23 case of fiscal years 1993 and 1994, and
24 \$60,500,000 in the case of fiscal years 1995, 1996,

1 and 1997 shall be at the discretion of the Secretary,
2 and”.
