1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Missing and Exploited3 Children Act of 1997".

4 SEC. 2. AUTHORIZATION OF APPROPRIATIONS.

5 There is authorized to be appropriated to The Na-6 tional Center for Missing and Exploited Children, a non-7 profit corporation organized under the laws of the District 8 of Columbia, \$5,000,000 for each of the fiscal years 1998, 9 1999, 2000, 2001, and 2002 to operate a national re-10 source center and clearinghouse designed—

(1) to provide to State and local governments,
public and private nonprofit agencies, and individuals information regarding—

- (B) the existence and nature of programs
 being carried out by Federal agencies to assist
 missing children and their families,

which locate, recover, or reunite missing children
with their legal custodians,
