AN ACT

To provide for the development of a plan and a management review of the National Park System and to reform the process by which areas are considered for addition to the National Park System, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "National Park System
- 3 New Area Studies Act".
- 4 SEC. 2. STUDY OF NEW PARK SYSTEM AREAS.
- 5 Section 8 of Public Law 91–383 (16 U.S.C. 1a–5;
- 6 popularly known as the National Park System General
- 7 Authorities Act) is amended as follows:
- 8 (1) By inserting "GENERAL AUTHORITY.—"
- 9 after "(a)".
- 10 (2) By striking the second through the seventh
- sentences of subsection (a).
- 12 (3) By designating the last two sentences of
- subsection (a) as subsection (e) and inserting in the
- 14 first of such sentences before the words "For the
- purposes of carrying" the following: "(e) Author-
- 16 IZATION OF APPROPRIATIONS.—".
- 17 (4) By inserting the following after subsection
- 18 (a):
- 19 "(b) Studies of Areas for Potential Addi-
- 20 TION.—(1) At the beginning of each calendar year, along
- 21 with the annual budget submission, the Secretary of the
- 22 Interior shall submit to the Committee on Resources of
- 23 the House of Representatives and to the Committee on
- 24 Energy and Natural Resources of the United States Sen-
- 25 ate a list of areas recommended for study for potential
- 26 inclusion in the National Park System.

- 1 "(2) In developing the list to be submitted under this
- 2 subsection, the Secretary shall give consideration to those
- 3 areas that have the greatest potential to meet the estab-
- 4 lished criteria of national significance, suitability, and fea-
- 5 sibility. The Secretary shall give special consideration to
- 6 themes, sites, and resources not already adequately rep-
- 7 resented in the National Park System.
- 8 "(3) No study of the potential of an area for inclusion
- 9 in the National Park System may be initiated after the
- 10 date of enactment of this subsection, except as provided
- 11 by specific authorization of an Act of Congress.
- 12 "(4) Nothing in this Act shall limit the authority of
- 13 the National Park Service to conduct preliminary resource
- 14 assessments, gather data on potential study areas, provide
- 15 technical and planning assistance, prepare or process
- 16 nominations for administrative designations, update pre-
- 17 vious studies, or complete reconnaissance surveys of indi-
- 18 vidual areas requiring a total expenditure of less than
- 19 \$25,000.
- 20 "(5) Nothing in this section shall be construed to
- 21 apply to or to affect or alter the study of any river segment
- 22 for potential addition to the national wild and scenic rivers
- 23 system or to apply to or to affect or alter the study of
- 24 any trail for potential addition to the national trails sys-
- 25 tem.

1	"(c) Report.—(1) The Secretary of the Interior
2	shall complete the study for each area for potential inclu-
3	sion in the National Park System within 3 complete fiscal
4	years following the date of enactment of specific legislation
5	providing for the study of such area. Each study under
6	this section shall be prepared with appropriate opportunity
7	for public involvement, including at least one public meet-
8	ing in the vicinity of the area under study, and after rea-
9	sonable efforts to notify potentially affected landowners
10	and State and local governments.
11	"(2) In conducting the study, the Secretary shall con-
12	sider whether the area under study—
13	"(A) possesses nationally significant natural or
14	cultural resources and represents one of the most
15	important examples of a particular resource type in
16	the country; and
17	"(B) is a suitable and feasible addition to the
18	system.
19	"(3) Each study—
20	"(A) shall consider the following factors with
21	regard to the area being studied—
22	"(i) the rarity and integrity of the re-
23	sources;
24	"(ii) the threats to those resources;

1	"(iii) similar resources are already pro-
2	tected in the National Park System or in other
3	public or private ownership;
4	"(iv) the public use potential;
5	"(v) the interpretive and educational po-
6	tential;
7	"(vi) costs associated with acquisition, de-
8	velopment and operation;
9	"(vii) the socioeconomic impacts of any
10	designation;
11	"(viii) the level of local and general public
12	support; and
13	"(ix) whether the area is of appropriate
14	configuration to ensure long-term resource pro-
15	tection and visitor use;
16	"(B) shall consider whether direct National
17	Park Service management or alternative protection
18	by other public agencies or the private sector is ap-
19	propriate for the area;
20	"(C) shall identify what alternative or combina-
21	tion of alternatives would in the professional judg-
22	ment of the Director of the National Park Service
23	be most effective and efficient in protecting signifi-
24	cant resources and providing for public enjoyment;
25	and

- 1 "(D) may include any other information which
- 2 the Secretary deems to be relevant.
- 3 "(4) Each study shall be completed in compliance
- 4 with the National Environmental Policy Act of 1969.
- 5 "(5) The letter transmitting each completed study to
- 6 Congress shall contain a recommendation regarding the
- 7 Secretary's preferred management option for the area.
- 8 "(d) List of Areas.—At the beginning of each cal-
- 9 endar year, along with the annual budget submission, the
- 10 Secretary of the Interior shall submit to the Committee
- 11 on Resources of the House of Representatives and to the
- 12 Committee on Energy and Natural Resources of the
- 13 United States Senate a list of areas which have been pre-
- 14 viously studied which contain primarily historical re-
- 15 sources, and a list of areas which have been previously
- 16 studied which contain primarily natural resources, in nu-
- 17 merical order of priority for addition to the National Park
- 18 System. In developing the lists, the Secretary should con-
- 19 sider threats to resource values, cost escalation factors,
- 20 and other factors listed in subsection (c) of this section.
- 21 The Secretary should only include on the lists areas for
- 22 which the supporting data is current and accurate.".
- 23 (5) By adding at the end of subsection (e) (as
- designated by paragraph (3) of this section) the fol-
- lowing: "For carrying out subsections (b) through

- 1 (d) there are authorized to be appropriated
- 2 \$2,000,000.".
