AN ACT

To authorize the President to award a gold medal on behalf of the Congress to Ecumenical Patriarch Bartholomew in recognition of his outstanding and enduring contributions toward religious understanding and peace, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 The Congress finds that—

5 (1) Ecumenical Patriarch Bartholomew—

6 (A) is the spiritual leader of nearly 300
7 million Orthodox Christians around the world
8 and millions of Orthodox Christians in America;
9 and

10 (B) is recognized in the United States and
11 abroad as a leader in the quest for world peace,
12 respect for the earth's environment, and greater
13 religious understanding;

14 (2) the extraordinary efforts of Ecumenical Pa-
15 triarch Bartholomew continue to bring people of all
16 faiths closer together in America and around the
17 world;

18 (3) the courageous leadership of Ecumenical
19 Patriarch Bartholomew for peace in the Balkans,
20 Eastern Europe, the Middle East, the Eastern Medi-
21 terranean, and elsewhere inspires and encourages
22 people of all faiths toward his dream of world peace
23 in the new millennium; and

24 (4) the outstanding accomplishments of Ecu-
25 menical Patriarch Bartholomew have been formally

1 recognized and honored by numerous governmental,
2 academic, and other institutions around the world.

3 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

4 (a) PRESENTATION AUTHORIZED.—The President is
5 authorized to present, on behalf of the Congress, a gold
6 medal of appropriate design to Ecumenical Patriarch Bar-
7 tholomew in recognition of his outstanding and enduring
8 contributions to religious understanding and peace.

9 (b) DESIGN AND STRIKING.—For the purpose of the
10 presentation referred to in subsection (a), the Secretary
11 of the Treasury (hereafter in this Act referred to as the
12 “Secretary”) shall strike a gold medal with suitable em-
13 blems, devices, and inscriptions, to be determined by the
14 Secretary.

15 **SEC. 3. DUPLICATE MEDALS.**

16 The Secretary may strike and sell duplicates in
17 bronze of the gold medal struck pursuant to section 2
18 under such regulations as the Secretary may prescribe,
19 and at a price sufficient to cover the costs thereof, includ-
20 ing labor, materials, dies, use of machinery, overhead ex-
21 penses, and the cost of the gold medal.

22 **SEC. 4. NATIONAL MEDALS.**

23 The medals struck pursuant to this Act are national
24 medals for purposes of chapter 51 of title 31, United
25 States Code.

1 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS; PROCEEDS**
2 **OF SALE.**

3 (a) AUTHORIZATION OF APPROPRIATIONS.—There is
4 hereby authorized to be charged against the Numismatic
5 Public Enterprise Fund an amount not to exceed \$30,000
6 to pay for the cost of the medal authorized by this Act.

7 (b) PROCEEDS OF SALE.—Amounts received from the
8 sales of duplicate bronze medals under section 3 shall be
9 deposited in the Numismatic Public Enterprise Fund.
