Mr. Riggs introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To authorize conveyance of 2 decommissioned Coast Guard vessels to Canvasback Mission, Inc., for use for provision of medical services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CONVEYANCE OF DECOMMISSIONED COAST
- 4 GUARD VESSELS.
- 5 (a) In General.—The Commandant of the Coast
- 6 Guard shall convey all right, title, and interest of the
- 7 United States in and to each of 2 decommissioned "White
- 8 Class" 133-foot Coast Guard vessels to Canvasback Mis-
- 9 sion, Inc. (a nonprofit corporation established under the

1	laws of the State of Oregon; in this section referred to
2	as "the recipient"), without consideration, if—
3	(1) the recipient agrees, with respect to each
4	vessel conveyed—
5	(A) to use the vessel for the purposes of
6	providing medical services to Central and South
7	Pacific island nations;
8	(B) not to use the vessel for commercial
9	transportation purposes except those incident to
10	the provision of those medical services;
11	(C) to make the vessel available to the
12	United States Government if needed for use by
13	the Commandant in times of war or a national
14	emergency; and
15	(D) to hold the Government harmless for
16	any claims arising from exposure to hazardous
17	materials, including asbestos and poly-
18	chlorinated biphenyls (PCBs), after conveyance
19	of the vessel, except for claims arising from the
20	use by the Government under paragraph $(1)(C)$;
21	(2) the recipient has funds available that will be
22	committed to operate and to maintain each vessel
23	conveyed in good working condition, in the form of
24	cash, liquid assets, or a written loan commitment,

- and in the amount of at least \$400,000 per vessel;
- 2 and
- 3 (3) the recipient agrees to any other conditions
- 4 the Commandant considers appropriate.
- 5 (b) Maintenance and Delivery of Vessel.—
- 6 Prior to conveyance of a vessel under this section, the
- 7 Commandant shall, to the extent practical, and subject to
- 8 other Coast Guard mission requirements, make every ef-
- 9 fort to maintain the integrity of the vessel and its equip-
- 10 ment until the time of delivery of the vessel. If a convey-
- 11 ance is made under this section, the Commandant shall
- 12 deliver the vessel at the place where the vessel is located,
- 13 in its present condition, and without cost to the Govern-
- 14 ment. The conveyance of the vessel under this section shall
- 15 not be considered a distribution in commerce for purposes
- 16 of section 6(e) of Public Law 94–469 (15 U.S.C. 2605(e)).
- 17 (c) Other Excess Equipment.—The Commandant
- 18 may convey to the recipient of a vessel under this section
- 19 any excess equipment or parts from other decommissioned
- 20 Coast Guard vessels for use to enhance the vessel's oper-
- 21 ability and function as a medical services vessel in Central
- 22 and South Pacific islands.
