3 SECTION 1. SCHOOL RESOURCE OFFICERS.

4 Part Q of title I of the Omnibus Crime Control and
5 Safe Streets Act of 1968 (42 U.S.C. 3796dd et seq.) is

6 amended—

7 (1) in section 1701(d)—

1	(A) by redesignating paragraphs (8)
2	through (10) as (9) through (11) , respectively;
3	and
4	(B) by inserting after paragraph (7) the
5	following:
6	"(8) establish school-based partnerships be-
7	tween local law enforcement agencies and local
8	school systems by using school resource officers who
9	operate in and around elementary and secondary
10	schools to combat school-related crime and disorder
11	problems, gangs, and drug activities;"; and
12	(2) in section 1709, by adding at the end the
13	following:
14	" 'school resource officer' means a career law
15	enforcement officer, with sworn authority, deployed
16	in community-oriented policing, and assigned by the
17	employing police department or agency to work in
18	collaboration with schools and community-based or-
19	ganizations—
20	((1) to address crime and disorder prob-
21	lems, gangs, and drug activities affecting or oc-
22	curring in or around an elementary or second-
23	ary school;
24	((2) to develop or expand crime prevention
25	efforts for students;

1	((3) to educate likely school-age victims in
2	crime prevention and safety;
3	"(4) to develop or expand community jus-
4	tice initiatives for students;
5	"(5) to train students in conflict resolu-
6	tion, restorative justice, and crime awareness;
7	"(6) to assist in the identification of phys-
8	ical changes in the environment that may re-
9	duce crime in or around the school; and
10	"(7) to assist in developing school policy
11	that addresses crime and to recommend proce-
12	dural changes.".
