A BILL

To amend title 38, United States Code, to establish certain presumptions of service connection for veterans who served in the Persian Gulf War, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Persian Gulf War Vet-
- 5 erans Health Act of 1998".

| 11 | "(a)(1) For purposes of section 1110 of this title, and |

| 13 | in paragraph (2) or identified pursuant to subsection (b) |
| 14 | shall be considered to have been incurred in or aggravated |
| 15 | by service referred to in that paragraph, notwithstanding |
| 16 | that there is no record of evidence of such illness during |
| 17 | the period of such service. |
| 18 | "(2) An illness referred to in paragraph (1) is any |
| 19 | diagnosed or undiagnosed illness that— |
| 20 | "(A) the Secretary determines in regulations |
| 21 | prescribed under this section to warrant a presump- |
| 22 | tion of service connection by reason of having a posi- |
| 23 | tive association with exposure to a biological, chemi- |
| 24 | cal, or other toxic agent or environmental or war- |
| 25 | time hazard known or presumed to be associated |
| 26 | with service in the Armed Forces in the Southwest |

- 1 Asia theater of operations during the period begin-
- 2 ning on August 2, 1990, and ending on December
- 3 31, 1991; and
- 4 "(B) becomes manifest in a Persian Gulf War
- 5 veteran who by reason of service in Southwest Asia
- 6 during the period beginning on August 2, 1990, and
- 7 ending on December 31, 1991, was exposed to such
- 8 agent or hazard.
- 9 "(3) For purposes of this subsection, a Persian Gulf
- 10 War veteran who has an illness described in paragraph
- 11 (2) shall be presumed to have been exposed by reason of
- 12 such service to the agent or hazard associated with the
- 13 illness in the regulations prescribed under this subsection
- 14 unless there is conclusive evidence to establish that the
- 15 veteran was not exposed to the agent or hazard by reason
- 16 of such service.
- 17 "(b)(1) The Secretary shall enter into a contract with
- 18 an appropriate independent scientific body to establish a
- 19 panel for the purpose of reviewing the medical and sci-
- 20 entific literature to identify those diseases and illnesses
- 21 epidemiologically, medically, or scientifically associated
- 22 with exposure of humans or animals to any of the mate-
- 23 rials specified in subsection (c). The panel shall be com-
- 24 posed of non-Government scientific experts representing,
- 25 at minimum, the disciplines of toxicology, immunology,

- 1 microbiology, molecular biology, genetics, biochemistry,
- 2 chemistry, epidemiology, medicine, and public health.
- 3 "(2) The Secretary shall require that the panel sub-
- 4 mit to the Secretary, not later than one year after the
- 5 date of the enactment of this section, a report, based upon
- 6 the review under paragraph (1), identifying such diseases
- 7 and illnesses.
- 8 "(3) Upon submission to the Secretary of the report
- 9 under paragraph (2), each disease or illness identified in
- 10 the report that becomes manifest in a Persian Gulf War
- 11 veteran shall be presumed to be service-connected.
- 12 "(4) There is authorized to be appropriated to the
- 13 Secretary \$1,000,000 to carry out this subsection.
- 14 "(5) The specification of presumed exposures in sub-
- 15 section (c) shall be updated as information develops con-
- 16 firming the exposure of Persian Gulf War veterans or
- 17 members of their families to additional chemical, biologi-
- 18 cal, radiological, or other genotoxic or infectious materials.
- 19 The Secretary shall periodically enter into a contract as
- 20 described in paragraph (1) for the purposes of identifying
- 21 and confirming such exposures. Upon submission to the
- 22 Secretary of a report pursuant to such a contract, the Sec-
- 23 retary shall add each disease or illness identified in the
- 24 report that becomes manifest in a Persian Gulf War vet-

SEC. 4. PLAN FOR PERMANENT EXPERT ADVISORY GROUP 2 ON CHEMICAL, BIOLOGICAL, AND RADIO-3 LOGICAL DEFENSE. 4 Not later than 180 days after the date of the enact-5 ment of this Act, the President shall submit to Congress a plan for the establishment of a permanent expert advi-6 7 sory group to be composed of individuals capable of providing expert advice both to the President and the congres-9 sional defense and intelligence committees on the adequacy of current United States chemical, biological, and 10 radiological defense technologies, procurement practices, 11 and doctrine to defend the Armed Forces against both the immediate and chronic consequences of acute and sub-13 acute exposures to chemical, biological, radiological, or other genotoxic battlefield materials.
