A BILL

Making appropriations for energy and water development for the fiscal year ending September 30, 1999, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 fiscal year ending September 30, 1999, for energy and

- 6 For expenses necessary for prosecuting work of flood

- 9 flood, as authorized by law (33 U.S.C. 702a, 702g-1),
- 10 \$312,077,000, to remain available until expended.
- 11 OPERATION AND MAINTENANCE, GENERAL
- For expenses necessary for the preservation, oper-
- 13 ation, maintenance, and care of existing river and harbor,
- 14 flood control, and related works, including such sums as
- 15 may be necessary for the maintenance of harbor channels
- 16 provided by a State, municipality or other public agency,
- 17 outside of harbor lines, and serving essential needs of gen-
- 18 eral commerce and navigation; surveys and charting of
- 19 northern and northwestern lakes and connecting waters;
- 20 clearing and straightening channels; and removal of ob-
- 21 structions to navigation, \$1,637,719,000, to remain avail-
- 22 able until expended, of which such sums as become avail-
- 23 able in the Harbor Maintenance Trust Fund, pursuant to
- 24 Public Law 99–662, may be derived from that Fund, and
- 25 of which such sums as become available from the special

- 1 account established by the Land and Water Conservation
- 2 Act of 1965, as amended (16 U.S.C. 460l), may be derived
- 3 from that Fund for construction, operation, and mainte-
- 4 nance of outdoor recreation facilities, and of which
- 5 \$4,200,000 is provided for repair of Chickamauga Lock,
- 6 Tennessee, subject to authorization.
- 7 Regulatory Program
- 8 For expenses necessary for administration of laws
- 9 pertaining to regulation of navigable waters and wetlands,
- 10 \$110,000,000, to remain available until expended.
- 11 FORMERLY UTILIZED SITES REMEDIAL ACTION
- 12 Program
- 13 For expenses necessary to clean up contaminated
- 14 sites throughout the United States where work was per-
- 15 formed as part of the Nation's early atomic energy pro-
- 16 gram, \$140,000,000, to remain available until expended.
- 17 GENERAL EXPENSES
- 18 For expenses necessary for general administration
- 19 and related functions in the Office of the Chief of Engi-
- 20 neers and offices of the Division Engineers; activities of
- 21 the Coastal Engineering Research Board, the Humphreys
- 22 Engineer Center Support Activity, the Water Resources
- 23 Support Center, and headquarters support functions at
- 24 the USACE Finance Center; \$148,000,000, to remain
- 25 available until expended: *Provided*, That no part of any

- 11 For carrying out the functions of the Bureau of Rec-
- 12 lamation as provided in the Federal reclamation laws (Act
- 13 of June 17, 1902, 32 Stat. 388, and Acts amendatory
- 14 thereof or supplementary thereto) and other Acts applica-
- 15 ble to that Bureau as follows:
- WATER AND RELATED RESOURCES
- 17 (INCLUDING TRANSFER OF FUNDS)
- 18 For management, development, and restoration of
- 19 water and related natural resources and for related activi-
- 20 ties, including the operation, maintenance and rehabilita-
- 21 tion of reclamation and other facilities, participation in
- 22 fulfilling related Federal responsibilities to Native Ameri-
- 23 cans, and related grants to, and cooperative and other
- 24 agreements with, State and local governments, Indian
- 25 Tribes, and others, \$622,054,000, to remain available
- 26 until expended, of which \$1,873,000 shall be available for

- 1 transfer to the Upper Colorado River Basin Fund and
- 2 \$49,908,000 shall be available for transfer to the Lower
- 3 Colorado River Basin Development Fund, and of which
- 4 such amounts as may be necessary may be advanced to
- 5 the Colorado River Dam Fund: Provided, That such trans-
- 6 fers may be increased or decreased within the overall ap-
- 7 propriation under this heading: Provided further, That of
- 8 the total appropriated, the amount for program activities

- 19 shall be derived by transfer of unexpended balances from

- 22 For the cost of direct loans and/or grants,
- 23 \$12,000,000, to remain available until expended, as au-

- 26 That such costs, including the cost of modifying such

- 1 loans, shall be as defined in section 502 of the Congres-

- 4 principal amount of direct loans not to exceed
- 5 \$38,000,000.
- 6 In addition, for administrative expenses necessary to
- 7 carry out the program for direct loans and/or grants,

- 9 That of the total sums appropriated, the amount of pro-
- 10 gram activities that can be financed by the Reclamation
- 11 Fund shall be derived from that Fund.
- 12 CENTRAL VALLEY PROJECT RESTORATION FUND
- For carrying out the programs, projects, plans, and
- 14 habitat restoration, improvement, and acquisition provi-
- 15 sions of the Central Valley Project Improvement Act,
- 16 \$33,130,000, to be derived from such sums as may be col-
- 17 lected in the Central Valley Project Restoration Fund pur-
- 18 suant to sections 3407(d), 3404(c)(3), 3405(f), and

- 20 until expended: Provided, That the Bureau of Reclamation
- 21 is directed to assess and collect the full amount of the

17	mental impact statement only if: (1) consistent with 40
