## A BILL

To require the establishment of a Consumer Price Index for Elderly Consumers to compute cost-of-living increases for Social Security and Medicare benefits under titles II and XVIII of the Social Security Act provided after 1999.

#### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Consumer Price Index
- 3 for Elderly Consumers Act of 1998".
- 4 SEC. 2. CONSUMER PRICE INDEX FOR ELDERLY CONSUM-
- 5 ERS.
- 6 (a) IN GENERAL.—The Bureau of Labor Statistics
- 7 of the Department of Labor shall, for each month after
- 8 June 1998, prepare and publish an index to be known as
- 9 the "Consumer Price Index for Elderly Consumers" that
- 10 indicates changes over time in expenditures for consump-
- 11 tion which are typical for individuals in the United States
- 12 who are 62 years of age or older.
- 13 (b) Initial Publication of Index.—The Bureau
- 14 of Labor Statistics shall prepare and publish the index re-
- 15 ferred to in subsection (a), for each month described in
- 16 such subsection that occurs before October 1999, not later
- 17 than 30 days after the close of the calendar quarter ending
- 18 on September 30, 1999.
