

***In the Senate of the United States,***

*July 30, 1998.*

*Resolved*, That the bill from the House of Representatives (H.R. 4103) entitled “An Act making appropriations for the Department of Defense for the fiscal year ending September 30, 1999, and for other purposes.”, do pass with the following

**AMENDMENT:**

Strike out all after the enacting clause and insert:

#### 8 *OPERATION AND MAINTENANCE, ARMY*

##### 9 *(INCLUDING TRANSFER OF FUNDS)*

10 *For expenses, not otherwise provided for, necessary for*  
 11 *the operation and maintenance of the Army, as authorized*  
 12 *by law; and not to exceed \$11,437,000 can be used for emer-*  
 13 *gencies and extraordinary expenses, to be expended on the*  
 14 *approval or authority of the Secretary of the Army, and*  
 15 *payments may be made on his certificate of necessity for*  
 16 *confidential military purposes; \$17,212,463,000 and, in ad-*  
 17 *dition, \$50,000,000 shall be derived by transfer from the*  
 18 *National Defense Stockpile Transaction Fund: Provided,*  
 19 *That of the funds appropriated under this heading,*  
 20 *\$130,000,000 shall be transferred to the Quality of Life En-*  
 21 *hancements, Defense account in this Act and shall be avail-*  
 22 *able only for expenses, not otherwise provided for, resulting*  
 23 *from unfunded shortfalls in the repair and maintenance of*  
 24 *real property of the Department of the Army (including*  
 25 *minor construction and major maintenance and repair of*

1 *military housing and barracks): Provided further, That of*  
 2 *the funds appropriated in this paragraph, not less than*  
 3 *\$375,000,000 shall be made available only for conventional*  
 4 *ammunition care and maintenance.*

6 *(INCLUDING TRANSFER OF FUNDS)*

7 *For expenses, not otherwise provided for, necessary for*  
 8 *the operation and maintenance of the Navy and the Marine*  
 9 *Corps, as authorized by law; and not to exceed \$5,360,000*  
 10 *can be used for emergencies and extraordinary expenses, to*  
 11 *be expended on the approval or authority of the Secretary*  
 12 *of the Navy, and payments may be made on his certificate*  
 13 *of necessity for confidential military purposes;*  
 14 *\$21,813,315,000 and, in addition, \$50,000,000 shall be de-*  
 15 *rived by transfer from the National Defense Stockpile*  
 16 *Transaction Fund: Provided, That of the funds appro-*  
 17 *priated under this heading, \$48,000,000 shall be transferred*  
 18 *to the Quality of Life Enhancements, Defense account in*  
 19 *this Act and shall be available only for expenses, not other-*  
 20 *wise provided for, resulting from unfunded shortfalls in the*  
 21 *repair and maintenance of real property of the Department*  
 22 *of the Navy (including minor construction and major*  
 23 *maintenance and repair of military housing and barracks).*

2           *For expenses, not otherwise provided for, necessary for*  
3 *the operation and maintenance of the Marine Corps, as au-*  
4 *thorized by law; \$2,576,190,000: Provided, That of the*  
5 *funds appropriated under this heading, \$36,000,000 shall*  
6 *be transferred to the Quality of Life Enhancements, Defense*  
7 *account in this Act and shall be available only for expenses,*  
8 *not otherwise provided for, resulting from unfunded short-*  
9 *falls in the repair and maintenance of real property of the*  
10 *Marine Corps (including minor construction and major*  
11 *maintenance and repair of military housing and barracks).*

12           *OPERATION AND MAINTENANCE, AIR FORCE*

13           *(INCLUDING TRANSFER OF FUNDS)*

14           *For expenses, not otherwise provided for, necessary for*  
15 *the operation and maintenance of the Air Force, as author-*  
16 *ized by law; and not to exceed \$7,968,000 can be used for*  
17 *emergencies and extraordinary expenses, to be expended on*  
18 *the approval or authority of the Secretary of the Air Force,*  
19 *and payments may be made on his certificate of necessity*  
20 *for confidential military purposes; \$19,064,941,000 and, in*  
21 *addition, \$50,000,000 shall be derived by transfer from the*  
22 *National Defense Stockpile Transaction Fund: Provided,*  
23 *That of the funds appropriated under this heading,*  
24 *\$50,000,000 shall be transferred to the Quality of Life En-*  
25 *hancements, Defense account in this Act and shall be avail-*

1 *able only for expenses, not otherwise provided for, resulting*  
 2 *from unfunded shortfalls in the repair and maintenance of*  
 3 *real property of the Air Force (including minor construc-*  
 4 *tion and major maintenance and repair of military hous-*  
 5 *ing and barracks): Provided further, That out of the funds*  
 6 *available under this heading, \$300,000 may be available*  
 7 *for the abatement of hazardous substances in housing at the*  
 8 *Finley Air Force Station, Finley, North Dakota.*

9 *OPERATION AND MAINTENANCE, DEFENSE-WIDE*

10 *For expenses, not otherwise provided for, necessary for*  
 11 *the operation and maintenance of activities and agencies*  
 12 *of the Department of Defense (other than the military de-*  
 13 *partments), as authorized by law; \$10,259,231,000, of*  
 14 *which not to exceed \$25,000,000 may be available for the*  
 15 *CINC initiative fund account; and of which not to exceed*  
 16 *\$29,000,000 can be used for emergencies and extraordinary*  
 17 *expenses, to be expended on the approval or authority of*  
 18 *the Secretary of Defense, and payments may be made on*  
 19 *his certificate of necessity for confidential military pur-*  
 20 *poses: Provided, That of the funds appropriated under this*  
 21 *heading, \$10,000,000 shall be made available only for use*  
 22 *in federally owned educational facilities located on military*  
 23 *installations for the purpose of transferring title of such fa-*  
 24 *cilities to the local educational facilities.*

2        *For expenses, not otherwise provided for, necessary for*  
3 *the operation and maintenance, including training, organi-*  
4 *zation, and administration, of the Army Reserve; repair of*

6 *travel and transportation; care of the dead; recruiting; pro-*  
7 *curement of services, supplies, and equipment; and commu-*  
8 *nications; \$1,202,622,000.*

9        *OPERATION AND MAINTENANCE, NAVY RESERVE*

10       *For expenses, not otherwise provided for, necessary for*  
11 *the operation and maintenance, including training, organi-*  
12 *zation, and administration, of the Navy Reserve; repair of*  
13 *facilities and equipment; hire of passenger motor vehicles;*  
14 *travel and transportation; care of the dead; recruiting; pro-*  
15 *curement of services, supplies, and equipment; and commu-*  
16 *nications; \$928,639,000.*

16 *plies, materials, and equipment, including such as may be*  
17 *furnished from stocks under the control of agencies of the*

21 *Guard commanders while inspecting units in compliance*

25 Circuit Board Manufacturing Development Center.

1        *SEC. 8125. COMMISSION TO ASSESS THE ORGANIZA-*  
2        *TION OF THE FEDERAL GOVERNMENT TO COMBAT THE*  
3        *PROLIFERATION OF WEAPONS OF MASS DESTRUCTION. The*  
4        *Combatting Proliferation of Weapons of Mass Destruction*  
5        *Act of 1996 (as contained in Public Law 104-293) is*

5 *SEC. 8144. (a) FINDINGS.—The Senate finds that—*

6 *(1) child experts estimate that as many as*  
7 *250,000 children under the age of 18 are currently*  
8 *serving in armed forces or armed groups in more*  
9 *than 30 countries around the world;*

10 *(2) contemporary armed conflict has caused the*  
11 *deaths of 2,000,000 minors in the last decade alone,*  
12 *and has left an estimated 6,000,000 children seriously*  
13 *injured or permanently disabled;*

14 *(3) children are uniquely vulnerable to military*  
15 *recruitment because of their emotional and physical*  
16 *immaturity, are easily manipulated, and can be*  
17 *drawn into violence that they are too young to resist*  
18 *or understand;*

19 *(4) children are most likely to become child sol-*  
20 *diers if they are poor, separated from their families,*  
21 *displaced from their homes, living in a combat zone,*  
22 *or have limited access to education;*

23 *(5) orphans and refugees are particularly vulner-*  
24 *able to recruitment;*

1           (6) one of the most egregious examples of the use  
2           of child soldiers is the abduction of some 10,000 chil-  
3           dren, some as young as 8 years of age, by the Lord's  
4           Resistance Army (in this section referred to as the  
5           "LRA") in northern Uganda;

6           (7) the Department of State's Country Reports  
7           on Human Rights Practices for 1997 reports that in  
8           Uganda the LRA kills, maims, and rapes large num-  
9           bers of civilians, and forces abducted children into  
10          "virtual slavery as guards, concubines, and soldiers";

11          (8) children abducted by the LRA are forced to  
12          raid and loot villages, fight in the front line of battle  
13          against the Ugandan army and the Sudan People's  
14          Liberation Army (SPLA), serve as sexual slaves to  
15          rebel commanders, and participate in the killing of  
16          other children who try to escape;

17          (9) former LRA child captives report witnessing  
18          Sudanese government soldiers delivering food sup-  
19          plies, vehicles, ammunition, and arms to LRA base  
20          camps in government-controlled southern Sudan;

21          (10) children who manage to escape from LRA  
22          captivity have little access to trauma care and reha-  
23          bilitation programs, and many find their families  
24          displaced, unlocatable, dead, or fearful of having their  
25          children return home;

1           (11) *Graca Machel, the former United Nations*  
2           *expert on the impact of armed conflict on children,*  
3           *identified the immediate demobilization of all child*  
4           *soldiers as an urgent priority, and recommended the*  
5           *establishment through an optional protocol to the*  
6           *Convention on the Rights of the Child of 18 as the*  
7           *minimum age for recruitment and participation in*  
8           *armed forces; and*

9           (12) *the International Committee of the Red*  
10          *Cross, the United Nations Children's Fund*  
11          *(UNICEF), the United Nations High Commission on*  
12          *Refugees, and the United Nations High Commissioner*  
13          *on Human Rights, as well as many nongovernmental*  
14          *organizations, also support the establishment of 18 as*  
15          *the minimum age for military recruitment and par-*  
16          *ticipation in armed conflict.*

17          (b) *IN GENERAL.—The Senate hereby—*

18                 (1) *deplores the global use of child soldiers and*  
19                 *supports their immediate demobilization;*

20                 (2) *condemns the abduction of Ugandan children*  
21                 *by the LRA;*

22                 (3) *calls on the Government of Sudan to use its*  
23                 *influence with the LRA to secure the release of ab-*  
24                 *ducted children and to halt further abductions; and*



1           (4) encourages the United States delegation not  
2       to block the drafting of an optional protocol to the  
3       Convention on the Rights of the Child that would es-  
4       tablish 18 as the minimum age for participation in  
5       armed conflict.

6       (c) *SENSE OF THE SENATE.*—It is the sense of the Sen-  
7       ate that the President and the Secretary of State should—

8           (1) support efforts to end the abduction of chil-  
9       dren by the LRA, secure their release, and facilitate  
10      their rehabilitation and reintegration into society;

11          (2) not block efforts to establish 18 as the mini-  
12      mum age for participation in conflict through an op-  
13      tional protocol to the Convention on the Rights of the  
14      Child; and

15          (3) provide greater support to United Nations  
16      agencies and nongovernmental organizations working  
17      for the rehabilitation and reintegration of former  
18      child soldiers into society.

19      *SEC. 8145. Notwithstanding any other provision of*  
20      *law, the Secretary of Defense shall obligate the funds pro-*  
21      *vided for Counterterror Technical Support in the Depart-*  
22      *ment of Defense Appropriations Act, 1998 (under title IV*  
23      *of Public Law 105–56) for the projects and in the amounts*  
24      *provided for in House Report 105–265 of the House of Rep-*  
25      *resentatives, One Hundred Fifth Congress, First Session:*

1 *Provided, That the funds available for the Pulsed Fast Neu-*  
 2 *tron Analysis Project should be executed through coopera-*  
 3 *tion with the Office of National Drug Control Policy.*

4 *SEC. 8146. Of the funds provided under title IV of this*  
 5 *Act under the heading “RESEARCH, DEVELOPMENT, TEST*  
 6 *AND EVALUATION, NAVY”, up to \$1,000,000 may be made*  
 7 *available only for the development and testing of alternate*  
 8 *turbine engines for missiles.*

9 *SEC. 8147. VOTING RIGHTS OF MILITARY PERSONNEL.*

10 *(a) GUARANTEE OF RESIDENCY.—Article VII of the Sol-*  
 11 *diers’ and Sailors’ Civil Relief Act of 1940 (50 U.S.C. 590*  
 12 *et seq.) is amended by adding at the end the following:*

13 *“SEC. 704. (a) For purposes of voting for an office of*  
 14 *the United States or of a State, a person who is absent from*  
 15 *a State in compliance with military or naval orders shall*  
 16 *not, solely by reason of that absence—*

17 *“(1) be deemed to have lost a residence or domi-*  
 18 *cile in that State;*

19 *“(2) be deemed to have acquired a residence or*  
 20 *domicile in any other State; or*

21 *“(3) be deemed to have become resident in or a*  
 22 *resident of any other State.*

23 *“(b) in this section, the term ‘State’ includes a terri-*  
 24 *tory or possession of the United States, a political subdivi-*

1 sion of a State, territory, or possession, and the District  
2 of Columbia.”.

3 (b) *STATE RESPONSIBILITY TO GUARANTEE MILITARY*  
4 *VOTING RIGHTS.—(1) REGISTRATION AND BALLOTING.—*  
5 *Section 102 of the Uniformed and Overseas Absentee Voting*  
6 *Act (42 U.S.C. 1973ff–1) is amended—*

7 (A) *by inserting “(a) ELECTIONS FOR FEDERAL*  
8 *OFFICES.—” before “Each State shall—”; and*

9 (B) *by adding at the end the following:*

10 “(b) *ELECTIONS FOR STATE AND LOCAL OFFICES.—*  
11 *Each State shall—*

12 “(1) *permit absent uniformed services voters to*  
13 *use absentee registration procedures and to vote by*  
14 *absentee ballot in general, special, primary, and run-*  
15 *off elections for State and local offices; and*

16 “(2) *accept and process, with respect to any elec-*  
17 *tion described in paragraph (1), any otherwise valid*  
18 *voter registration application from an absent uni-*  
19 *formed services voter if the application is received by*  
20 *the appropriate State election official not less than 30*  
21 *days before the election.”.*

22 (2) *CONFORMING AMENDMENT.—The heading for title*  
23 *I of such Act is amended by striking out “**FOR FED-***  
24 ***ERAL OFFICE**”.*

1       *SEC. 8148. From amounts made available by this Act,*  
2 *up to \$10,000,000 may be available to convert the Eighth*  
3 *Regiment National Guard Armory into a Chicago Military*  
4 *Academy: Provided, That the Academy shall provide a 4*  
5 *year college preparatory curriculum combined with a manda-*  
6 *tory JROTC instruction program.*

7       *SEC. 8149. (a) The Air National Guard shall, during*  
8 *the period beginning on April 15, 1999, and ending on Oc-*  
9 *tober 15, 1999, provide support at the Francis S. Gabreski*  
10 *Airport, Hampton, New York, for seasonal search and res-*  
11 *cue mission requirements of the Coast Guard in the vicinity*  
12 *of Hampton, New York.*

13       *(b) The support provided under subsection (a) shall in-*  
14 *clude access to and use of appropriate facilities at Francis*  
15 *S. Gabreski Airport, including runways, hangars, the oper-*  
16 *ations center, and aircraft berthing and maintenance*  
17 *spaces.*

18       *(c)(1) The adjutant general of the National Guard of*  
19 *the State of New York and the Commandant of the Coast*  
20 *Guard shall enter into a memorandum of understanding*  
21 *regarding the support to be provided under subsection (a).*

22       *(2) Not later than December 1, 1998, the adjutant gen-*  
23 *eral and the Commandant shall jointly submit to the Com-*  
24 *mittee on Appropriations of the Senate and the Committee*  
25 *on Appropriations of the House of Representatives a copy*

1 of the memorandum of understanding entered into under  
2 paragraph (1).

3       SEC. 8150. (a) *The Secretary of Defense, in coordina-*  
4 *tion with the Secretary of Health and Human Services,*  
5 *may carry out a program to distribute surplus dental*  
6 *equipment of the Department of Defense, at no cost to the*  
7 *Department of Defense, Indian health service facilities and*  
8 *to federally-qualified health centers (within the meaning of*  
9 *section 1905(l)(2)(B) of the Social Security Act (42 U.S.C.*  
10 *1396d(l)(2)(B))).*

11       (b) *Not later than March 15, 1999, the Secretary of*  
12 *Defense shall submit to Congress a report on the program,*  
13 *including the actions taken under the program.*

14       SEC. 8151. (a) *Not later than March 15, 1999, the Sec-*  
15 *retary of Defense shall submit to the Committees on Appro-*  
16 *priations and on Armed Services of the Senate and the*  
17 *Committees on Appropriations and on National Security*  
18 *of the House of Representatives a report on the policies,*  
19 *practices, and experience of the uniformed services pertain-*  
20 *ing to the furnishing of dental care to dependents of mem-*  
21 *bers of the uniformed services on active duty who are 18*  
22 *years of age and younger.*

23       (b) *The report shall include (1) the rates of usage of*  
24 *various types of dental services under the health care system*  
25 *of the uniformed services by the dependents, set forth in cat-*

1 egories defined by the age and the gender of the dependents  
2 and by the rank of the members of the uniformed services  
3 who are the sponsors for those dependents, (2) an assessment  
4 of the feasibility of providing the dependents with dental  
5 benefits (including initial dental visits for children) that  
6 conform with the guidelines of the American Academy of  
7 Pediatric Dentistry regarding infant oral health care, and  
8 (3) an evaluation of the feasibility and potential effects of  
9 offering general anesthesia as a dental health care benefit  
10 available under *TRICARE* to the dependents.

11       *SEC. 8152. (a) Of the total amount appropriated for*  
12 *the Army, the Army Reserve, and the Army National Guard*  
13 *under title I, \$1,700,000 may be available for taking the*  
14 *actions required under this section to eliminate the backlog*  
15 *of unpaid retired pay and to submit a report.*

16       *(b) The Secretary of the Army may take such actions*  
17 *as are necessary to eliminate, by December 31, 1998, the*  
18 *backlog of unpaid retired pay for members and former*  
19 *members of the Army (including members and former mem-*  
20 *bers of the Army Reserve and the Army National Guard).*

21       *(c) Not later than 30 days after the date of the enact-*

5           SEC. 8153. (a) *The Secretary of Defense may take such*  
6           *actions as are necessary to ensure the elimination of the*  
7           *backlog of incomplete actions on requests of former members*  
8           *of the Armed Forces for replacement medals and replace-*  
9           *ments for other decorations that such personnel have earned*  
10          *in the military service of the United States.*

11          (b)(1) *The actions taken under subsection (a) may in-*  
12          *clude, except as provided in paragraph (2), allocations of*  
13          *additional resources to improve relevant staffing levels at*  
14          *the Army Reserve Personnel Command, the Bureau of*  
15          *Naval Personnel, and the Air Force Personnel Center, allo-*  
16          *cations of Department of Defense resources to the National*  
17          *Archives and Records Administration, and any additional*  
18          *allocations of resources that the Secretary considers nec-*  
19          *essary to carry out subsection (a).*

20          (2) *An allocation of resources may be made under*  
21          *paragraph (1) only if and to the extent that the allocation*  
22          *does not detract from the performance of other personnel*  
23          *service and personnel support activities within the Depart-*  
24          *ment of Defense.*

1        *SEC. 8154. Beginning no later than 60 days after en-*  
2 *actment, effective tobacco cessation products and counseling*  
3 *may be provided for members of the Armed Forces (includ-*  
4 *ing retired members), former members of the Armed Forces*  
5 *entitled to retired or retainer pay, and dependents of such*  
6 *members and former members, who are identified as likely*  
7 *to benefit from such assistance in a manner that does not*  
8 *impose costs upon the individual.*

9        *SEC. 8155. (a) Of the amounts appropriated by title*  
10 *II of this Act under the heading “OPERATION AND MAINTENANCE,*  
11 *MARINE CORPS”, \$5,000,000 may be available for*  
12 *procurement of lightweight maintenance enclosures (LME).*

13        *(b) Of the amounts appropriated by title III of this*  
14 *Act under the heading “OTHER PROCUREMENT, ARMY”,*  
15 *\$2,000,000 may be available for procurement of lightweight*  
16 *maintenance enclosures (LME).*

17        *SEC. 8156. Of the funds available for Drug Interdic-*  
18 *tion, up to \$8,500,000 may be made available to support*  
19 *restoration of enhanced counter-narcotics operations around*  
20 *the island of Hispaniola, for operation and maintenance*  
21 *for establishment of ground-based radar coverage at Guan-*  
22 *tanamo Bay Naval Base, Cuba, for procurement of 2*  
23 *Schweizer observation/spray aircraft, and for upgrades for*  
24 *3 UH–IH helicopters for Colombia.*



1       *SEC. 8157. (a) The Secretary of Defense shall study*  
2 *the policies, procedures, and practices of the military de-*  
3 *partments for protecting the confidentiality of communica-*  
4 *tions between—*

5               *(1) a dependent of a member of the Armed*  
6 *Forces who—*

7                       *(A) is a victim of sexual harassment, sexual*  
8 *assault, or intrafamily abuse; or*

9                       *(B) has engaged in such misconduct; and*

10               *(2) a therapist, counselor, advocate, or other pro-*  
11 *fessional from whom the victim seeks professional*  
12 *services in connection with effects of such misconduct.*

13       *(b)(1) The Secretary of Defense shall prescribe in regu-*  
14 *lations the policies and procedures that the Secretary con-*  
15 *siders necessary to provide the maximum possible protec-*  
16 *tions for the confidentiality of communications described in*  
17 *subsection (a) relating to misconduct described in that sub-*  
18 *section.*

19       *(2) The regulations shall provide the following:*

20               *(A) Complete confidentiality of the records of the*  
21 *communications of dependents of members of the*  
22 *Armed Forces.*

23               *(B) Characterization of the records under family*  
24 *advocacy programs of the Department of Defense as*  
25 *primary medical records for purposes of the protec-*

1        *tions from disclosure that are associated with pri-*  
2        *mary medical records.*

3                *(C) Facilitated transfer of records under family*  
4        *advocacy programs in conjunction with changes of*  
5        *duty stations of persons to whom the records relate in*  
6        *order to provide for continuity in the furnishing of*  
7        *professional services.*

8                *(D) Adoption of standards of confidentiality and*  
9        *ethical standards that are consistent with standards*  
10       *issued by relevant professional associations.*

11        *(3) In prescribing the regulations, the Secretary shall*  
12       *consider the following:*

13                *(A) Any risk that the goals of advocacy and*  
14        *counseling programs for helping victims recover from*  
15        *adverse effects of misconduct will not be attained if*  
16        *there is no assurance that the records of the commu-*  
17        *nications (including records of counseling sessions)*  
18        *will be kept confidential.*

19                *(B) The extent, if any, to which a victim's safety*  
20        *and privacy should be factors in determinations re-*  
21        *garding—*

22                        *(i) disclosure of the victim's identity to the*  
23                        *public or the chain of command of a member of*  
24                        *the Armed Forces alleged to have engaged in the*  
25                        *misconduct toward the victim; or*

1                   (ii) any other action that facilitates such a  
2                   disclosure without the consent of the victim.

3                   (C) The eligibility for care and treatment in  
4                   medical facilities of the uniformed services for any  
5                   person having a uniformed services identification  
6                   card (including a card indicating the status of a per-  
7                   son as a dependent of a member of the uniformed  
8                   services) that is valid for that person.

9                   (D) The appropriateness of requiring that so-  
10                  called Privacy Act statements be presented as a condi-  
11                  tion for proceeding with the furnishing of treatment  
12                  or other services by professionals referred to in sub-  
13                  section (a).

14                  (E) The appropriateness of adopting the same  
15                  standards of confidentiality and ethical standards  
16                  that have been issued by such professional associa-  
17                  tions as the American Psychiatric Association and  
18                  the National Association of Social Workers.

19                  (4) The regulations may not prohibit the disclosure of  
20                  information to a Federal or State agency for a law enforce-  
21                  ment or other governmental purpose.

22                  (c) The Secretary of Defense shall consult with the At-  
23                  torney General in carrying out this section.

24                  (d) Not later than 90 days after the date of the enact-  
25                  ment of this Act, the Secretary of Defense shall submit to

1 *Congress a report on the actions taken under this section.*  
2 *The report shall include a discussion of the results of the*  
3 *study under subsection (a) and the comprehensive discus-*  
4 *sion of the regulations prescribed under subsection (b).*

5 *SEC. 8158. (a) FINDINGS.—The Senate finds that—*

6 *(1) on the third of February a United States*  
7 *Marine Corps jet aircraft, flying a low-level training*  
8 *mission out of Aviano, Italy, flew below its prescribed*  
9 *altitude and severed the cables supporting a gondola*  
10 *at the Italian ski resort near Cavalese, resulting in*  
11 *the death of twenty civilians;*

12 *(2) the crew of the aircraft, facing criminal*  
13 *charges, is entitled to a speedy trial and is being pro-*  
14 *vided that and all the other protections and advan-*  
15 *tages of the United States system of justice;*

16 *(3) the United States, to maintain its credibility*  
17 *and honor amongst its allies and all nations of the*  
18 *world, should make prompt reparations for an acci-*  
19 *dent clearly caused by a United States military air-*  
20 *craft;*

21 *(4) a high-level delegation, including the United*  
22 *States Ambassador to Italy, recently visited Cavalese*  
23 *and, as a result, \$20,000,000 was promised to the*  
24 *people in Cavalese for their property damage and*  
25 *business losses;*

1           (5) *without our prompt action, these families*  
2           *continue to suffer financial agonies, our credibility in*  
3           *the European community continues to suffer, and our*  
4           *own citizens remain puzzled and angered by our lack*  
5           *of accountability;*

6           (6) *under the current arrangement we have with*  
7           *Italy in the context of our Status of Forces Agreement*  
8           *(SOFA), civil claims arising from the accident at*  
9           *Cavalese must be brought against the Government of*  
10          *Italy, in accordance with the laws and regulations of*  
11          *Italy, as if the armed forces of Italy had been respon-*  
12          *sible for the accident;*

13          (7) *under Italian law, every claimant for prop-*  
14          *erty damage, personal injury or wrongful death must*  
15          *file initially an administrative claim for damages*  
16          *with the Ministry of Defense in Rome which is ex-*  
17          *pected to take 12–18 months, and, if the Ministry’s*  
18          *offer in settlement is not acceptable, which it is not*  
19          *likely to be, the claimant must thereafter resort to the*  
20          *Italian court system, where civil cases for wrongful*  
21          *death are reported to take up to ten years to resolve;*

22          (8) *while under the SOFA process, the United*  
23          *States—as the “sending state”—will be responsible*  
24          *for 75 percent of any damages awarded, and the Gov-*  
25          *ernment of Italy—as the “receiving state”—will be*

1        *responsible for 25 percent, the United States has*  
2        *agreed to pay all damages awarded in this case.*

3        *(b) SENSE OF CONGRESS.—It is the sense of the Con-*  
4        *gress that the United States should resolve the claims of the*  
5        *victims of the February 8, 1998 United States Marine*  
6        *Corps aircraft incident in Cavalese, Italy as quickly and*  
7        *fairly as possible.*

8        *SEC. 8159. TRAINING AND OTHER PROGRAMS. (a)*  
9        *PROHIBITION.—None of the funds made available by this*  
10       *Act may be used to support any training program involv-*  
11       *ing a unit of the security forces of a foreign country if the*  
12       *Secretary of Defense has received credible information from*  
13       *the Department of State that a member of such unit has*  
14       *committed a gross violation of human rights, unless all nec-*  
15       *essary corrective steps have been taken.*

16       *(b) MONITORING.—Not more than 90 days after enact-*  
17       *ment of this Act, the Secretary of Defense, in consultation*  
18       *with the Secretary of State, shall establish procedures to en-*  
19       *sure that prior to a decision to conduct any training pro-*  
20       *gram referred to in subsection (a), full consideration is*  
21       *given to all information available to the Department of*  
22       *State relating to human rights violations by foreign secu-*  
23       *rity forces.*

24       *(c) WAIVER.—The Secretary of Defense, after consulta-*  
25       *tion with the Secretary of State, may waive the prohibition*

1 *in subsection (a) if he determines that such waiver is re-*  
2 *quired by extraordinary circumstances.*

3       *(d) REPORT.—Not more than 15 days after the exercise*  
4 *of any waiver under subsection (c), the Secretary of Defense*  
5 *shall submit a report to the congressional defense commit-*  
6 *tees describing the extraordinary circumstances, the purpose*  
7 *and duration of the training program, the United States*  
8 *forces and the foreign security forces involved in the train-*  
9 *ing program, and the information relating to human rights*  
10 *violations that necessitates the waiver.*

11       *SEC. 8160. (a) FINDINGS.—Congress makes the follow-*  
12 *ing findings:*

13               *(1) Since 1989—*

14                       *(A) the national defense budget has been cut*  
15                       *in half as a percentage of the gross domestic*  
16                       *product;*

17                       *(B) the national defense budget has been cut*  
18                       *by over \$120,000,000,000 in real terms;*

19                       *(C) the United States military force struc-*  
20                       *ture has been reduced by more than 30 percent;*

21                       *(D) the Department of Defense's operations*  
22                       *and maintenance accounts have been reduced by*  
23                       *40 percent;*

1           (E) the Department of Defense's procure-  
2           ment funding has declined by more than 50 per-  
3           cent;

4           (F) United States military operational  
5           commitments have increased fourfold;

6           (G) the Army has reduced its ranks by over  
7           630,000 soldiers and civilians, closed over 700  
8           installations at home and overseas, and cut 10  
9           divisions from its force structure;

10          (H) the Army has reduced its presence in  
11          Europe from 215,000 to 65,000 personnel;

12          (I) the Army has averaged 14 deployments  
13          ever four years, increased significantly from the  
14          Cold War trend of one deployment ever four  
15          years;

16          (J) the Air Force has downsized by nearly  
17          40 percent, while experiencing a fourfold in-  
18          crease in operational commitments.

19          (2) In 1992, 37 percent of the Navy's fleet was  
20          deployed at any given time. Today that number is 57  
21          percent; at its present rate, it will climb to 62 percent  
22          by 2005.

23          (3) The Navy Surface Warfare Officer commu-  
24          nity will fall short of its needs of a 40 percent in-  
25          crease in retention to meet requirements.



1           (4) *The Air Force is 18 percent short of its reten-*  
2           *tion goal for second-term airmen.*

3           (5) *The Air Force is more than 800 pilots short,*  
4           *and more than 70 percent eligible for retention bo-*  
5           *nuses have turned them down in favor of separation.*

6           (6) *The Army faces critical personnel shortages*  
7           *in combat units, forcing unit commanders to borrow*  
8           *troops from other units just to participate in training*  
9           *exercises.*

10          (7) *An Air Force F-16 squadron commander tes-*  
11          *tified before the House National Security Committee*  
12          *that his unit was forced to borrow three aircraft and*  
13          *use cannibalized parts from four other F-16's in*  
14          *order to deploy to Southwest Asia.*

15          (8) *In 1997, the Army averaged 31,000 soldiers*  
16          *deployed away from their home station in support of*  
17          *military operations in 70 countries with the average*  
18          *deployment lasting 125 days.*

19          (9) *Critical shortfalls in meeting recruiting and*  
20          *retention goals is seriously affecting the ability of the*  
21          *Army to train and deploy. The Army reduced its re-*  
22          *cruiting goal for 1998 by 12,000 personnel.*

23          (10) *In fiscal year 1997, the Army fell short of*  
24          *its recruiting goal for critical infantry soldiers by al-*  
25          *most 5,000. As of February 15, 1998, Army-wide*

1       *shortages existed for 28 Army specialties. Many posi-*  
2       *tions in squads and crews are left unfilled or mini-*  
3       *mally filled because personnel are diverted to work in*  
4       *key positions elsewhere.*

5               *(11) The Navy reports it will fall short of en-*  
6       *listed sailor recruitment for 1998 by 10,000.*

7               *(12) One in ten Air Force front-line units are*  
8       *not combat ready.*

9               *(13) Ten Air Force technical specialties, rep-*  
10       *resenting thousands of airmen, deployed away from*  
11       *their home station for longer than the Air Force*  
12       *standard 120-day mark in 1997.*

13               *(14) The Air Force fell short of its reenlistment*  
14       *rate for mid-career enlisted personnel by an average*  
15       *of six percent, with key war fighting career fields ex-*  
16       *periencing even larger drops in reenlistments.*

17               *(15) In 1997, United States Marines in the oper-*  
18       *ating forces have deployed on more than 200 exercises,*  
19       *rotational deployments, or actual contingencies.*

20               *(16) United States Marine Corps maintenance*  
21       *forces are only able to maintain 92 percent ground*  
22       *equipment and 77 percent aviation equipment readi-*  
23       *ness rates due to excessive deployments of troops and*  
24       *equipment.*

1           (17) *The National Security Strategy of the*  
2           *United States assumes the ability of the United States*  
3           *Armed Forces to prevail in two major regional con-*  
4           *flicts nearly simultaneously.*

5           (18) *To execute the National Security of the*  
6           *United States, the United States Army's five later-de-*  
7           *ploying divisions, which constitute almost half of the*  
8           *Army's active combat forces, are critical to the success*  
9           *of specific war plans.*

10          (19) *According to commanders in these divisions,*  
11          *the practice of under staffing squads and crews that*  
12          *are responsible for training, and assigning personnel*  
13          *to other units as fillers for exercises and operations,*  
14          *has become common and is degrading unit capability*  
15          *and readiness.*

16          (20) *In the aggregate, the Army's later-deploying*  
17          *divisions were assigned 93 percent of their authorized*  
18          *personnel at the beginning of fiscal year 1998. In one*  
19          *specific case, the 1st Armored Division was staffed at*  
20          *94 percent in the aggregate; however, its combat sup-*  
21          *port and service support specialties were filled at*  
22          *below 85 percent, and captains and majors were filled*  
23          *at 73 percent.*

24          (21) *At the 10th Infantry Division, only 138 of*  
25          *162 infantry squads were fully or minimally filled,*

1        *and 36 of the filled squads were unqualified. At the*  
2        *1st Brigade of the 1st Infantry Division, only 56 per-*  
3        *cent of the authorized infantry soldiers for its Bradley*  
4        *Fighting Vehicles were assigned, and in the 2nd Bri-*  
5        *gade, 21 of 48 infantry squads had no personnel as-*  
6        *signed.*

7                *(22) At the 3rd Brigade of the 1st Armored Divi-*  
8        *sion, only 16 of 116 M1A1 tanks had full crews and*  
9        *were qualified, and in one of the Brigade's two armor*  
10       *battalions, 14 of 58 tanks had no crewmembers as-*  
11       *signed because the personnel were deployed to Bosnia.*

12               *(23) At the beginning of fiscal year 1998, the five*  
13       *later-deploying divisions critical to the execution of*  
14       *the United States National Security Strategy were*  
15       *short nearly 1,900 of the total 25,357 Non-Commis-*  
16       *sioned Officers authorized, and as of February 15,*  
17       *1998, this shortage had grown to almost 2,200.*

18               *(24) Rotation of units to Bosnia is having a di-*  
19       *rect and negative impact on the ability of later-de-*  
20       *ploying divisions to maintain the training and readi-*  
21       *ness levels needed to execute their mission in a major*  
22       *regional conflict. Indications of this include:*

23               *(A) The reassignment by the Commander of*  
24       *the 3rd Brigade Combat Team of 63 soldiers*  
25       *within the brigade to serve in infantry squads of*

1        *a deploying unit of 800 troops, stripping non-*  
2        *deploying infantry and armor units of mainte-*  
3        *nance personnel, and reassigning Non-Commis-*  
4        *sioned Officers and support personnel to the task*  
5        *force from throughout the brigade.*

6                *(B) Cancellation of gunnery exercises for at*  
7        *least two armor battalions in later-deploying di-*  
8        *visions, causing 43 of 116 tank crews to lose*  
9        *their qualifications on the weapon system.*

10               *(C) Hiring of outside contract personnel by*  
11        *1st Armored and 1st Infantry later-deploying di-*  
12        *visions to perform routine maintenance.*

13               *(25) National Guard budget shortfalls com-*  
14        *promise the Guard's readiness levels, capabilities,*  
15        *force structure, and end strength, putting the Guard's*  
16        *personnel, schools, training, full-time support, reten-*  
17        *tion and recruitment, and morale at risk.*

18               *(26) The President's budget requests for the Na-*  
19        *tional Guard have been insufficient, notwithstanding*  
20        *the frequent calls on the Guard to handle wide-rang-*  
21        *ing tasks, including deployments in Bosnia, Iraq,*  
22        *Haiti, and Somalia.*

23        *(b) SENSE OF CONGRESS.—It is the sense of Congress*  
24        *that—*

1           (1) *the readiness of United States military forces*  
2           *to execute the National Security Strategy of the*  
3           *United States is being eroded from a combination of*  
4           *declining defense budgets and expanded missions;*

5           (2) *the ongoing, open-ended commitment of*  
6           *United States forces to the peacekeeping mission in*  
7           *Bosnia is causing assigned and supporting units to*  
8           *compromise their principle wartime assignments;*

9           (3) *defense appropriations are not keeping pace*  
10          *with the expanding needs of the Armed Forces.*

11          (c) *REPORT REQUIREMENT.*—*Not later than June 1,*  
12          *1999, the President shall submit to the Committee on Armed*  
13          *Services of the Senate and the Committee on National Secu-*  
14          *rity of the House of Representatives, and to the Committees*  
15          *on Appropriations in both Houses, a report on the military*  
16          *readiness of the Armed Forces of the United States. The*  
17          *President shall include in the report a detailed discussion*  
18          *of the competition for resources service-by-service caused by*  
19          *the ongoing commitment to the peacekeeping operation in*  
20          *Bosnia, including in those units that are supporting but*  
21          *not directly deployed to Bosnia. The President shall specifi-*  
22          *cally include in the report the following—*

23               (1) *an assessment of current force structure and*  
24               *its sufficiency to execute the National Security Strat-*  
25               *egy of the United States;*

1           (2) *an outline of the service-by-service force*  
2           *structure expected to be committed to a major re-*  
3           *gional contingency as envisioned in the National Se-*  
4           *curity Strategy of the United States;*

5           (3) *a comparison of the force structures outlined*  
6           *in paragraph (2) with the service-by-service order of*  
7           *battle in Operation Desert Shield/Desert Storm, as a*  
8           *representative and recent major regional conflict;*

9           (4) *the force structure and defense appropriation*  
10          *increases that are necessary to execute the National*  
11          *Security Strategy of the United States assuming cur-*  
12          *rent projected ground force levels assigned to the*  
13          *peacekeeping mission in Bosnia are unchanged;*

14          (5) *a discussion of the United States ground*  
15          *force level in Bosnia that can be sustained without*  
16          *impacting the ability of the Armed Forces to execute*  
17          *the National Security Strategy of the United States,*  
18          *assuming no increases in force structure and defense*  
19          *appropriations during the period in which ground*  
20          *forces are assigned to Bosnia.*

21          SEC. 8161. SENSE OF THE SENATE REGARDING PAY-  
22          ROLL TAX RELIEF. (a) FINDINGS.—*The Senate finds the*  
23          *following:*

1           (1) *The payroll tax under the Federal Insurance*  
2           *Contributions Act (FICA) is the biggest, most regres-*  
3           *sive tax paid by working families.*

4           (2) *The payroll tax constitutes a 15.3 percent tax*  
5           *burden on the wages and self-employment income of*  
6           *each American, with 12.4 percent of the payroll tax*  
7           *used to pay social security benefits to current bene-*  
8           *ficiaries and 2.9 percent used to pay the medicare*  
9           *benefits of current beneficiaries.*

10          (3) *The amount of wages and self-employment*  
11          *income subject to the social security portion of the*  
12          *payroll tax is capped at \$68,400. Therefore, the lower*  
13          *a family's income, the more they pay in payroll tax*  
14          *as a percentage of income. The Congressional Budget*  
15          *Office has estimated that for those families who pay*  
16          *payroll taxes, 80 percent pay more in payroll taxes*  
17          *than in income taxes.*

18          (4) *In 1996, the median household income was*  
19          *\$35,492, and a family earning that amount and tak-*  
20          *ing standard deductions and exemptions paid \$2,719*  
21          *in Federal income tax, but lost \$5,430 in income to*  
22          *the payroll tax.*

23          (5) *Ownership of wealth is essential for everyone*  
24          *to have a shot at the American dream, but the payroll*



1       *tax is the principal burden to savings and wealth cre-*  
2       *ation for working families.*

3               *(6) Since 1983, the payroll tax has been higher*  
4       *than necessary to pay current benefits.*

5               *(7) Since most of the payroll tax receipts are de-*  
6       *posited in the social security trust funds, which masks*  
7       *the real amount of Government borrowing, those*  
8       *whom the payroll tax hits hardest, working families,*  
9       *have shouldered a disproportionate share of the Fed-*  
10       *eral budget deficit reduction and, therefore, a dis-*  
11       *proportionate share of the creation of the Federal*  
12       *budget surplus.*

13               *(8) Over the next 10 years, the Federal Govern-*  
14       *ment will generate a budget surplus of*  
15       *\$1,550,000,000,000, and all but \$32,000,000,000 of*  
16       *that surplus will be generated by excess payroll taxes.*

17       *(b) SENSE OF THE SENATE.—It is the sense of the Sen-*  
18       *ate that—*

19               *(1) if Congress decides to provide tax relief, re-*  
20       *ducing the burden of payroll taxes should be a top*  
21       *priority; and*

22               *(2) Congress and the President should work to*  
23       *reduce this payroll tax burden on American families.*

1        *TITLE IX —MONITORING OF HUMAN RIGHTS*  
2                    *ABUSES IN CHINA*

3        *SEC. 9001. SHORT TITLE. This title may be cited as*  
4 *the “Political Freedom in China Act of 1998”.*

5        *SEC. 9002. FINDINGS. Congress makes the following*  
6 *findings:*

7            *(1) Congress concurs in the following conclusions*  
8 *of the United States State Department on human*  
9 *rights in the People’s Republic of China in 1996:*

10            *(A) The People’s Republic of China is “an*  
11 *authoritarian state” in which “citizens lack the*  
12 *freedom to peacefully express opposition to the*  
13 *party-led political system and the right to*  
14 *change their national leaders or form of govern-*  
15 *ment”.*

16            *(B) The Government of the People’s Repub-*  
17 *lic of China has “continued to commit wide-*  
18 *spread and well-documented human rights*  
19 *abuses, in violation of internationally accepted*  
20 *norms, stemming from the authorities’ intoler-*  
21 *ance of dissent, fear of unrest, and the absence*  
22 *of inadequacy of laws protecting basic freedoms”.*

23            *(C) “abuses include torture and mistreat-*  
24 *ment of prisoners, forced confessions, and arbi-*  
25 *trary and incommunicado detention”.*

1           (D) “prison conditions remained harsh and  
2           the Government continued severe restrictions on  
3           freedom of speech, the press, assembly, associa-  
4           tion, religion, privacy, and worker rights”.

5           (E) “although the Government denies that it  
6           holds political prisoners, the number of persons  
7           detained or serving sentences for  
8           ‘counterrevolutionary crimes’ or ‘crimes against  
9           the state’, or for peaceful political or religious  
10          activities are believed to number in the thou-  
11          sands”.

12          (F) “nonapproved religious groups, includ-  
13          ing Protestant and Catholic  
14          groups . . . experienced intensified repression”.

15          (G) “serious human rights abuses persist in  
16          minority areas, including Tibet, Xinjiang, and  
17          Inner Mongolia, and controls on religion and on  
18          other fundamental freedoms in these areas have  
19          also intensified”.

20          (H) “overall in 1996, the authorities  
21          stepped up efforts to cut off expressions of protest  
22          or criticism. All public dissent against the party  
23          and government was effectively silenced by in-  
24          timidation, exile, the imposition of prison terms,

1           *administrative detention, or house arrest. No dis-*  
2           *sidents were known to be active at year's end."*

3           *(2) In addition to the State Department, credible*  
4           *independent human rights organizations have docu-*  
5           *mented an increase in repression in China during*  
6           *1995, and effective destruction of the dissident move-*  
7           *ment through the arrest and sentencing of the few re-*  
8           *maining pro-democracy and human rights activists*  
9           *not already in prison or exile.*

10          *(3) Among those were Li Hai, sentenced to 9*  
11          *years in prison on December 18, 1996, for gathering*  
12          *information on the victims of the 1989 crackdown,*  
13          *which according to the court's verdict constituted*  
14          *"state secrets"; Liu Nianchun, an independent labor*  
15          *organizer, sentenced to 3 years of "re-education*  
16          *through labor" on July 4, 1996, due to his activities*  
17          *in connection with a petition campaign calling for*  
18          *human rights reforms; and Ngodrup Phuntsog, a Ti-*  
19          *betan national, who was arrested in Tibet in 1987*  
20          *immediately after he returned from a 2-year trip to*  
21          *India, where the Tibetan government in exile is lo-*  
22          *cated, and following a secret trial was convicted by*  
23          *the Government of the People's Republic of China of*  
24          *espionage on behalf of the "Ministry of Security of the*  
25          *Dalai clique".*

1           (4) *Many political prisoners are suffering from*  
2           *poor conditions and ill-treatment leading to serious*  
3           *medical and health problems, including—*

4                   (A) *Gao Yu, a journalist sentenced to 6*  
5                   *years in prison in November 1994 and honored*  
6                   *by UNESCO in May 1997, has a heart condi-*  
7                   *tion; and*

8                   (B) *Chen Longde, a leading human rights*  
9                   *advocate now serving a 3-year re-education*  
10                  *through labor sentence imposed without trial in*  
11                  *August 1995, has reportedly been subject to re-*  
12                  *peated beatings and electric shocks at a labor*  
13                  *camp for refusing to confess his guilt.*

14           (5) *The People's Republic of China, as a member*  
15           *of the United Nations, is expected to abide by the pro-*  
16           *visions of the Universal Declaration of Human*  
17           *Rights.*

18           (6) *The People's Republic of China is a party to*  
19           *numerous international human rights conventions,*  
20           *including the Convention Against Torture and Other*  
21           *Cruel, Inhuman or Degrading Treatment or Punish-*  
22           *ment.*

23           SEC. 9003. CONDUCT OF FOREIGN RELATIONS. (a) RE-  
24           LEASE OF PRISONERS.—*The Secretary of State, in all offi-*  
25           *cial meetings with the Government of the People's Republic*

1 *of China, should request the immediate and unconditional*  
2 *release of Ngodrup Phuntsog and other prisoners of con-*  
3 *science in Tibet, as well as in the People's Republic of*  
4 *China.*

5 (b) *ACCESS TO PRISONS.—The Secretary of State*  
6 *should seek access for international humanitarian organiza-*  
7 *tions to Drapchi prison and other prisons in Tibet, as well*  
8 *as in the People's Republic of China, to ensure that pris-*  
9 *oners are not being mistreated and are receiving necessary*  
10 *medical treatment.*

11 (c) *DIALOGUE ON FUTURE OF TIBET.—The Secretary*  
12 *of State, in all official meetings with the Government of*  
13 *the People's Republic of China, should call on that country*  
14 *to begin serious discussions with the Dalai Lama or his*  
15 *representatives, without preconditions, on the future of*  
16 *Tibet.*

17 *SEC. 9004. AUTHORIZATION OF APPROPRIATIONS FOR*  
18 *ADDITIONAL PERSONNEL AT DIPLOMATIC POSTS TO MON-*  
19 *ITOR HUMAN RIGHTS IN THE PEOPLE'S REPUBLIC OF*  
20 *CHINA. There are authorized to be appropriated to support*  
21 *personnel to monitor political repression in the People's Re-*  
22 *public of China in the United States Embassies in Beijing*  
23 *and Kathmandu, as well as the American consulates in*  
24 *Guangzhou, Shanghai, Shenyang, Chengdu, and Hong*

1 *Kong, \$2,200,000 for fiscal year 1999 and \$2,200,000 for*  
2 *fiscal year 2000.*

3       *SEC. 9005. DEMOCRACY BUILDING IN CHINA. (a) AU-*  
4 *THORIZATION OF APPROPRIATIONS FOR NED.—In addition*  
5 *to such sums as are otherwise authorized to be appropriated*  
6 *for the “National Endowment for Democracy” for fiscal*  
7 *years 1999 and 2000, there are authorized to be appro-*  
8 *priated for the “National Endowment for Democracy”*  
9 *\$4,000,000 for fiscal year 1999 and \$4,000,000 for fiscal*  
10 *year 2000, which shall be available to promote democracy,*  
11 *civil society, and the development of the rule of law in*  
12 *China.*

13       *(b) EAST ASIA-PACIFIC REGIONAL DEMOCRACY*  
14 *FUND.—The Secretary of State shall use funds available in*  
15 *the East Asia-Pacific Regional Democracy Fund to provide*  
16 *grants to nongovernmental organizations to promote democ-*  
17 *racy, civil society, and the development of the rule of law*  
18 *in China.*

19       *SEC. 9006. HUMAN RIGHTS IN CHINA. (a) RE-*  
20 *PORTS.—Not later than March 30, 1999, and each subse-*  
21 *quent year thereafter, the Secretary of State shall submit*  
22 *to the International Relations Committee of the House of*  
23 *Representatives and the Foreign Relations Committee of the*  
24 *Senate an annual report on human rights in China, includ-*  
25 *ing religious persecution, the development of democratic in-*

stitutions, and the rule of law. Reports shall provide information on each region of China.

(b) *PRISONER INFORMATION REGISTRY.*—The Secretary of State shall establish a Prisoner Information Registry for China which shall provide information on all political prisoners, prisoners of conscience, and prisoners of faith in China. Such information shall include the charges, judicial processes, administrative actions, use of forced labor, incidences of torture, length of imprisonment, physical and health conditions, and other matters related to the incarceration of such prisoners in China. The Secretary of State is authorized to make funds available to nongovernmental organizations presently engaged in monitoring activities regarding Chinese political prisoners to assist in the creation and maintenance of the registry.

*SEC. 9007. SENSE OF CONGRESS CONCERNING ESTABLISHMENT OF A COMMISSION ON SECURITY AND COOPERATION IN ASIA.* It is the sense of Congress that Congress, the President, and the Secretary of State should work with the governments of other countries to establish a Commission on Security and Cooperation in Asia which would be modeled after the Commission on Security and Cooperation in Europe.

*SEC. 9008. SENSE OF CONGRESS REGARDING DEMOCRACY IN HONG KONG.* It is the sense of Congress that the



1 *people of Hong Kong should continue to have the right and*  
2 *ability to freely elect their legislative representatives, and*  
3 *that the procedure for the conduct of the elections of the*  
4 *legislature of the Hong Kong Special Administrative Re-*  
5 *gion should be determined by the people of Hong Kong*  
6 *through an election law convention, a referendum, or both.*

7 *SEC. 9009. SENSE OF CONGRESS RELATING TO ORGAN*  
8 *HARVESTING AND TRANSPLANTING IN THE PEOPLE'S RE-*  
9 *PUBLIC OF CHINA. It is the sense of Congress that—*

10 *(1) the Government of the People's Republic of*  
11 *China should stop the practice of harvesting and*  
12 *transplanting organs for profit from prisoners that it*  
13 *executes;*

14 *(2) the Government of the People's Republic of*  
15 *China should be strongly condemned for such organ*  
16 *harvesting and transplanting practice;*

17 *(3) the President should bar from entry into the*  
18 *United States any and all officials of the Government*  
19 *of the People's Republic of China known to be directly*  
20 *involved in such organ harvesting and transplanting*  
21 *practice;*

22 *(4) individuals determined to be participating in*  
23 *or otherwise facilitating the sale of such organs in the*  
24 *United States should be prosecuted to the fullest pos-*  
25 *sible extent of the law; and*

*HUMAN RIGHTS IN CHINA*

8        *SEC. 10001. This subtitle may be cited as the “Forced*  
9 *Abortion Condemnation Act”.*

11                   (1) *Forced abortion was rightly denounced as a*  
12                   *crime against humanity by the Nuremberg War*  
13                   *Crimes Tribunal.*

(2) For over 15 years there have been frequent and credible reports of forced abortion and forced sterilization in connection with the population control policies of the People's Republic of China. These reports indicate the following:

(A) Although it is the stated position of the politburo of the Chinese Communist Party that forced abortion and forced sterilization have no role in the population control program, in fact the Communist Chinese Government encourages both forced abortion and forced sterilization through a combination of strictly enforced birth

1        *quotas and immunity for local population con-*  
2        *trol officials who engage in coercion. Officials ac-*  
3        *knowledge that there have been instances of*  
4        *forced abortions and sterilization, and no evi-*  
5        *dence has been made available to suggest that the*  
6        *perpetrators have been punished.*

7                *(B) People's Republic of China population*  
8        *control officials, in cooperation with employers*  
9        *and works unit officials, routinely monitor wom-*  
10       *en's menstrual cycles and subject women who*  
11       *conceive without government authorization to ex-*  
12       *treme psychological pressure, to harsh economic*  
13       *sanctions, including unpayable fines and loss of*  
14       *employment, and often to physical force.*

15               *(C) Official sanctions for giving birth to*  
16       *unauthorized children include fines in amounts*  
17       *several times larger than the per capita annual*  
18       *incomes of residents of the People's Republic of*  
19       *China. In Fujian, for example, the average fine*  
20       *is estimated to be twice a family's gross annual*  
21       *income. Families which cannot pay the fine may*  
22       *be subject to confiscation and destruction of their*  
23       *homes and personal property.*

24               *(D) Especially harsh punishments have*  
25       *been inflicted on those whose resistance is moti-*

1           vated by religion. For example, according to a  
2           1995 Amnesty International report, the Catholic  
3           inhabitants of 2 villages in Hebei Province were  
4           subjected to population control under the slogan  
5           “better to have more graves than one more  
6           child”. Enforcement measures included torture,  
7           sexual abuse, and the detention of resisters’ rel-  
8           atives as hostages.

9           (E) Forced abortions in Communist China  
10          often have taken place in the very late stages of  
11          pregnancy.

12          (F) Since 1994 forced abortion and steri-  
13          lization have been used in Communist China not  
14          only to regulate the number of children, but also  
15          to eliminate those who are regarded as defective  
16          in accordance with the official eugenic policy  
17          known as the “Natal and Health Care Law”.

18          SEC. 10003. (a) Notwithstanding any other provision  
19          of law, the Secretary of State may not utilize any funds  
20          appropriated or otherwise available for the Department of  
21          State for fiscal year 1999 to issue any visa to any official  
22          of any country (except the head of state, the head of govern-  
23          ment, and cabinet level ministers) who the Secretary finds,  
24          based on credible and specific information, has been directly  
25          involved in the establishment or enforcement of population

1 *control policies forcing a woman to undergo an abortion*  
2 *against her free choice, or forcing a man or woman to un-*  
3 *dergo sterilization against his or her free choice or policies*  
4 *condoning the practice of genital mutilation.*

5 *(b) Notwithstanding any other provision of law, the*  
6 *Attorney General may not utilize any funds appropriated*  
7 *or otherwise available for the Department of Justice for fis-*  
8 *cal year 1999 to admit to the United States any national*  
9 *covered by subsection (a).*

10 *(c) The President may waive the prohibition in sub-*  
11 *section (a) or (b) if the President—*

12 *(1) determines that it is in the national interest*  
13 *of the United States to do so; and*

14 *(2) provides written notification to Congress con-*  
15 *taining a justification for the waiver.*

16 *Subtitle B—Freedom on Religion in China*

17 *SEC. 10011. (a) It is the sense of Congress that the*  
18 *President should make freedom of religion one of the major*  
19 *objectives of United States foreign policy with respect to*  
20 *China.*

21 *(b) As part of this policy, the Department of State*  
22 *should raise in every relevant bilateral and multilateral*  
23 *forum the issue of individuals imprisoned, detained, con-*  
24  *fined, or otherwise harassed by the Chinese Government on*  
25 *religious grounds.*

1       (c) *In its communications with the Chinese Govern-*  
2 *ment, the Department of State should provide specific*  
3 *names of individuals of concern and request a complete and*  
4 *timely response from the Chinese Government regarding the*  
5 *individuals' whereabouts and condition, the charges against*  
6 *them, and sentence imposed.*

7       (d) *The goal of these official communications should*  
8 *be the expeditious release of all religious prisoners in China*  
9 *and Tibet and the end of the Chinese Government's policy*  
10 *and practice of harassing and repressing religious believers.*

11       SEC. 10012. (a) *Notwithstanding any other provision*  
12 *of law, the Secretary of State may not utilize any funds*  
13 *appropriated or otherwise available for the Department of*  
14 *State for fiscal year 1999 to issue a visa to any official*  
15 *of any country (except the head of state, the head of govern-*  
16 *ment, and cabinet level ministers) who the Secretary of*  
17 *State finds, based on credible and specific information, has*  
18 *been directly involved in the establishment or enforcement*  
19 *of policies or practices designed to restrict religious freedom.*

20       (b) *Notwithstanding any other provision of law, the*  
21 *Attorney General may not utilize any funds appropriated*  
22 *or otherwise available for the Department of Justice for fis-*  
23 *cal year 1999 to admit to the United States any national*  
24 *covered by subsection (a).*

1       (c) *The President may waive the prohibition in sub-*  
2 *section (a) or (b) with respect to an individual described*  
3 *in such subsection if the President—*

4           (1) *determines that it is vital to the national in-*  
5 *terest to do so; and*

6           (2) *provides written notification to the appro-*  
7 *priate congressional committees containing a jus-*  
8 *tification for the waiver.*

9       SEC. 10013. *In this subtitle, the term “appropriate*  
10 *congressional committees” means the Committee on Foreign*  
11 *Relations of the Senate and the Committee on International*  
12 *Relations of the House of Representatives.*

13       *This Act may be cited as the “Department of Defense*  
14 *Appropriations Act, 1999”.*
