A BILL

To amend section 1926 of the Public Health Service Act to waive sanctions against a State that provides for drivers'-license-related sanctions for minors who purchase or possess tobacco products for personal consumption.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. WAIVER OF SANCTIONS FOR STATES THAT**
2 **ENACT DRIVER’S-LICENSE-RELATED SANC-**
3 **TIONS FOR MINORS WHO PURCHASE OR POS-**
4 **SESS TOBACCO PRODUCTS FOR PERSONAL**
5 **CONSUMPTION.**

6 (a) IN GENERAL.—Section 1926 of the Public Health
7 Service Act (42 U.S.C. 300x–26) is amended—

8 (1) in subsection (b), by inserting “Subject to
9 subsection (e)—” after “(b) ENFORCEMENT.—”;

10 (2) in subsection (c), by striking “Before mak-
11 ing” and inserting “Subject to subsection (e), before
12 making”, and

13 (3) by adding at the end the following new sub-
14 section:

15 “(e) WAIVER OF REQUIREMENTS AND SANCTIONS IN
16 CASE OF STATE ENACTING DRIVERS’-LICENSE-RELATED
17 SANCTIONS FOR MINORS WHO PURCHASE OR POSSESS
18 TOBACCO PRODUCTS FOR PERSONAL CONSUMPTION.—

19 “(1) IN GENERAL.—The requirements of sub-
20 section (b) and any sanctions under subsection (c)
21 shall not apply to a State for a fiscal year if the
22 State demonstrates to the satisfaction of the Sec-
23 retary that it has in effect (as of the first day of the
24 fiscal year) a law which provides at least the follow-
25 ing sanctions in the case of an individual under 18
26 years of age who purchases (or attempts to pur-

1 chase) or possesses a tobacco product for the pur-
2 pose of personal consumption:

3 “(A) DELAY IN OBTAINING DRIVER’S LI-
4 CENSE.—In the case of such an individual who
5 does not have a general motor vehicle operator’s
6 permit, a delay by at least 2 months in the min-
7 imum qualifying age to obtain such a permit
8 (or, in the case of an individual who has
9 reached such age, such a delay from the date
10 of determination of the offense).

11 “(B) SUSPENSION OF DRIVER’S LICENSE
12 PRIVILEGES.—In the case of such an individual
13 who has such a permit, a suspension of driving
14 privileges under such a permit for a period of
15 at least 2 months.

16 Notwithstanding the previous sentence, a State may
17 provide for a process for granting on a case-by-case
18 basis exceptions to the imposition of such sanctions
19 in circumstances under which the imposition of the
20 sanctions would impose an undue hardship.

21 “(2) CONSTRUCTION.—Paragraph (1) shall not
22 be construed as applying to the purchase or posses-
23 sion by an individual of a product in the course of
24 carrying on a lawful trade or business (such as the

1 lawful production, distribution, or sale of ciga-
2 rettes).”.

3 (b) EFFECTIVE DATE.—The amendments made by
4 subsection (a) shall apply to fiscal years beginning with
5 fiscal year 1999.
