Mr. VENTO introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To authorize the Secretary of Veterans Affairs to conduct Stand Down events and to establish a pilot program that will provide for an annual Stand Down event in each State.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stand Down Author-
5 ization Act”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds that—

1 (1) Stand Down events have proven to be an ef-
2 fective form of outreach and a successful way to pro-
3 vide assistance to veterans who have most often not
4 utilized or availed themselves of other existing serv-
5 ice delivery functions;

6 (2) the Secretary of Veterans Affairs should be
7 fully authorized to provide sufficient assistance to
8 meet the needs of all veterans at Stand Down
9 events;

10 (3) the several branches of the United States
11 Armed Forces and the National Guard, which have
12 provided valuable support and services to establish
13 and maintain the delivery of services to veterans at
14 Stand Down events, should continue to do so to the
15 extent that their various missions, responsibilities,
16 and roles permit; and

17 (4) national and local veterans' organizations,
18 which have also provided valuable support and serv-
19 ices to veterans at Stand Down events and have
20 been instrumental to the success of such events,
21 should be commended and recognized for their out-
22 standing contributions and should be strongly en-
23 couraged to continue to provide volunteers and re-
24 sources at such events.

1 **SEC. 3. STAND DOWN EVENTS.**

2 Subchapter VII of chapter 17 of title 38, United
3 States Code, is amended by adding at the end the follow-
4 ing new section:

5 **“§ 1775. Stand Down events**

6 “(a) The Secretary may (directly or in conjunction
7 with a governmental or other entity)—

8 “(1) carry out Stand Down events; and

9 “(2) in connection with any Stand Down event,
10 whether carried out under paragraph (1) or other-
11 wise—

12 “(A) provide outreach services;

13 “(B) use or provide any personal property
14 of the Department of Veterans Affairs that the
15 Secretary determines is not otherwise reason-
16 ably needed by the Department of Veterans Af-
17 fairs; and

18 “(C) provide any other benefit or service of
19 the Department of Veterans Affairs that the
20 Secretary considers appropriate.

21 “(b) For purposes of this section, the term ‘Stand
22 Down event’ means an event to provide veterans who are
23 without a home, unemployed, experiencing health or social
24 adjustment challenges, or otherwise in need of assistance,
25 with 1 to 3 days of safety and security, access to assist-
26 ance such as food, shelter, clothing, benefits certification,

1 and health care, and any other form of assistance that
 2 the Secretary considers appropriate.

3 “(c) The Secretary shall establish and implement a
 4 pilot program under which the Secretary shall carry out
 5 (directly or in conjunction with a governmental or other
 6 entity) a single Stand Down event in each State in each
 7 calendar year, beginning in 1999.

8 “(d) Not later than February 1 of each year, the Sec-
 9 retary shall submit to the Senate and House of Represent-
 10 atives a report containing—

11 “(1) for the preceding year, a description of the
 12 implementation of the pilot program established
 13 under subsection (c);

14 “(2) the Secretary’s recommendations, if any,
 15 for legislation regarding the pilot program; and

16 “(3) any other matter that the Secretary con-
 17 siders appropriate.”.

18 **SEC. 4. CLERICAL AMENDMENT.**

19 The table of sections at the beginning of chapter 17
 20 of title 38, United States Code, is amended by adding
 21 after the item relating to section 1774 the following new
 22 item:

“1775. Stand Down events.”.
