A BILL

To ensure effective rail competition and maintain reasonable rates in the absence of effective competition.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Rail Service Improve-
- 5 ment Act of 1998".
- 6 SEC. 2. OFFERS OF FINANCIAL ASSISTANCE TO AVOID
- 7 ABANDONMENT AND DISCONTINUANCE.
- 8 Section 10904 of title 49, United States Code, is
- 9 amended—

1	(1) in subsection (e), by striking "4 months"
2	and inserting "16 months"; and
3	(2) in subsections (d)(1) and (f)(3), by striking
4	"4-month" each place it appears and inserting "16-
5	month".
6	SEC. 3. RATE CASE PROCEDURES.
7	Not later than 1 year after the date of the enactment
8	of this Act, the Surface Transportation Board shall—
9	(1) identify, and to the extent practicable imple-
10	ment, improvements to its procedures for deciding
11	whether a rate, classification, rule, or order of a rail
12	carrier is in violation of part A of subtitle IV of title
13	49, United States Code, that will result in a more
14	expeditious resolution of issues and a less expensive
15	process for parties initiating a complaint; and
16	(2) transmit to the Congress a report includ-
17	ing—
18	(A) a description of actions taken under
19	paragraph (1);
20	(B) a description of further actions of the
21	same nature anticipated but not yet taken; and
22	(C) recommendations for any changes in
23	law required to make further improvements de-
24	scribed in paragraph (1).

1	SEC. 4. CLARIFICATION OF RAIL TRANSPORTATION POL-
2	ICY.
3	Section 10101 of title 49, United States Code, is
4	amended—
5	(1) by inserting "(a) In General.—" before
6	"In regulating"; and
7	(2) by adding at the end the following:
8	"(b) Primary Objectives.—The primary objectives
9	of the rail transportation policy of the United States shall
10	be—
11	"(1) to ensure effective competition among rail
12	carriers at origin and destination;
13	"(2) to maintain reasonable rates in the ab-
14	sence of effective competition; and
15	"(3) to ensure the continued health and viabil-
16	ity of the railroad industry.".
17	SEC. 5. APPROVAL OF ABANDONMENT OR DISCONTINU-
18	ANCE.
19	Section 10903(e)(1)(B) of title 49, United States
20	Code, is amended by inserting "or are important to pro-
21	tect the potential for later revival of the railroad line as
22	an economically viable railroad line" after "convenience
23	and necessity".
