A BILL

- To provide grants to certain local educational agencies to provide integrated classroom-related computer training for elementary and secondary school teachers.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Teacher Training

5 Technology Act".

6 SEC. 2. FINDINGS.

- 7 Congress finds the following:
- 8 (1) Between 1994 and 2005, more than a 9 1,000,000 new computer scientists and engineers,

1	system analysts, and computer programmers will be
2	required in the United States.
3	(2) Today's elementary and secondary school
4	students need effective computer training in schools
5	so that they can effectively compete in tomorrow's
6	job market.
7	(3) More schools are using computers than ever
8	before creating a greater need for teachers to utilize
9	computer equipment effectively in a classroom set-
10	ting.
11	(4) In just 3 years, the percentage of public
12	schools with Internet access increased from 35 per-
13	cent in the fall of 1994 to 78 percent in the fall of
14	1997, with 98 percent of all schools owning comput-
15	ers.
16	(5) The need for teachers who have knowledge
17	and mastery of computer skills in the classroom is
18	great.
19	(6) States that have the fastest population
20	growth and lead the Nation in projected student en-
21	rollment will need increased funding to serve the
22	computer and technology needs of their rapidly
23	growing student populations.

1 SEC. 3. PROGRAM AUTHORIZED.

2 (a) IN GENERAL.—The Secretary of Education,
3 through the Office of Educational Technology, is author4 ized to award grants to local educational agencies identi5 fied under subsection (b) to provide classroom-related
6 computer training to credentialed teachers.

7 (b) GRANT AWARD SELECTION.—The Secretary of 8 Education may award grants to local educational agencies 9 located in the States, identified by the Department of 10 Education in the Baby Boom Echo Report (current at the time grants are made), which are projected to have an in-11 12 crease in student enrollment of not less than 20,000 in 13 public elementary and secondary schools during the next 14 ten years.

15 (c) DURATION.—A grant made under this Act may16 be awarded for a period not to exceed 3 years.

17 SEC. 4. GRANT AWARD.

18 (a) ELIGIBILITY.—To be eligible to receive a grant 19 award under this Act, a local educational agency located 20in one of the States identified in section 3(b) shall submit 21 an application to the Secretary of Education at such time 22 and in such form as the Secretary may require. Such ap-23 plication shall include a certification that the agency has 24 developed a progression of computer training for teachers 25 that begins with basic classroom-related computer training

and progresses through to a superior level of proficiency
 throughout the agency.

3 (b) PRIORITY.—The Secretary of Education shall provide not less than one grant in each State identified 4 5 in section 3(b) to an eligible local educational agency in such State that meets the qualifications established by the 6 7 Secretary of Education. The Secretary may award grants 8 to additional eligible local educational agencies in such 9 States based on the quality of the application submitted 10 and the enrollment levels in public elementary and second-11 ary schools located in such agencies.

(c) GRANT AMOUNT.—Each grant award made under
this Act shall be of sufficient size to carry out the goals
of this Act, but shall not exceed \$500,000.

15 SEC. 5. USES OF FUNDS.

16 A local educational agency that receives a grant 17 award under this Act may use such funds received to pro-18 vide training by local educational agency personnel on 19 school premises.

20 SEC. 6. EVALUATION.

(a) IN GENERAL.—Not later than one year after
grant awards are made, the Secretary of Education shall
evaluate computer training programs for teachers developed by local educational agencies in accordance with this
Act.

(b) DISSEMINATION OF RESULTS.—The Secretary of
 Education shall collect such information and make avail able evaluation results to the public upon request.

4 (c) ADMINISTRATIVE COSTS.—The Secretary of Edu5 cation may use not more than 2 percent of the total
6 amount appropriated in the first year to carry out this
7 Act to conduct evaluations pursuant to subsection (a).

8 SEC. 7. AUTHORIZATION OF APPROPRIATIONS.

9 There are authorized to be appropriated to carry out 10 this Act \$10,000,000 for fiscal year 2000 and such sums 11 as may be necessary for each of fiscal years 2001 and 12 2002.
