## A BILL

To amend chapter 84 of title 5, United States Code, to provide that annuities for Members of Congress be computed under the same formula as applies to Federal employees generally, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. COMPUTATION OF ANNUITY.**

4 Section 8415 of title 5, United States Code, is  
5 amended—

1 (1) in subsection (a) by inserting “or Member”  
2 after “employee”; and

3 (2) by repealing subsection (b).

4 **SEC. 2. CONTRIBUTIONS.**

5 (a) DEDUCTIONS FROM PAY.—Section 8422(a)(2) of  
6 title 5, United States Code, is amended—

7 (1) in subparagraph (A) by inserting “or Mem-  
8 ber” after “employee”); and

9 (2) in subparagraph (B) by striking “Mem-  
10 ber,”.

11 (b) GOVERNMENT CONTRIBUTIONS.—Section  
12 8423(a)(1) of title 5, United States Code, is amended—

13 (1) in subparagraph (A)(i) by striking “sub-  
14 paragraph (B)),” and inserting “subparagraph (B))  
15 and Members,”;

16 (2) in subparagraph (A)(ii) by inserting “and  
17 Members” before “(under”;

18 (3) in subparagraph (B)(i) by striking “Mem-  
19 bers,”; and

20 (4) in subparagraph (B)(ii) by striking “and  
21 Members”.

22 **SEC. 3. EFFECTIVE DATE; SAVINGS PROVISION.**

23 (a) EFFECTIVE DATE.—This Act—

24 (1) shall take effect on the first day of the first  
25 applicable pay period beginning after the end of the

1 12-month period beginning on the date of the enact-  
2 ment of this Act; and

3 (2) shall apply with respect to any individual  
4 who first serves as a Member of Congress in the One  
5 Hundred Third Congress or later.

6 (b) SAVINGS PROVISION.—The annuity—

7 (1) of a Member of Congress described in sub-  
8 section (a)(2), to the extent based on service per-  
9 formed before the effective date of this Act, and

10 (2) of any other Member of Congress, whether  
11 based on service performed before, on, or after the  
12 effective date of this Act,

13 shall be computed as if this Act had never been enacted.
