Mr. DIAZ-BALART, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for consideration of the bill (H.R. 2159) making appropriations for foreign operations, export financing, and related programs for the fiscal year ending September 30, 1998, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2159) making appropriations for

1 foreign operations, export financing, and related programs  
2 for the fiscal year ending September 30, 1998, and for  
3 other purposes. The first reading of the bill shall be dis-  
4 pensed with. Points of order against consideration of the  
5 bill for failure to comply with clause 2(1)(6) of rule XI  
6 or clause 7 of rule XXI are waived. General debate shall  
7 be confined to the bill and shall not exceed one hour equal-  
8 ly divided and controlled by the chairman and ranking mi-  
9 nority member of the Committee on Appropriations. After  
10 general debate the bill shall be considered for amendment  
11 under the five-minute rule. Points of order against provi-  
12 sions in the bill for failure to comply with clause 2 or 6  
13 of rule XXI are waived except as follows: beginning with  
14 “: *Provided*” on page 24, line 8, through “justice” on line  
15 16. Where points of order are waived against part of a  
16 paragraph, points or order against a provision in another  
17 part of such paragraph may be made only against such  
18 provision and not against the entire paragraph. The  
19 amendments printed in the report of the Committee on  
20 Rules accompanying this resolution may be offered only  
21 by a Member designated in the report and only at the ap-  
22 propriate point in the reading of the bill, shall be consid-  
23 ered as read, shall be debatable for the time specified in  
24 the report equally divided and controlled by the proponent  
25 and an opponent, shall not be subject to amendment ex-

1 cept as specified in the report, and shall not be subject  
2 to a demand for division of the question in the House or  
3 in the Committee of the Whole. All points of order against  
4 the amendments printed in the report are waived. No  
5 other amendment shall be in order unless printed in the  
6 portion of the Congressional Record designated for that  
7 purpose in clause 6 of rule XXIII. The Chairman of the  
8 Committee of the Whole may: (1) postpone until a time  
9 during further consideration in the Committee of the  
10 Whole a request for a recorded vote on any amendment;  
11 and (2) reduce to five minutes the minimum time for elec-  
12 tronic voting on any postponed question that follows an-  
13 other electronic vote without intervening business, pro-  
14 vided that the minimum time for electronic voting on the  
15 first in any series of questions shall be fifteen minutes.  
16 At the conclusion of consideration of the bill for amend-  
17 ment the Committee shall rise and report the bill to the  
18 House with such amendments as may have been adopted.  
19 The previous question shall be considered as ordered on  
20 the bill and amendments thereto to final passage without  
21 intervening motion except one motion to recommit with  
22 or without instructions.
