## RESOLUTION

Expressing the sense of the House of Representatives regarding strengthening the Social Security system to meet the challenges of the next century.

Whereas the Board of Trustees of the Federal Old-Age and Survivors Insurance Trust Fund and the Federal Disability Insurance Trust Fund estimates that the Trust

Funds will be solvent for the next 34 years but may experience shortfalls thereafter;

Whereas the Board of Trustees believes that there is ample time to discuss and examine alternative solutions with deliberation and care;

Whereas the Board of Trustees believes that the long-range balance of the Trust Funds could be restored within the framework of the present Social Security structure; and

Whereas the Social Security system provides benefits to all Americans at every stage of their lives, whether or not they themselves receive Social Security checks: Now, therefore, be it

1       *Resolved*, That it is the sense of the House of Rep-  
2 representatives—

3           (1) that the Congress must assure that the fun-  
4       damental protections that Social Security provides  
5       for American families are available for generations  
6       to come;

7           (2) that the problems facing the Social Security  
8       system are manageable, and can be prudently ad-  
9       dressed by making careful and modest changes;

10          (3) that hastily conceived and radical solutions,  
11       such as utilizing Social Security system resources to  
12       fund individual accounts, require significant reduc-  
13       tions in guaranteed benefits, are not necessary to as-  
14       sure the financial solvency of the system, and should  
15       be rejected;

1           (4) that solutions to a projected shortfall should  
2           be enacted within the existing Social Security struc-  
3           ture, without compromising the guaranteed nature  
4           of benefits to individuals and families under the So-  
5           cial Security system; and

6           (5) that any solutions adopted by the Congress  
7           must be nondiscriminatory and equitable to Ameri-  
8           cans of all ages and must, in the original spirit of  
9           Social Security, help insure American workers and  
10          their families against the economic risks associated  
11          with disability, the death of a parent or spouse, and  
12          retirement.
