 - 4 This Act may be cited as the "Aviation Insurance Re-

1 SEC. 2. VALUATION OF AIRCRAFT.

- 7 the commercial aviation insurance industry.".
- 8 (b) Limitation on Maximum Insured Amount.—
- 9 Section 44306(c) of title 49, United States Code, is
- 10 amended by striking "as determined by the Secretary."
- 11 and inserting "as determined by the Secretary in accord-
- 12 ance with reasonable business practices in the commercial
- 13 aviation insurance industry.".

14 SEC. 3. EFFECT OF INDEMNITY AGREEMENTS.

- Section 44305(b) of title 49, United States Code, is
- 16 amended by adding at the end the following: "If such an
- 17 agreement is countersigned by the President or the Presi-
- 18 dent's designee, the agreement shall constitute, for pur-
- 19 poses of section 44302(b), a determination that continu-
- 20 ation of the aircraft operations to which the agreement
- 21 applies is necessary to carry out the foreign policy of the
- 22 United States.".

- 24 (a) Authorization of Binding Arbitration.—

- 3 be agreed to by the Secretary and any commercial insurer
- 4 that may be responsible for any part of a loss to which
- 5 such policy relates.".
- 6 (b) AUTHORITY TO PAY ARBITRATION AWARD.—Sec-
- 7 tion 44308(b)(2) of such title is amended—
- 8 (1) by striking "and" at the end of subpara-

- 10 (2) by redesignating subparagraph (B) as sub-
- 11 paragraph (C); and
- 12 (3) by inserting after subparagraph (A) the fol-
- lowing:
- 14 "(B) pay the amount of a binding arbitra-
- tion award made under paragraph (1); and".
- 16 SEC. 5. EXTENSION OF PROGRAM.
- 17 (a) In General.—Section 44310 of title 49, United
- 18 States Code, is amended by striking "September 30,
- 19 2002" and inserting "December 31, 1998".
- 20 (b) Effective Date.—The amendment made by
- 21 subsection (a) takes effect on October 1, 1997.
