# A BILL

To amend the John F. Kennedy Center Act to authorize appropriations for the John F. Kennedy Center for the Performing Arts and to further define the criteria for capital repair and operation and maintenance.

#### SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "John F. Kennedy Cen-
- 3 ter for the Performing Arts Authorization Act".
- 4 SEC. 2. CAPITAL REPAIR DUTIES.
- 5 Section 4(a)(1)(G) of the John F. Kennedy Center
- 6 Act (20 U.S.C. 76j(a)(1)(G)) is amended to read as fol-
- 7 lows:
- 8 "(G) with respect to the building and site

4	Subsections (a) and (b) of section 12 of the John F.

8	There are authorized to be appropriated to the Board to
9	earry out section 4(a)(1)(H) \$13,000,000 for fiscal year
10	1999, \$14,000,000 for each of fiscal years 2000 and 2001
11	\$15,000,000 for each of fiscal years 2002 and 2003
12	\$16,000,000 for each of fiscal years 2004 and 2005
13	\$17,000,000 for each of fiscal years 2006 and 2007, and
14	\$18,000,000 for each of fiscal years 2008 and 2009.
15	"(b) Capital Projects.—There are authorized to
16	be appropriated to the Board to carry out subparagraphs
17	(F) and (G) of section $4(a)(1)$ \$20,000,000 for each of
18	fiscal years 1999, 2000, and 2001, \$19,000,000 for fiscal

23	security, and other services and equipment
24	necessary for the operations of, the building

1 quirements for high quality operations; 2 and". SEC. 4. AUDIT REQUIREMENT. 4 Section 6 of the John F. Kennedy Center Act (20) U.S.C. 76l) is amended— 6 (1) by striking subsection (d); and 7 (2) by redesignating subsections (e) and (f) as 8 subsections (d) and (e), respectively. SEC. 5. AUTHORIZATION OF APPROPRIATIONS. 10 Subsections (a) and (b) of section 12 of the John F. Kennedy Center Act (20 U.S.C. 76r) are amended to read as follows: 12 13 "(a) Maintenance, Repair, and Security.—There are authorized to be appropriated to the Board to carry 14 15 out section 4(a)(1)(H) \$13,000,000 for fiscal year 1999, \$14,000,000 for each of fiscal years 2000 and 2001, and 16 17 \$15,000,000 for each of fiscal years 2002 and 2003. 18 "(b) Capital Projects.—There are authorized to be appropriated to the Board to carry out subparagraphs (F) and (G) of section 4(a)(1) \$20,000,000 for each of fiscal 21 years 1999, 2000, and 2001, \$19,000,000 for fiscal year

22 2002, and \$17,000,000 for fiscal year 2003.".
