AN ACT

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the design, planning, and construction of the Willow Lake Natural Treatment System Project for the reclamation and reuse of water, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION. 1. WILLOW LAKE NATURAL TREATMENT SYSTEM**
2 **PROJECT.**

3 (a) IN GENERAL.—The Reclamation Wastewater and
4 Groundwater Study and Facilities Act (43 U.S.C. 390h
5 et seq.) is amended—

6 (1) by redesignating sections 1631, 1632, and
7 1633 as sections 1632, 1633, and 1634, respectively;
8 and

9 (2) by inserting after section 1630 the following
10 new section 1631:

11 **“SEC. 1631. WILLOW LAKE NATURAL TREATMENT SYSTEM**
12 **PROJECT.**

13 “(a) AUTHORIZATION.—The Secretary, in coopera-
14 tion with the City of Salem, Oregon, is authorized to par-
15 ticipate in the design, planning, and construction of the
16 Willow Lake Natural Treatment System Project to re-
17 claim and reuse wastewater within and without the service
18 area of the City of Salem.

19 “(b) COST SHARE.—The Federal share of the cost
20 of a project described in subsection (a) shall not exceed
21 25 percent of the total cost.

22 “(c) LIMITATION.—The Secretary shall not provide
23 funds for the operation and maintenance of a project de-
24 scribed in subsection (a).”.

25 (b) CONFORMING AMENDMENTS.—That Act is fur-
26 ther amended—

1 (1) in section 1632 (43 U.S.C. 390h–13) (as
2 redesignated by subsection (a)(1)), by striking “sec-
3 tion 1630” and inserting “section 1631”;

4 (2) in section 1633(c) (43 U.S.C. 390h–14) (as
5 so redesignated), by striking “section 1633” and in-
6 serting “section 1634”; and

7 (3) in section 1634 (43 U.S.C. 390h–15) (as so
8 redesignated), by striking “section 1632” and insert-
9 ing “section 1633”.

10 (c) CLERICAL AMENDMENT.—The table of contents
11 in section 2 of the Reclamation Projects Authorization and
12 Adjustment Act of 1992 is amended by striking the items
13 relating to sections 1631 through 1633 and inserting the
14 following:

“Sec. 1631. Willow Lake Natural Treatment System Project.

“Sec. 1632. Authorization of appropriations.

“Sec. 1633. Groundwater study.

“Sec. 1634. Authorization of appropriations.”.
