A BILL

To make the Occupational Safety and Health Act of 1970 applicable to the United States Postal Service in the same manner as any other employer.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Postal Employees
- 5 Safety Enhancement Act".

1 SEC. 2. APPLICATION OF ACT.

- 2 (a) Definition.—Section 3(5) of the Occupational
- 3 Safety and Health Act of 1970 (29 U.S.C. 652(5)) is
- 4 amended by inserting after "the United States" the fol-
- 5 lowing: "(not including the United States Postal Serv-
- 6 ice)".
- 7 (b) Federal Programs.—
- 8 (1) Occupational safety and health.—
- 9 Section 19(a) of the Occupational Safety and Health
- 10 Act of 1970 (29 U.S.C. 668(a)) is amended by in-
- serting after "each Federal Agency" the following:
- "(not including the United States Postal Service)".
- 13 (2) OTHER SAFETY PROGRAMS.—Section
- 14 7902(a)(2) of title 5, United States Code, is amend-
- ed by inserting after "Government of the United
- 16 States" the following: "(not including the United
- 17 States Postal Service)".
- 18 SEC. 3. CLOSING OR CONSOLIDATION OF OFFICES NOT
- 19 BASED ON OSHA COMPLIANCE.
- Section 404(b)(2) of title 39, United States Code, is
- 21 amended to read as follows:
- 22 "(2) The Postal Service, in making a determination
- 23 whether or not to close or consolidate a post office—
- 24 "(A) shall consider—

1	"(i) the effect of such closing or consolida-
2	tion on the community served by such post of-
3	fice;
4	"(ii) the effect of such closing or consolida-
5	tion on employees of the Postal Service em-
6	ployed at such office;
7	"(iii) whether such closing or consolidation
8	is consistent with the policy of the Government,
9	as stated in section 101(b) of this title, that the
10	Postal Service shall provide a maximum degree
11	of effective and regular postal services to rural
12	areas, communities, and small towns where post
13	offices are not self-sustaining;
14	"(iv) the economic savings to the Postal
15	Service resulting from such closing or consolida-
16	tion; and
17	"(v) such other factors as the Postal Serv-
18	ice determines are necessary; and
19	"(B) may not consider compliance with any
20	provision of the Occupational Safety and Health Act
21	of 1970 (29 U.S.C. 651 et seq.).".

1 SEC. 4. PROHIBITION ON RESTRICTION OR ELIMINATION

- 2 **OF SERVICES.**
- 3 (a) In General.—Chapter 4 of title 39, United
- 4 States Code, is amended by adding after section 414 the
- 5 following:

6 "§ 415. Prohibition on restriction or elimination of

- 7 services
- 8 "The Postal Service may not restrict, eliminate, or
- 9 adversely affect any service provided by the Postal Service
- 10 as a result of the payment of any penalty imposed under
- 11 the Occupational Safety and Health Act of 1970 (29
- 12 U.S.C. 651 et seq.).".
- 13 (b) Technical and Conforming Amendment.—
- 14 The table of sections for chapter 4 of title 39, United
- 15 States Code, is amended by adding at the end the follow-
- 16 ing:

"415. Prohibition on restriction or elimination of services.".

17 SEC. 5. LIMITATIONS ON RAISE IN RATES.

- 18 Section 3622 of title 39, United States Code, is
- 19 amended by adding at the end the following:
- 20 "(c) Compliance with any provision of the Occupa-
- 21 tional Safety and Health Act of 1970 (29 U.S.C. 651 et
- 22 seq.) shall not be considered by the Commission in deter-
- 23 mining whether to increase rates and shall not otherwise
- 24 affect the service of the Postal Service.".
