### **3** SECTION 1. DENVER WATER REUSE PROJECT.

- 4 (a) IN GENERAL.—The Reclamation Projects Au-
- 5 thorization and Adjustment Act of 1992 (43 U.S.C. 390h
- 6 et seq.) is amended—

1(1) by redesignating sections 1631, 1632, and21633 (42 U.S.C. 390h-13, 390h-14, 390h-15) as3sections 1632, 1633, and 1634, respectively; and

4 (2) by inserting after section 1630 (43 U.S.C.
5 390h-12p) the following:

#### 6 "SEC. 1631. DENVER WATER REUSE PROJECT.

7 "(a) AUTHORIZATION.—The Secretary, in coopera8 tion with the appropriate State and local authorities, may
9 participate in the design, planning, and construction of the
10 Denver Water Reuse project to reclaim and reuse water
11 in the service area of the Denver Water Department of
12 the city and county of Denver, Colorado.

13 "(b) COST SHARE.—The Federal share of the cost
14 of the project described in subsection (a) shall not exceed
15 25 percent of the total cost.

16 "(c) LIMITATION.—The Secretary shall not provide
17 funds for the operation or maintenance of the project de18 scribed in subsection (a).".
