Mr. Johnson (for himself and Mr. Daschle) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To establish the Minuteman Missile National Historic Site in the State of South Dakota, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Minuteman Missile Na-
- 5 tional Historic Site Act of 1998".
- 6 SEC. 2. FINDINGS AND PURPOSES.
- 7 (a) FINDINGS.—Congress finds that—
- 8 (1) the Minuteman II intercontinental ballistic
- 9 missile launch control facility and launch facility
- 10 known as Delta 1 and Delta 9, respectively, have na-

1	tional significance as the best preserved examples of
2	the operational character of American history during
3	the Cold War;
4	(2) the facilities are symbolic of the dedication
5	and preparedness exhibited by the missileers of the
6	Air Force stationed throughout the upper Great
7	Plains in remote and forbidding locations during the
8	Cold War;
9	(3) the facilities provide a unique opportunity
10	to illustrate the history and significance of the Cold
11	War, the arms race, and ICBM development; and
12	(4) the National Park System does not contain
13	a unit that specifically commemorates or interprets
14	the Cold War.
15	(b) Purposes.—The purposes of this Act are—
16	(1) to preserve, protect, and interpret for the
17	benefit and enjoyment of present and future genera-
18	tions the physical structures associated with the
19	Minuteman II missile defense system;
20	(2) to interpret—
21	(A) the historical role of the Minuteman II
22	missile defense system in the broader context of
23	the Cold War; and

1	(B) the role of the system as a key compo-
2	nent of America's strategic commitment to pre-
3	serve world peace; and
4	(3) to complement the interpretive programs re-
5	lating to the Minuteman II missile defense system
6	offered by the South Dakota Air and Space Museum
7	at Ellsworth Air Force Base.
8	SEC. 3. DEFINITIONS.
9	In this Act:
10	(1) Historic site.—The term "historic site"
11	means the Minuteman Missile National Historic Site
12	established by section 4.
13	(2) ICBM.—The term "ICBM" means inter-
14	continental ballistic missile.
15	(3) Secretary.—The term "Secretary" means
16	the Secretary of the Interior.
17	SEC. 4. MINUTEMAN MISSILE NATIONAL HISTORIC SITE.
18	(a) In General.—There is established in Pen-
19	nington and Jackson Counties, South Dakota, a historic
20	site to be known as the "Minuteman Missile National His-
21	toric Site".
22	(b) Boundaries.—The historic site shall comprise—
23	(1) an area surrounding the Minuteman II
24	ICBM launch control facility known as Delta 1;

1	(2) an area surrounding the Minuteman II
2	ICBM launch facility known as Delta 9; and
3	(3) an area outside the areas described in para-
4	graphs (1) and (2) suitable for construction of an
5	administrative support facility.
6	(e) Acquisition of Land.—Within the boundaries
7	of the historic site as determined by the Secretary, the
8	Secretary may acquire land and interests in land by dona-
9	tion, exchange, or transfer from any other Federal agency.
10	SEC. 5. ADMINISTRATION OF HISTORIC SITE.
11	(a) In General.—The historic site shall be adminis-
12	tered by the Secretary in accordance with this Act and
13	the laws generally applicable to units of the National Park
14	System, including—
15	(1) the Act entitled "An Act to establish a Na-
16	tional Park Service, and for other purposes", ap-
17	proved August 25, 1916 (16 U.S.C. 1 et seq.); and
18	(2) the Act entitled "An Act to provide for the
19	preservation of historic American sites, buildings,
20	objects, and antiquities of national significance, and
21	for other purposes", approved August 21, 1935 (16
22	U.S.C. 461 et seq.).
23	(b) Cooperative Agreements.—The Secretary
24	may consult and enter into cooperative agreements with
25	interested entities (including institutions) and individuals

- 1 to provide for the preservation, development, interpreta-
- 2 tion, and use of the historic site.
- 3 (c) General Management Plan.—
- (1) Submission to congress.—Not later than 5 the last day of the second fiscal year beginning after 6 the date of enactment of this Act, the Secretary 7 shall submit to the Committee on Resources of the 8 House of Representatives and the Committee on En-9 ergy and Natural Resources of the Senate a general 10 management plan for the historic site, including a 11 description of the boundaries necessary to protect in-12 tegral historic views and landscapes and to provide
 - (2) Implementation.—The Secretary shall implement the plan as soon as practicable after the date of submission under paragraph (1).

for administrative support and public use facilities.

- 18 (a) Authorization of Appropriations.—In addi-
- 19 tion to amounts made available under subsection (b), there
- 20 are authorized to be appropriated such sums as are nec-
- 21 essary to operate and maintain the historic site.
- (b) AIR FORCE FUNDS.—The Secretary of the Air
- 23 Force shall transfer to the Director of the National Park
- 24 Service for use in operating and maintaining the historic
- 25 site any funds specifically appropriated for the Air Force

- 1 for the maintenance, protection, or preservation of the fa-
- 2 cilities described in paragraphs (1) and (2) of section 4(b).
- 3 (c) Legacy Resource Management Program.—
- 4 Nothing in this Act affects the use of any funds available
- 5 for the Legacy Resource Management Program being car-
- 6 ried out by the Air Force that were directed, before the
- 7 date of enactment of this Act, to be used for resource pres-
- 8 ervation and treaty compliance.
