 - 3 SECTION 1. TRUCKEE WATERSHED RECLAMATION
 - 4 PROJECT.
 - 5 (a) IN GENERAL.—The Reclamation Wastewater and
 - 6 Groundwater Study and Facilities Act (43 U.S.C. 390h
 - 7 et seq.) is amended—

1	(1) by redesignating sections 1631, 1632, and
2	1633 as sections 1632, 1633, and 1634, respectively;
3	and
4	(2) by inserting after section 1630 the follow-
5	ing:
6	"SEC. 1631. TRUCKEE WATERSHED RECLAMATION
7	PROJECT.
8	"(a) Authorization.—The Secretary, in coopera-
9	tion with Washoe County, Nevada, is authorized to partici-
10	pate in the design, planning, and construction of the
11	Truckee Watershed Reclamation Project to reclaim and
12	reuse wastewater (including degraded ground water) with-
13	in and without the service area of Washoe County, Ne-
14	vada.
15	"(b) Cost Share.—The Federal share of the cost
16	of the project described in subsection (a) shall not exceed
17	25 percent of the total cost.
18	"(c) Limitation.—The Secretary shall not provide
19	funds for the operation and maintenance of the project
20	described in subsection (a).".
21	(b) Conforming Amendments.—
22	(1) The Reclamation Wastewater and Ground-
23	water Study and Facilities Act is amended—
24	(A) in section 1632 (43 U.S.C. 390h–13)
25	(as redesignated by subsection (a)(1)), by strik-

1	ing "section 1630" and inserting "section
2	1631";
3	(B) in section 1633(c) (43 U.S.C. 390h-
4	14) (as redesignated by subsection (a)(1)), by
5	striking "section 1633" and inserting "section
6	1634"; and
7	(C) in section 1634 (43 U.S.C. 390h–15)
8	(as redesignated by subsection (a)(1)), by strik-
9	ing "section 1632" and inserting "section
10	1633".
11	(2) The table of contents in section 2 of the
12	Reclamation Projects Authorization and Adjustment
13	Act of 1992 is amended by striking the items relat-
14	ing to sections 1631 through 1633 and inserting the
15	following:
