A BILL

To amend the Act entitled “An Act to provide for the creation of the Morristown National Historical Park in the State of New Jersey, and for other purposes” to authorize the acquisition of property known as the “Warren Property”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ACQUISITION OF WARREN PROPERTY FOR**
2 **MORRISTOWN NATIONAL HISTORICAL PARK.**

3 The Act entitled “An Act to provide for the creation
4 of the Morristown National Historical Park in the State
5 of New Jersey, and for other purposes”, approved March
6 2, 1933 (16 U.S.C. 409 et seq.), is amended by adding
7 at the end the following:

8 **“SEC. 8. ACQUISITION OF WARREN PROPERTY FOR MOR-**
9 **RISTOWN NATIONAL HISTORICAL PARK.**

10 “(a) IN GENERAL.—In addition to any other land or
11 interest authorized to be acquired for inclusion in the Mor-
12 ristown National Historical Park, and notwithstanding the
13 first proviso of the first section of this Act, the Secretary
14 of the Interior may acquire by purchase, donation, or
15 other means not to exceed 15 acres of land and interests
16 in land comprising the property known as the ‘Warren
17 Property’ or ‘Mount Kemble’.

18 “(b) AUTHORIZED EXPENDITURE.—The Secretary
19 may expend such sums as are necessary for the acquisi-
20 tion.

21 “(c) ADMINISTRATION.—Any land or interest ac-
22 quired under this section shall be included in and adminis-
23 tered as part of the Morristown National Historical
24 Park.”
