A BILL

To authorize the Secretary of Agriculture to pay employees of the Food Safety and Inspection Service working in establishments subject to the Federal Meat Inspection Act and the Poultry Products Inspection Act for overtime and holiday work performed by the employees.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Federal Meat and
- 5 Poultry Employees Pay Act of 1998".

SEC. 2. OVERTIME AND HOLIDAY PAY.

- 2 (a) In General.—The Secretary of Agriculture
- 3 may—
- 4 (1) pay employees of the Department of Agri-
- 5 culture employed in an establishment subject to the
- 6 Federal Meat Inspection Act (21 U.S.C. 601 et seq.)
- 7 or the Poultry Products Inspection Act (21 U.S.C.
- 8 451 et seq.) for all overtime and holiday work per-
- 9 formed at the establishment at rates determined by
- the Secretary, subject to applicable law relating to
- 11 minimum wages and maximum hours; and
- 12 (2) accept from the establishment reimburse-
- ment for any sums paid by the Secretary for the
- overtime and holiday work, at rates determined
- under paragraph (1).
- 16 (b) AVAILABILITY.—Sums received by the Secretary
- 17 under this section shall remain available until expended
- 18 without further appropriation and without fiscal year limi-
- 19 tation, to carry out this section.

20 SEC. 3. CONFORMING AMENDMENTS.

- 21 (a) Section 25 of the Poultry Products Inspection Act
- 22 (21 U.S.C. 468) is amended by striking "except that the
- 23 cost" and all that follows and inserting "except the cost
- 24 of overtime and holiday pay paid pursuant to the Federal
- 25 Meat and Poultry Employees Pay Act of 1998.".

- 2 amended by striking "overtime" and all that follows and
- 3 inserting "overtime and holiday pay paid pursuant to the
- 4 Federal Meat and Poultry Employees Pay Act of 1998.".
- 5 (c) The matter under the heading "BUREAU OF ANI-
- 6 MAL INDUSTRY" of the Act of July 24, 1919, is amended
- 7 by striking the next to the last paragraph (7 U.S.C. 394).
- 8 (d) Section 5549 of title 5, United States Code is
- 9 amended by striking paragraph (1) and inserting the fol-
- 10 lowing:
- 11 "(1) the Federal Meat and Poultry Employees
- 12 Pay Act of 1998;".
