## CONCURRENT RESOLUTION

1       *Resolved by the Senate (the House of Representatives*  
2       *concurring),*

3       **SECTION 1. AUTHORIZING USE OF ROTUNDA OF THE CAP-**  
4                       **ITOL FOR MEMORIAL SERVICE FOR DETEC-**  
5                       **TIVE JOHN MICHAEL GIBSON AND PRIVATE**  
6                       **FIRST CLASS JACOB JOSEPH CHESTNUT.**

7       The rotunda of the Capitol is authorized to be used  
8       for a memorial service and proceedings related thereto for  
9       Detective John Michael Gibson and Private First Class  
10      Jacob Joseph Chestnut of the United States Capitol Police  
11      on Tuesday, July 28, 1998, under the direction of the  
12      United States Capitol Police Board.

13      **SEC. 2. PLACEMENT OF PLAQUE IN CAPITOL IN MEMORY**  
14                       **OF DETECTIVE GIBSON AND PRIVATE FIRST**  
15                       **CLASS CHESTNUT.**

16      The Architect of the Capitol shall place a plaque in  
17      honor of the memory of Detective John Michael Gibson  
18      and Private First Class Jacob Joseph Chestnut of the  
19      United States Capitol Police at an appropriate site in the

1 United States Capitol, with the approval of the Speaker  
2 of the House of Representatives and the President Pro  
3 Tempore of the Senate.

4 **SEC. 3. PAYMENT OF FUNERAL EXPENSES FOR JOHN GIB-**  
5 **SON AND JACOB JOSEPH CHESTNUT.**

6 (a) IN GENERAL.—The Sergeant at Arms of the  
7 House of Representatives is authorized and directed to  
8 make such arrangements as may be necessary for funeral  
9 services for Detective John Michael Gibson and Private  
10 First Class Jacob Joseph Chestnut of the United States  
11 Capitol Police, including payments for travel expenses of  
12 immediate family members, and for the attendance of  
13 Members of the House of Representatives at such services,  
14 including payments for expenses incurred by Members in  
15 attending such services.

16 (b) SOURCE AND MANNER OF MAKING PAYMENTS.—  
17 Any payment made under subsection (a) shall be made  
18 from the applicable accounts of the House of Representa-  
19 tives, using vouchers approved in a manner directed by  
20 the Committee on House Oversight.

21 **SEC. 4. PAYMENT OF SURVIVOR'S GRATUITY TO WIDOWS OF**  
22 **JOHN GIBSON AND JACOB JOSEPH CHEST-**  
23 **NUT.**

24 (a) IN GENERAL.—In accordance with the first sen-  
25 tence of the last undesignated paragraph under the center

1 heading “HOUSE OF REPRESENTATIVES” in the  
2 first section of the Legislative Branch Appropriation Act,  
3 1955 (2 U.S.C. 125), the Chief Administrative Officer of  
4 the House of Representatives is authorized and directed  
5 to pay, from the applicable accounts of the House of Rep-  
6 resentatives—

7           (1) a gratuity to the widow of Detective John  
8       Michael Gibson of the United States Capitol Police  
9       in the amount of \$51,866.00; and

10          (2) a gratuity to the widow of Private First  
11       Class Jacob Joseph Chestnut of the United States  
12       Capitol Police in the amount of \$47,280.00.

13       (b) TREATMENT AS GIFT.—Each gratuity paid under  
14 subsection (a) shall be held to have been a gift.

15 **SEC. 5. SENSE OF CONGRESS REGARDING ESTABLISHMENT**  
16 **OF CAPITOL POLICE MEMORIAL FUND.**

17       It is the sense of Congress that there should be estab-  
18 lished under law a United States Capitol Police Memorial  
19 Fund for the surviving spouse and children of members

1 of the United States Capitol Police who are slain in the  
2 line of duty.
