CONCURRENT RESOLUTION

Expressing the sense of the Congress that a commemorative postage stamp should be issued honoring the United States Submarine Force on its 100th anniversary.

Whereas, in the year 2000, the United States Submarine Force will celebrate a century of service to the Nation;

Whereas little has captured our imagination more than exploring the ocean depths;

Whereas submarine technology has proven invaluable to our Nation by strengthening our national defense, preserving world maritime freedom, and producing scientific breakthroughs;

Whereas submarines have not only provided a remarkable strategic platform, but have helped establish a firm foundation for scientific exploration;

Whereas the United States Submarine Force was responsible for 55 percent of all Japanese shipping destroyed during World War II even though submariners constituted only 2 percent of all United States Navy personnel serving in that war;

Whereas 52 American submarines and over 3500 American submariners were lost during World War II;

Whereas, in peacetime, the Silent Service continues to patrol around the clock under the oceans to keep us free; and

Whereas veterans of the United States Submarine Force have served with honor and courage, risking their lives in combat against determined foes and always against an unforgiving sea: Now, therefore, be it

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That it is the sense of the Congress that—

3 (1) a commemorative postage stamp should be
4 issued by the United States Postal Service honoring
5 the United States Submarine Force on its 100th an-
6 niversary; and

7 (2) the Citizens' Stamp Advisory Committee
8 should recommend to the Postmaster General that
9 such a stamp be issued.
