CONCURRENT RESOLUTION

- 1 Resolved by the House of Representatives (the Senate
- 2 concurring), That when the House adjourns on any legisla-
- 3 tive day from Thursday, November 18, 1999, through
- 4 Monday, November 22, 1999, on a motion offered pursu-
- 5 ant to this concurrent resolution by its Majority Leader

- 1 or his designee, it shall stand adjourned until noon on
- 2 Thursday, December 2, 1999 (unless it sooner has re-
- 3 ceived a message from the Senate transmitting its concur-
- 4 rence in the conference report to accompany H.R. 3194,
- 5 in which case the House shall stand adjourned sine die),
- 6 or until noon on the second day after Members are notified
- 7 to reassemble pursuant to section 3 of this concurrent res-
- 8 olution; and that when the Senate adjourns on any day
- 9 from Thursday, November 18, 1999, through Thursday,
- 10 December 2, 1999, on a motion offered pursuant to this
- 11 concurrent resolution by its Majority Leader or his des-
- 12 ignee, it shall stand adjourned sine die, or until noon on
- 13 the second day after Members are notified to reassemble
- 14 pursuant to section 3 of this concurrent resolution.
- 15 Sec. 2. When the House convenes for the second ses-
- 16 sion of the One Hundred Sixth Congress, it shall conduct
- 17 no organizational or legislative business on that day and,
- 18 when the House adjourns on that day, it shall stand ad-
- 19 journed until noon on January 27, 2000, or until noon
- 20 on the second day after Members are notified to reassem-
- 21 ble pursuant to section 3 of this concurrent resolution.
- SEC. 3. The Speaker of the House and the Majority
- 23 Leader of the Senate, acting jointly after consultation with
- 24 the Minority Leader of the House and the Minority Lead-
- 25 er of the Senate, shall notify the Members of the House

- 1 and Senate, respectively, to reassemble whenever, in their
- 2 opinion, the public interest shall warrant it.
- 3 Sec. 4. The Congress declares that clause 2(h) of
- 4 rule II of the Rules of the House of Representatives and
- 5 the order of the Senate of January 6, 1999, authorize for
- 6 the duration of the One Hundred Sixth Congress the Clerk
- 7 of the House of Representatives and the Secretary of the
- 8 Senate, respectively, to receive messages from the Presi-
- 9 dent during periods when the House and Senate are not
- 10 in session, and thereby preserve until adjournment sine
- 11 die of the final regular session of the One Hundred Sixth
- 12 Congress the constitutional prerogative of the House and
- 13 Senate to reconsider vetoed measures in light of the objec-
- 14 tions of the President, since the availability of the Clerk
- 15 and the Secretary during any earlier adjournment of ei-
- 16 ther House during the current Congress does not prevent
- 17 the return by the President of any bill presented to him
- 18 for approval.

- 1 Sec. 5. The Clerk of the House of Representatives
- 2 shall inform the President of the United States of the
- 3 adoption of this concurrent resolution.
